SPECIAL ORDINANCE NO. 3, 1961

- AN ORDINANCE establishing paydays for certain employees of the City of Indianapolis and fixing a time when the same shall take effect.
- WHEREAS, the semimonthly payment of wages tends to work a hardship on persons who are at the lower end of the wage scale, and
- WHEREAS, the payment of wages on a biweekly basis would eliminate some of these hardships and be more in conformity with personnel pay practices used by private business in the Indianapolis community.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. This Common Council does hereby ordain that the City of Indianapolis, Indiana, shall pay all personnel biweekly except those who are paid an hourly rate on a weekly basis.

Section 2. The City Controller shall establish proper pay periods so that payday for all nonhourly paid employees shall be on alternate Fridays and, when such Fridays shall be a legal holiday observed by City employees, that payday shall be the Thursday preceding the holiday.

Section 3. That this ordinance shall become effective from and after its passage and signature by the Mayor, as of July 1, 1961.

- WHEREAS, Keystone Avenue from Fall Creek north to the north City Limits of Indianapolis (approximately 63rd Street at present) is an avenue within the City of Indianapolis, and,

- WHEREAS, the State Highway Department of Indiana is proposing, planning and proceeding to improve and widen said section of Keystone Avenue, and

- WHEREAS, the Bureau of Traffic Engineering for the City of Indianapolis, has studied said parking restrictions and said speed limit and has recommended that said parking restrictions and

speed limit be approved and concurred in by the City of Indianapolis and,

WHEREAS, the Board of Public Safety of the City of Indianapolis has considered said parking restrictions and said speed limit and has approved them and has recommended that the City of Indianapolis concur with the State Highway Department of the State of Indiana regarding said parking restriction and said speed limit.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS:

Section 1. That the City of Indianapolis concurs with the above said parking restrictions and the speed limit, proposed and recommended by the State Highway Department of the State of Indiana, that is, that on the section of Keystone Avenue which extends from Fall Creek on the South to the North City Limits of Indianapolis, that when said section is improved and widened there shall be no parking, stopping or standing at any and all times on both sides of said section of Keystone Avenue and that the speed limit on said section of Keystone Avenue shall be 35 miles per hour.

Section 2. This Resolution shall be deemed a statement of policy by the Common Council with reference to traffic control over said section of Keystone Avenue.
