
Ordered, That the Committee Streets and Alleys, contract for the grading and gravelling of Kentucky Avenue, to the lowest responsible bidder.

Ordered, That the City Commissioner proceed forthwith to make a gravel walk at the crossing of the different alleys and Streets on the side walks between Washington and New York Streets on Alabama Street, Also to erect foot bridges at the crossings of the Streets on said side walks where needed between said points, above named, The same to be paid out of the Road Fund of said Ward, Provided there is Road Fund sufficient for that purpose, and if there is not, the same to be paid out of the General Fund.

A petition signed by A Teal, Norwood & others, praying the Council to grade and gravel the Alleys, lying between Washington and Market Streets, and between Meridian & Illinois was Read, and on motion, was referred to Committee on Street and Alleys.

A petition signed by Benson Cornelius, Samuel Merrill and some 20 others, praying the Council, to fix the width of Alabama Street between Merrill and McCarty Streets; also to establish the width of both sides walks on said Street between the Streets aforesaid, with the grade of said side walks, was Read, and on motion was referred to Committee on



Streets and Alleys.

The petition signed by T. M Phipps and some 60 others, praying the Council to make a gravel walk 12 feet wide along Market Street and at, and along the South side of East Market Square, and along the East side of said square so far as the public grade extends, was Read, and on Motion the following Order was adopted.

Ordered, That the Street Commissioner proceed forthwith to make a gravel walk of 12 feet wide and 6 inches deep along Market Street on the South side of East Market square, and also along the East side of said square, so far as the public grade extends.

Ordered, That Charles Mayer be authorized to erect upon Lot Number 5, in square No 3 in Harris's addition to Indianapolis: (it being in Out No 157) a building or Magazine for the Storrage of gun powder, the grant to be upon the same conditions as that given to Little, Drum & Andersons and others, as ordered at the Regular Meeting of the Council of the present year 1850, holden on Sept 2nd.

The Estimate of the City Engineer of the probbable Cost for grading and gravelling of Kentucky Avenue between Washington Street and the Canal Bridge was presented, Read, accepted and ordered to be placed on file.

The following Resolution was offered, and adopted.

Resolved, That the Secretary Report to the Council at its next meeting the amount of appropriations made for the two quarters, commencing with the fiscal year, including Salary of Officers; also that he Report at the expiration of each quarter hereafter in like manner.

The following Ordinance was presented and adopted, An ordinance to restrain Hogs or swine from running at large.

Sec. 1. Be it ordained by the City Council of Indianapolis

That from and after the first day of January next, it shall be unlawful for hogs or swine of any description to run at large within the bounds of East, West, North and South Streets in said City.

Sec 2nd That from and after the time named, all hogs or swine, of every description found running at large within the bounds aforesaid, shall be taken up and impounded by the marshall; of which he shall give immediate notice in writing, set up at each Market House describing each hog, shote or pig so taken up and impounded; and if the owner or owners thereof do not appear in twenty four hours after the putting up of such Notice as aforesaid, and pay the expence of such taking up and impounding, then the Marshall shall sell the same to

. 0 -

defray such expence, returning the overplus, if any, to the owner or owners of said hog, shote or pig, if Known, otherwise he shall pay it to the City Treasurer.

Sec 3. The Marshall shall be allowed twenty five cents for his services in taking up and impounding each hog, shote or pig, where the same is claimed before sale, to be paid by the owner or owners of such hog, shote or pig, before the same shall be released; but in case of sale, the marshall shall be allowed the further sum of twelve and one half cents for ech hog, shote or pig offered for sale as aforesaid, to be retained out of the proceeds of the sale.

An ordinance amendatory of the 5th Chapter of the revised ordinances, on the subject of the grade of Streets, and the improvement of side walks.


Sec 1. Be it ordained by the City Council of Indianapolis:

That whenever in the opinion of the Council it would be for the public good and convenence to grade, gravel or pave any Street, Alley, or side-

or any part thereof, in said City, and the property holders owning lots or parts of Lots along the line of the Street Alley or side-walk needing improvement, as aforesaid, shall fail or refuse to petition the City Council asking for such improvements, then and in such case the City Council in their discretion, may order the improvement to be made in the same manner and under the like regulations as if the same was asked for by petition.

Sec 2. That in all cases of improvement made by order of the City Council, as Contemplated in the first section of this ordinance, owner or owners of a lot or Lots, or parts of a lot or Lots shall be subject to the same liabilities and have the same privilages as are allowed by the ordinance to which this is an amendment, except as hereinbefore changed; and all officers employed in carrying out the orders of the City Council, as to any Street, Alley or side walk or part thereof, shall observe & perform all the duties required of them by the ordinance to which this is an amendent, except as to the alterations hereby made necessary: Provided, the width and depth of gravelling on any Street, Alley or side walk may be raised to conform to the order of the



City Council, should any such be made in any particular case.

Sec 3. All ordinances or parts of Ordinances contravening this ordinance be and the same are hereby repealed.
