The Bill of Vanblaricum & Jones on motion was refered to the Committee on Claims.

The estimate of the City Engineer for the gravelling of Pennsylvania Street between Washington Street and Massachusetts Avenue was presented and Read, and ordered to be filed.

The following Resolution was on Motion, refered to the Committee on Streets.

Resolved, That the pavements between Meridian Street and the alley West, be ordered to be put down to the proper grade in front of the buildings of S. W. Norris at the Auction Room of Little Drum & Andersons, and the whole grade be put down to the plat of the

City between said Street and alley.

On Motion the following Resolution was read and adopted.

Resolved, That the Mayor, H. C. Newcomb Esqr. and the late Treasurer James H. Kenneday be requested to make a satisfactory explanation to the Council in relation to a receipt given by said Kenneday to said Newcomb, dated Nov 12th 1849 for \$20.60, and reported by the present Treasurer to the Council on Nov 4th 1850.

The following Resolution was read and adopted.

Resolved, That James Blake be permitted to postpone the making of his side walk on the South side of Washington Street, between Tennessee and Illinois Streets, util the first day of May 1851. Provided, said Blake makes a gravel walk on or before thirty days from this date. November 4th 1850.

Ordered, That the Lot owner or owners on the West side of Meridian Street, between Washington and Circle Streets, be and they are hereby required to grade and pave the side walk in front of their several Lots or Lots in the time and manner required by ordinance.

Ordered, That in case any lot owner or owners shall fail to grade and pave his or her side walk as aforesaid, a sum equal to the amount necessary to do the same by the City authority be and the same is hereby assessed upon such delinquent or delinquents, to be levied and collected as prescribed by ordinance.


Ordered, That the City Engineer make the necessary survey, estimates, and set stakes; and that the Street Commissioner see that the above order is carried into effect.

Ordered, That Pennsylvania Street from Washington to Ohio Streets, including the junction with Massachusetts Avenue, be gravelled with coarse gravel 16 feet wide, one foot deep in centre, and declining each way to 6 inches at the edges.

Ordered, That 30 feet in length of the gutter on the East side of Pennsylvania Street, at the junction of Massachusetts Avenue, be paved with boulders and gravelled, as on Washington Street.

Ordered, That a sum equal to the estimate of the City Engineer, (herewith submitted) be assessed on the lot owners on each side of said Pennsylvania Street, in proportion to the number of feet held by each, to pay for the improvement contemplated above.



Ordered, That the Street Commissioner, under direction of the City Surveyor, carry out the objects of the above orders in 35 days.

Ordered, That, the lot owner or owners on the West side of Pennsylvania Street, from Washington Street, to the alley dividing Lots 4 & 5, in square 45, be and they are hereby required to grade and pave the side walk in front of their several lot or lots in the time and manner required by ordinance: Provided, that lot No 10, in square No 56, and that part of lot No 6, in said square, owned by Mrs Paxton, shall be excepted from this order, if conformadable to the grade.

Ordered, That the City Engineer make the necessary survey, estimates, and set stakes; and that the Street Commissioner see that the above order be carried into effect.

Ordered, further, That in case any lot owner or owners shall fail to grade and pave his or her side walk as aforesaid, a sum equal to the amount necessary to do the same by the City authority be and the same is hereby assessed upon such delinquent or delinquents, to be levied and collected as prescribed by ordinance.
