Council Chamber Indianapolis January 6th 1851

The Committee on Public wells made the following Report, which was also concured in by the Council.


The Committee on Public Wells beg leave to offer the following Report, The City Wells are all in very bad condition, (being almost dry.) and the pumps are in about the same situation.


