

Resolved That the Committee on Streets be directed to let the grading and gravelling of Kentucky Street from the Canal to the Grave Yard at not more than the Engineers Estimate, the same to be paid in orders on the City Treasurer

(485 & 86) Resolved That John McCollum be allowed \$10.00 extra for sinking the sills of the Bridge just erected across Pogues Run on Virginia Avenue some two feet lower than the point named in the contract.

On Motion of Mr Hetselgesser, George Espy was appointed inspector of the Election in the 5th Ward, Vice W. D. Wygant resigned.

On Motion The Bill of Matthew Little filling the Mud hole in New Jersey Street, between Washington & Market Streets, was taken up - Mr Landis moved that the Bill be allowed, which motion did not prevail.
