"Resolved That the order heretofore passed directing the President to contract for enclosing the public burying ground with a new fence, be so allowed as to authorize the enclosing the grave yard used by the colored people with the material to be taken from the city grave yard so far as the same may be necessary."

Which was adopted.

Mr. Culley offered the following resolution:

"Resolved, That the Market Master of the East & West Markets be and he is hereby authorized and required to lease the outside stalls in the Market Houses aforesaid to persons who may wish to use the same for the sale of fruits and vegatables, etc.; said lease to extend to the next yearly sale of stalls, the lesses paying for each stall five dollars for the year, commencing in May, and in that proportion for a less time. The Market Master to give certificates and make return of money as in other cases.

Ordered That the Secretary furnish Market Master with a copy of this resolution.

Mr.Greer not being willing to remain longer The Council adjourned.
