CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS,
WEDNESDAY, JUNE 5, 1867, 7½ O'CLOCK, P. M.

The Common Council met in special session.

Present—Honorable Sims A. Colley, President pro tem., in the chair, and the following members:

Councilmen Brown, Coburn, Colley, Davis, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, MacArthur, Schmidt, Seidensticker, Stanton and Woodburn—15.

Absent—Councilmen Burgess and Cottrell—2.

The President pro tem. announced that the first in order of business was the receiving of the reports of the Board of Equalization and the Finance Committee.

The City Assessor, from the Board of Equalization, submitted the following report:

INDIANAPOLIS, June 5, 1867.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—Your Committee, to whom was referred the Assessor's return, have heard the complaints that have been presented, and have equalized the assessments, and herewith return the total amount of taxables, as shown by the footings of the Assessor's books, to be twenty-one million nine hundred

and forty-three thousand six hundred and five dollars, and five thousand three hundred polls.

Gentlemen:—The Finance Committee beg leave to report the receipts of the city during the year ending March 20th, 1867, from taxation, as follows:-

As the amount really expended as current expenses for the year ending March 20, 1867, which exceeds, by about one per cent, the estimate of your Committee presented a year ago.

Which is the whole amount of indebtedness in excess of funds in the City Treasury March 20, 1867.

At the close of the year there was an unusually heavy delinquent list from which your committee estimate at least \$42,000 can be realized during the

ensuing August and September.

Deducting this further sum from amount of debt unprovided for on the 20th day of March last, and the entire indebtedness of the City at that time, above its available assetts (cash on hand and collectable on delinquent list) was \$44,070.07.

Though samewhat irrevalent to the subject of this report, your Committee find upon examining the records, that during the last two years the indebtedness of the city has been diminished nearly \$300,000 and that its present proportions are such as not in future to impede our growth or lessen our prosperity.

We present the following as our estimate of the expenses of the city dur-

ing the current year ending March 20, 1868.

Your Committee do not wish to be considered as endorsing as proper, to be expended in the manner indicated, each of the items of the foregoing estimate, but in several particulars would suggest a reduction. In reference to the item of gas \$15,000 in our opinion might be saved annually by extinguishing street lamps at midnight, and by diminishing the size of the burn-Whether this shall be expedient the Council must determine. We are also in doubt as to the propriety of building additional fire cisterns, until more is definitely known in regard to the erection of water works.

We also think that with rigid economy some of the items of the estimate

relative to the Fire Department, might be omitted.

To provire for the expenses of the present year in accordance with the estimate presented, and meet all other obligations in good faith, \$230,000 will have to be raised by taxation, \$170,000 of which should be paid out on current expenses, (the expense on gas being paid in two year warrants) and the remainder applied for the liquidation of the ten per cent. warrants and war bonds, both of which become due early next year, the former on the 1st of April and the latter on the 1st of July.

The aggregate of these liabilities is \$109,000 for the payment of which, according to our estimate, there will be in the City Treasury \$60,000, the remaining \$49,000 will have to be raised by a loan, in addition to which a sufficient amount, probably \$100,000, will also have to be raised by loan, to meet the current expenses of the city during the first half of the next fiscal

year.

For the raising of this amount, namely, \$230,000, your committee respectfully recommends a levy of one dollar and fifteen cents be made on each one hundred dollars returned for taxation, for which levy your committee present the accompanying ordinance and recommend its passage.

The assessment this year as shown by the Assessors return, is \$21,943,605. Under this levy, taking last years levy and collections as a basis of calculation, there can be collected \$188,796, in addition to which there can be realized on collection of the delinquent list, about \$42,000, or in the aggregate, \$230,769, which will meet the above estimated requirements of the city and leave \$769 in the Treasury.

In view of the wants of the city in relation to sewerage, your committee beg leave to suggest, that by selling a sufficient amount of war bonds maturing fifteeu years after date, to realize therefrom \$100,000 the floating debt of the city can be so adjusted, as to warrant the expenditure of \$40,000 during the latter part of this, and the first part of next year, for the inauguration of a general plan of sewerage.

Your committee would therefore respectfully ask to be empowered to negotiate for the sale of the same, said sale being subject to your final approval.

All of which is respectfully submitted.

On motion by Mr. Davis, the report was received and ordered to be spread upon the printed records of the Council.

Dr. Jameson, Chairman of the Finance Committee, reported an ordinance entitled:

An Ordinance levying a general tax for the year 1867, upon the taxable property within the City of Indianapolis,

Providing for a levy of one dollar and fifteen cents on the one hundred dollars for general purposes, and fifty cents on each poll.

Which was read the first time.

Mr. Loomis moved to strike out the words "one dollar and fifteen cents," and insert the words "one dollar and thirty-five cents."

Mr. Brown moved to amend Mr. Loomis' motion by inserting "one dollar."

The ayes and noes being demanded, those who voted in the affirmative were Councilmen Brown and Woodburn—2.

Those who voted in the negative were Councilmen Coburn, Colley, Davis, Geisel, Goddard, Henschen, Jameson, Loomis, MacArthur, Schmidt, Seidensticker and Stanton—12.

So the amendment was not adopted.

The question then recurring on Mr. Loomis' motion, the ayes and noes were called for.

Those who voted in the affirmative were Councilmen Loomis, Schmidt and Seidensticker—3.

Those who voted in the negative were Councilmen Brown, Coburn,

Davis, Geisel, Goddard, Henschen, Jameson, MacArthur, Stanton and Woodburn—10.

So the amendment was not adopted.

Mr. Geisel then moved to amend by strking out the words "one dollar and fifteen cents," and inserting the words "one dollar and twenty-five cents."

The ayes and noes being demanded, those who voted in the affirmative were Councilmen Davis, Geisel, Goddard, Henschen, Loomis, Schmidt, Seidensticker and Stantor—8.

Those who voted in the negative were Councilman Brown, Coburn, Colley, Jameson, MacArthur and Woodburn—6.

So the amendment was adopted.

Mr. Brown then moved that the further consideration of the ordinance be postponed until next Monday evening, June 10th, 1867.

The ayes and noes being demanded on the postponement, those who voted in the affirmative were Councilmen Brown, Coburn, Davis, Geisel, Goddard, Henschen, Kappes, MacArthur and Woodburn—9.

Those who voted in the negative were Councilmen Jameson, Loomis, Schmidt and Seidensticker—4.

So the motion to postpone was adopted.

Mr. Davis moved that the City papers be requested to publish the report of the Finance Committee.

Which was adopted.

On motion by Mr. MacArthur, the Council adjourned until Thursday evening, June 6th, 1867.
