# COMMON COUNCIL.

REGULAR SESSION.

CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, Monday, August 12TH, 1867, 2 o'clock, p. M.

The Common Council met in regular session.

Present—His Honor, the Mayor, Daniel Macauley, in the chair, and the following members:

Councilmen Burgess. Coburn, Cottrell, Davis, Geisel, Henschen, Jameson, Kappes, Loomis, MacArthur, Seidensticker, Stanton and Woodburn—13.

Absent-Councilmen Brown, Colley, Goddard and Schmidt-4.

The proceedings of the regular session held August 5, 1867, were read and approved.

Mr. Coburn presented the contract and bond of Richard Carr, giving as security, Hiram Seibert and S. J. Smock—for grading and graveling Kentucky Avenue and sidewalks, from West street to White river.

Which was referred to the Judiciary Committee, with instructions to report on it at next meeting.

Mr Coburn introduced special appropriation ordinance No. 48-1867, entitled:

AN ORDINANCE appropriating money for the payment of sundry claims against the city of Indianapolis.

Which was read the first time by its title.

## Mr. Cottrell offered the following resolution :

*Resolved*, That the Chief of the Police notify *every* member of the Police force that they must comply with the requirements of Section 15 of an ordinance entitled "an ordinance for the public morality, decency, and order."

The failure of the Chief of Police to enforce the provisions of said section 15, or the failure of any policeman to obey the order from the Chief of Police, shall be deemed guilty of a gross misdemeanor, and on sufficient proof thereof shall be immediately dismissed by the Board of Police.

The ayes and noes being taken under the charter, those who voted in the affirmative were Councilmen Cottrell, Davis, Geisel, Henschen and Woodburn-5.

Those who voted in the negative were Councilmen Burgess, Coburn, Kappes, Loomis, MacArthur, Seidensticker and Stanton-7.

So the resolution was not adopted.

Ewing, together with those whose names are hereunto attached, are firmly held and bound unto the Indianapolis Gas Light and Coke Company, in the sum of five hundred dollars, upon the conditions following, to-wit:

WHEREAS, A petition has been presented to the Common Council, of the city of Indianapolis, praying that main and service pipes be laid on South street, and Fletcher Avenue, between School and Cedar streets; and the said Indianapolis Gas Light and Coke Company, are about to lay such pipes; Now, if the citizens along the line of said street, between the limits aforesaid, shall take and use, consuming to each burner the fair average amount of gas consumed in the vicinity of such street, fifteen or more burners to each space of five hundred and ten feet along the street where said pipes are laid, this obligation shall be void, else in force.

Mr. MacArthur introduced special appropriation ordinance No. 49-1867, entitled :

AN ORDINANCE appropriating money for the payment of the Board of Registers and clerks of the city of Indianapolis.

Which was read the first time by its title.

Mr. MacArthur presented the following petition:

INDIANAPOLIS, Aug. 12, 1867.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN:—The undersigned respectfully ask of your honorable body the privilege of constructing a foot bridge across the canal at St. Clair street. We ask this owing to the great inconvenience that the citizens of that part of the city is subject to for reason of the incompletion of St. Clair street bridge. ### REPORTS FROM CITY OFFICERS.

The City Auditor made the following report:

INDIANAPOLIS, Aug. 12, 1867.

To the Mayor and Common Council of the City of Indianapolis :

1. The contract and bond of William Kowan, for grading and bouldering the alley running north and south through square fifty-five, between Washington and Market streets.

2. The contract and bond of D. Root, for erecting lamp posts, lamps and fixtures on East street, between Massachusetts Avenue and St. Clair streets.

3. The contract and bond of John Schier, for grading and grave'ing St. Clair street and sidewalk, between the Peru Railroad track and East Second street.

4. The contract and bond of the Indianapolis Gas Light and Coke Company, for erecting lamp posts, lamps and fixtures on McNabb streets, between Illinois and Meridian streets.

5, The contract and bond of Richard Carr, for grading and graveling Mc-Carty street and sidewalks, between Illinois and Tennessee streets.

6. The contract and bond of Hiram Seibert, for grading and graveling Cherry street and sidewalks, between Fort Wayne Avenue and Ash street.

7. A petition was presented to your honorable body some time ago, and was referred to me from owners of real estate in square sixty-two, to have seventeen feet of the west side of lot one in square sixty-two, which is valued at two thousand two hundred and fifty dollars, and is owned by John P. Michael. I herewith report the necessary resolution to have it filled up, if you desire to do so.

8. The Civil Engineer to whom was referred a motion, offered by William H. Loomis, Esq., instructing the Civil Engineer to examine the proposals for grading, paving with brick and curbing the outside edge of the sidewalk, with flat rock stone, of Meridian street, west side, between Washington street and the Union Railway Company's track, informs me that he has made an examination of the proposals, and, that John Schier is the lowest bidder, his bid

being \$1.12 per lineal foot front for paving, and 85 cents per lineal foot front for curbing; his contract and bond is herewith submitted for approval.

9. Also, first and final estimate allowed Joseph Bernauer and John Bly, for grading and graveling New York street and south sidewalk, between Alabama and New Jersey streets. 10. The contract and bond of Charles Rooney, for grading and paving so

much of the sidewalk as has not been already paved on the east side of Meridian street, between Washington and Maryland streets.

11. The contract and bond of Dan Mahoney, for grading and graveling the west sidewalk on Douglass street, between New York and Vermont streets. 12. The contract and bond of Joseph Schwartze, for grading and graveling

the alley running north and south, through square thirty-two, between Ohio and New York streets.

13. Contract and bond of D. Root, for erecting lamp posts, lamps and fix-tures on South street, between New Jersey street and Virginia Avenue.

At the intersection of North and Winston streets, 1; Fort Wayne Avenue and Delaware street, 1; Meridian and Vermond streets, 1; Tennessee and Walnut streets, 1; Vine, or Cherry and Jackson streets, 1; Alabama and Maryland or Cumberland streets, 1; South street and Fletcher's Avenue, 1; Illinois and McCarty streets, 1; St. Clair and East streets, 1; West and McCarty, or Kingan streets, 1; East and Dougherty streets, 1; Virginia Avenue and Grove or Bradshaw streets, 1.

I would also recommend the placing of boxes in Pogue's Run under the bridges so as to receive the flow of water, with lids to keep out the sand or gravel, which can be raised when needed to receive the suction, which it is thought will facilitate the getting of water, and save machinery from the All of which is respectfully submitted. effect of gravel.
