CHAMBER OF THE COMMON COUNCIL OF THE
CITY OF INDIANAPOLIS,
MONDAY, NOVEMBER 25TH, 1867, 7 O'CLOCK, P. M.

The Common Council met in regular session.

Present-His Honor, the Mayor, Daniel Macauley, in the chair, and the following members:

Councilmen Brown, Coburn, Colley, Cottrell, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes Loomis, MacArthur, Schmidt, Seidensticker, Stanton and Woodburn—17.

Absent-Councilman Burgess-1.

The proceedings of the regular session held November 18, 1867, were read and approved.

Mr. Davis offered the following motion:

That the Street Commissioner be, and is hereby directed to fill up the holes on Maryland street, between Delaware and Meridian streets, with stone spalls.

Which was referred to the Board of Public Improvements, with instructions to have the work done as they deem best.

Mr. Davis, also, offered the following motion:

That the Street Commissioner be, and is hereby directed to place two foot bridges on Kentucky Avenue, on the north side, at the intersection of West street.

Which was adopted.

Mr. Davis, also, offered the following motion:

That the Sexton of the city cemetery be, and is hereby directed to properly grade and gravel the carriage ways in said cemetery.

Which was adopted.

Mr. Foster introduced general ordinance No. 115, entitled:

An Ordinance relative to placing a flagman at the crossing, at the intersection of Missouri street and Kentucky Avenue.

Which was read the first time by its title.

Mr. Henschen offered the following motion:

That the Street Commissioner be, and is hereby instructed to gravel the crossing of East and Bicking streets.

Which was adopted.

Mr. Henschen, also, offered the following motion:

That Wm. Stolte, be granted permission to dig a well on the sidewalk, in front of his property, on the corner of McCarty and Delaware sfreets.

Which was adopted.

Dr. Jameson presented the following petition:

Dr. Jameson, from the Finance Committee, made the following report:

Indianapolis, Nov. 25, 1867.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—The Committee on Finance beg leave to report in reference to petition of H. Seymour, asking remuneration for laying down of drain pipe on Illinois street, that the city should pay no part of the cost thereof unless sa'd pipe can be used for the benefit of the public. We beg leave to suggest the propriety of referring the same to a special committee consisting of Messrs. Brown, Woodburn and Goddard, who shall enquire what arrangements can be made for draining other nuisances through said pipe, &c.

In relation to petition of Geo. S. D. Rooker, would recommend that prayer

of petitioner be granted.

In relation to petition of John Smithmeyer, we find his assessment papers in due form, signed and sworn to by himself, and in accordance with the usage of the Committee, recommend that no deduction be made.

To the Mayor and Common Council of the City of Indianapolis:

The Committee on Revision of Ordinances, to whom a petition of A. C. Brackebush, for permission to erect a sign post, with sign attached, on Washington street, was referred, respectfully report, that while it is doubtful whether sections 17 and 26 of the ordinance on streets and alleys expressly prohibits the Council from granting the privileges asked for in the petition, the general policy of the Council, as indicated in the ordinance referred to, and others, seems to be against the granting of such privileges.

Indianapolis, Nov. 25, 1867.

To the Mayor and Common Council of the City of Indianapolis:

The Committee on Revision of Ordinances, to whom the motion for an ordinance prohibiting minors from getting on railroad trains within the city limits was referred, respectfully herewith report an ordinance which, in their opinion, is adapted to the aims of the motion referred to us.

While your committee had some doubts whether such an ordinance would repress the recklessness of persons who habitually endanger heir own life and limb, we thought that even the remote possibility of preventing a single accident would justify the drafting and passage of such an ordinance, and therefore submit the same for your consideration.

An Ordinance prohibiting all persons but travelers and railroad employees from getting on or jumping off any railroad trains within the corporate limits, while the same are in motion.

Mr. Coburn, from the Committee on Fire Department, made the following report:

Indianapolis, Nov. 25, 1867.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—The Committee on Fire Department, to whom was referred the motion to purchase ground for an engine house north of Vermont and west of Illinois streets, would report that they deem it inexpedient to purchase ground at present for a new engine house, and the establishing of another fire company. This matter is so well understood that your committee consider it useless to enter into the reasons in this report.

Mr. Seidensticker, from special committee, made the following report:

INDIANAPOLIS, Nov. 25, 1867.

To the Mayor and Common Council of the City of Indianapolis:

The undersigned special committee, to whom the petition praying an ap propriation of \$1,000 for the purpose of assisting in the boring of an artesian well was referred, respectfully report:

1 While the locality for the artesian well suggested in the petition has the advantage of having a commencement of nearly 100 feet of boring, it is so much secluded and out of the way, besides being on private ground, that it hardly seems the best adapted for the expenditure of public money.

2. It is doubtful whether the amount of \$1,000, even if doubled by private

subscriptions, would be sufficient to secure an artesian well with a proportionate supply of water; and if not, the money would be uselessly expended.

We doubt whether the finances of the city are in such a condition as to warrant the expenditure of \$1,000 or more in an experiment.

For these reasons your committee recommend that the prayer of the petitioners for an appropriation of \$1,000 be not granted.

To the Mayor and Common Council of the City of Indianapolis:

The following work I done in the city of Indianapolis, from October 21, up to November 23, 1867:

- 1. Put one foot bridge on Pennsylvania and Maryland streets.
- Put one foot bridge on Alabama street, with the intersection of the Eastern Market Square.
 - 3. Filled the crossings on Mississippi and Michigan streets with spalls.
 - 4. Filled the crossings on Davidson and Vermont streets with gravel.
- 5. Filled around the cistern on Market and Pennsylvania streets with gravel.
 - 6. Filled around the cistern on Market and New Jersey streets with gravel
 - 7. Repaired the culvert on New Jersey and Washington streets.
- 8. Built a culvert on Wyoming street, the third alley east of Delawar street.
- 9. Built a small culvert on Delaware street, the first alley south-west o Pogue's Run.
 - 10. Built a culvert on New Jersey and Duncan streets.
 - 11. Repaired a culvert on Illinois and South streets.
 - 12. Lowered a culvert on Illinois and Market streets.
- 13. Deepened the ditch on Railroad street; commenced on Bellefontain Railroad track with deepening the same 19½ feet, and let the same run or with 7 inches at Massachusetts Avenue and St. Clair street.
- 14. Built twenty-three bridges over the ditch on Railroad street at different length; three of them are 8 feet wide and 12 feet long; two are 8 by 3 feet, and the balance are all 8 feet wide, and 24 and 28 feet long.

- 15. Repaired the stone tumbler on Washington street, near Noble street.
- 16. Filled the crossings on Chatham and St. Clair streets with gravel.
- 17. Filled the crossings on Jackson and St. Clair streets with gravel.
- 18. Filled around the cistern on Alabama and Cumberland streets with gravel.
 - 19. Filled around the cistern on Tennessee and Market streets with spalls
- 20. Moved the earth away from the new built cistern on Alabama and Cumberland streets.
 - 21. Filled the crossings on Tennessee and St. Clair streets with gravel.
 - 22. Filled the crossings on Tennessee and Pratt streets with gravel.
 - 23. Lowered the culvert on Bright and New York streets one foot.
 - 24. Built a new culvert on Bright and New York streets.
 - 25. Put two new foot bridges on Bright and New York streets.
- 26. Built a new bridge on Benton street across Pogue's Run, with stone abutments the full width of the street.
- 27. Built a new foot bridge on Mississippi street, across Pogues Run, 8 feet wide and 88 feet long.
 - 28. Built two small culverts on Liberty street and Pogue's Run.
 - 29. Put two foot bridges on Massachusetts Avenue and Ohio street.
 - 30. Put one foot bridge on Indiana Avenue and Vermont street.
 - 31. Put one foot bridge on Indiana Avenue and Louisiana street.
- 32. Cleaned the gutters on Meridian street, between Washington and Louisiana streets.
- 33. Cleaned the gutters on Washington street, between Illinois and Noble streets.
- 34. Cleaned the gutters on Pennsylvania street, between Washington and New York streets.
- 35. Cleaned the gutters on Market street, between Pennsylvania street and the Governor's Circle.
- 36. Filled the holes on Massachusetts Avenue, between New Jersey and Liberty streets, with gravel.
- 37. Filled the mouth of the alley on Pennsylvania street, on the east side, between Walnut and St. Clair streets.
- 38. Deepened the gutter on Kentucky Avenue, along the grave yard, so that the water can run out of West street.
- 39. Hauled 33 yards of spalls and gravel at the crossings of West and Georgia streets.
- 40. Filled the holes on East street, between Pogue's Run and Louisiana street, with gravel.
 - 41. Put flat stone crossings on Illinois and Ohio streets.
 - 42. Graded and graveled the Eastern Market Square.
- 43. Filled the crossings on Indiana Avenue and California street with spalls.
 - 44. Filled the crossings on Fletcher Avenue and Cider street with gravel.
 - 45. Filled the crossings on Meridian and New York streets with gravel.
 - 46. Filled the crossings on Delaware and Merrill streets with gravel.
- 47. Filled the holes on Noble street, between South and Louisiana streets, with gravel.
- 48. Filled around the cistern on Pennsylvania and St. Clair streets with gravel.

49. Dug a ditch on Cady street, up to Lord street, for to lead the water out of Lord street

50 Put two foot bridges on Delaware and Merrill streets.

ORDINANCES ON SECOND READING.

Mr. MacArthur called up general ordinance No. 112 creating the office of Meat inspector.

Which was read the second time, and, on motion, was made the special order of business for the regular meeting to be held Monday, December 2, 1867.

On motion by Mr. Kappes, special appropriation ordinance No. 69—1867, was read the second time, and ordered to be engrossed.

On motion by Mr. Coburn, special appropriation ordinance No. 70 —1867, was read the second time, and ordered to be engrossed.

On motion by Mr. Davis, the Auditor was instructed to embody in the above ordinance a bill in favor of Joseph Kruger, amounting to \$600, for building cistern.

Mr. Coburn moved that the rules be suspended for the purpose of passing the ordinance.

The question being on a suspension of the rules, those who voted in the affirmative were Councilmen Coburn, Colley, Davis, Goddard, Henschen, Jameson, Loomis, MacArthur, Schmidt, Seidensticker, Stanton and Woodburn—12.

Those who voted in the negative were Councilmen Brown, Cottrell, Foster, Geisel and Kappes—5.

So the rules were suspended, and special appropriation ordinance No. 70—1867, was read the third time, and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Coburn, Colley, Davis, Goddard, Henschen, Jameson, Loomis, MacArthur, Schmidt, Seidensticker and Woodburn—11.

Those who voted in the negative were Councilmen Brown, Cottrell, Foster, Geisel, Kappes and Stanton—6.

So the ordinance passed.

The question being on a suspension of the rules, those who voted in the affirmative were Councilmen Brown, Coburn, Colley, Cottrell, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, MacArthur, Schmidt, Seidensticker, Stanton and Woodburn—17.

No Councilman voting in the negative.

Special appropriation ordinance No. 69—1867, was then taken up, read the third time, and placed upon its passage.

So the ordinance passed.
