BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That there be and there is hereby appropriated out of the anticipated unexpended and unappropriated balance in the

general fund for the year 1935, the sum of Seven Thousand Two Hundred Dollars (\$7,200.00) to the budget of the Board of Public Safety, the same being hereby allocated and transferred as follows:

To Fire Department Item 1—Services, Personal, Fund 11—Salaries and Wages, Regular—Merit Commission—4 Clerical Assistants @ \$1,200.00—\$3,600.00.

To Police Department Item 1—Services, Personal, Fund 11—Salaries and Wages, Regular—Merit Commission—4 Clerical Assistants @ \$1,200.00-\$3,600.00.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

# INTRODUCTION OF GENERAL ORDINANCES

AN ORDINANCE authorizing the advancement of Seventy-three Thousand Dollars (\$73,000.00) out of the general fund of the City of Indianapolis to the Sanitary District for the purposes mentioned in "An Act concerning the issuance of bonds by the Sanitary District of the City of Indianapolis for certain purposes and matters connected therewith, and declaring an emergency," enacted by the General Assembly of the State of Indiana at its regular session in the year 1935 and approved by the governor on March 5, 1935, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the sum of Seventy-three Thousand Dollars (\$72,000.00) be advanced out of the general fund of the City of Indianapolis to the Sanitary District of Indianapolis, or be paid at its discretion, for the purposes mentioned in "An Act concerning the issuance of bonds by the Sanitary District of the City of Indianapolis for ceertain purposes and matters connected therewith, and declaring an emergency," enacted by the General Assembly of the State of Indiana at its regular session in the year 1935, approved and signed by the Governor of Indiana on March 5, 1935. Said general fund shall be reimbursed for such amount so advanced, or paid by means of the proceeds of bonds hereafter to be sold by said Sanitary District for such purpose.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

Which was read the first time and referred to the Committee on Finance. By the City Controller:

#### GENERAL ORDINANCE NO. 25, 1935

- AN ORDINANCE creating and establishing the positions of clerical assistants, Merit Commission, police and firemen's promotion boards and schools in the Board of Public Safety, fixing salaries thereof, authorizing appropriations to pay the same, and fixing a time when the same shall take effect.
- WHEREAS, the Mayor of the City of Indianapolis has advised the Common Council that, pursuant to an act of the legislature concerning boards of public safety in cities of the first class, authorizing the setting up and establishment of a Merit Commission and police and firemen's schools and promotion boards for the appointment and promotion of members of the Indianapolis police and fire departments, which act provides for the employment of the necessary clerical employees and the purchase of requisite supplies to administer the same by the Board of Public Safety, and that by reason thereof, said Mayor has created the positions of clerical assistants Merit Commission, police and firemen's promotion boards in the Board of Public Safety, as follows:

Clerical assistants, not more than four (4), Merit Commission, Firemen's Promotion Board and School in the Board of Public Safety; salary, each, Twelve Hundred Dollars (\$1200.00) per annum;

Clerical assistants, not more than four (4), Merit Commission, Policemen's Promotion Board and School, in the Board of Public Safety; salary, each, Twelve Hundred Dollars (\$1200.00) per annum; and

WHEREAS, the Mayor has requested this body to approve the establishment of said positions, and said salaries, and to make appropriations from funds not otherwise appropriated for the payment of said salaries, NOW, THEREFORE,

# BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the establishment by the Mayor of the positions of clerical assistants, Merit Commission, in the Board of Public Safety, not more than four (4) in the Firemen's Promotion Board and School, and not more than four (4) in the Policemen's Promotion Board and School, at an annual salary of Twelve Hundred Dollars (\$1200.00), each, be and the same is hereby approved.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

Which was read the first time and referred to the Committee on Finance.
