The dog tax assessed against Mr. John Dunlap was remitted the same being improperly assessed.

Ordered, That all applications for remission of Taxes be made under Oath or affirmation to be administered by the President of the Council.

October 5, 1839.

Council met; present N.B. Palmer President, George Lockerbie, Wm. Sullivan J. E. McCluer, P.W. Seibert George Norwood Councilmen.

Mr. Lockerbie from the Committee on allowances, Reported that forty dollars was due Douglass & Noel as per account filed whereupon Ordered that Douglass & Noel be allowed said forty dollars.

Allowed Joseph McChord eight dollars and ten cents as per account filed.

Allowed Thomas McCollum two dollars as per account filed.  
(Issd. 20 Oct. 1839 J V)

Mr. Sullivan presented the petition of Isaac Newkirk and others on the subject of fire, which was refered to a committee consisting of Messrs Sullivan, Lockerbie and McCluer.

The Treasurer and Weigh Master made their monthly reports which were severally accepted and adopted.

Allowed John Carson Sixteen dollars, Sixty Six & two third cents as per account filed.

(Issd. 9 Oct 1839. J.V.)

John Carson presented an account for putting timber in Delaware Street bridge, which was referred to a committee on accounts consisting of Messrs. Sullivan, Norwood and Palmer (president).

Allowed James M. Ray eight dollars for timber as per account filed.

(Issd. 8 Oct. 1839 W.S.)

Ordered That an order be issued for five hundred dollars & interest due in favor of Elder Colstock & Co in discharge of One of the notes drawn by the Corporation in their favor.

(Issd. 8 Oct 1839 T.D.G.)

Ordered That a second order be issued for five hundred dollars & interest due in favor of Elder Colstock & Co in discharge of a second note drawn by the Corporation in their favor so soon as said note is due & payable.

Ordered That the taxes on School houses and the lots on which they are situated be remitted.

Ordered That the taxes on Churches and the lots on which they are situated, be remitted.

Ordered That the Supervisor under the direction of the Councilman of the Second Ward, proceed forthwith to fill up and grade Delaware Street on the North Side of Washington Street.

On Motion of Mr. Sullivan

Resolved That a Committee be appointed to wait on the Superintendant of the Cumberland Road, and request him to Cause the Bridge over Pogues run east of Indianapolis, to be repaired.

Whereupon Messrs Sullivan, Lockerbie & McCluer were appointed Said Committee.

On Motion of Mr. Norwood

Resolved That a Committee be appointed to examine the accounts and Settle with the Town Supervisor

Messrs. Norwood, McCluer & Seibert were appointed Said Committee.

Whereupon the Council adjourned.
