On Motion of Mr. McCluer.

Resolved That the posts standing on the side walks on Illinois and also on Washington between Pennsylvania and Delaware Streets be removed.

On Motion of Mr. Seibert

Resolved that a committee be appointed to wait on Nicholas McCarty and request him to remove so much of the horse rackon Pennsylvania Street in front of said McCarty's property as obstructs the side walk of Washington Street - Also that said Committee view the alley between Meredian and Illinois Street and ascertain if any obstruction exist and report to the Council at its next meeting.

Messrs. Seibert and McCluer were appointed said Committee.

Mr. Frederick Trucksess made application for license to keep a Grocery and retail liquor.

Ordered that the Secretary issue license to Frederick Trucksess upon his complying with the Ordinance etc.

Ordered That upon said Frederick Trucksess taking out license as aforesaid the Suit wherein the Council are plantiff and said Trucksess is defendant be dismissed at the cost of said Trucksess

Ordered That the President of the Council proceed no further in the case of the Common Council against Henry Renshaupt until further orders from the Council.

Mr. Edward Browning made application for license to vend spirits by retail.

Ordered that the Secretary issue license to Edward Browning upon his complying with the Ordinance etc.

On Motion of Mr. Norwood

Resolved That a committee be appointed to have all repairs which are absolutely necessary done about the West Market and also report all other repairs which are needed and the probable cost

Messrs Seibert Norwood & Rooker were appointed said Committee.

On Motion of Mr. McCluer

Resolved That a Committee be appointed to have all repairs which are absolutely neccessary done about the East Market and also report all other repairs which are needed and the probable cost.

Messrs McCluer Sullivan & Lockerbie were appointed said Committee.

Resolved That foot bridges be erected across the gutters on the West Side of Tennessee Street where Washington Street crosses said Street, Also on the gutters across Washington Street on the East Side of Meredian Street Also across Washington Street on the West Side of Delaware Street also across Washington Street across the West Side of Alabama Street.

The Several Committees heretofore appointed on the subject of Market houses reported that railings were needed to enclose said Market houses and also reported the probable cost.

Whereupon On Motion of Mr. Seibert
Resolved that the subject of said reports be indefinately postponed.

And thereupon the Council adjourned
