Mr. Seibert offered the following resolution

Resolved That a Committee be appointed to advertise for proposals and contract for the construction of four cisterns on Washington Street each to contain two hundred & fifty hogsheads towit; One at the crossing of Delaware; one at Pennsylvania; one at Meridian; and one at Illinois Streets, and that they be made as near the public wells as practicable.

Which on motion of Mr. Rooker was laid on the table

On Motion of Mr. Sullivan

Resolved That a committee be appointed to correspond with citizens of the several towns and cities in the West and ascertain the cost and procure the most approved plan for the construction of Cisterns.

Messrs Sullivan Lockerbie & Seibert were appointed said committee.

On Motion of Mr. Seibert

Resolved That a Committee be appointed to examine the accounts of David Creviston for work on pumps etc. and report what is due him and also the manner in which he has performed his contract.

Messrs Seibert, McCluer & Lockerbie were appointed said committee.

Ordered that the Secretary issue orders to the several officers of the Corporation for their third quarters salary.

Council met. present Palmer President. Messrs Lockerbie Sullivan & Rooker Councilmen.

A communication was received from the Fire department of the town of Indianapolis nominating James Vanblaricum Messenger for the Engine Company in pursuance of previous orders of the Council: Whereupon the nominations was confirmed and James Vanblaricum declared Messenger for said Company for the term of One year.

On Motion of Mr. Sullivan

Resolved That the President of the Common Council be directed to dismiss the suits pending between the Council and M. Little upon said Little complying with the requisition, heretofore made.

Mr. Sullivan from the Committee heretofore appointed to examine whether Mississippi Street and Kentucky Avenue were fenced up, reported that said Streets were fenced nearly across and that said Streets were included within the fence of an adjoining block, and that said fence should be removed.

Ordered that the Marshal be directed to notify the persons having said Streets fenced to remove said fences within twenty days and that on their failure to remove the same, that the Marshal remove the same as nuisances.

Ordered That the Committee heretofore appointed to settle with David Creviston contractor on public wells; notify said Creviston that unless he shall have completed his contract and delivered the pumps and wells up to the Council prior to next regular meeting: that the Council will proceed to liquidate the several accounts growing out of the contract as Justice may require and also recind said contract.

Ordered That a remonstrance be presented the General Assembly now in session in Indianapolis remonstrating against the vacation of any Street or alley in the town of Indianapolis; and that the same be signed by the officers of the Common Council.

The Treasurer & Weighmaster each made monthly reports which were concurred in.

And the Council adjourned
