The above being the whole number of feet owned between the points named in said petition. The prayer of said petition is granted and said petitioners and owners on and along said side walk are ordered to grade and gravel said side walk within sixty days from this time otherwise that the proper officer of the Corporation cause the same to be done according to the laws and ordinances on that subject at the proper cost of the property owners aforesaid - Ordered further that the Surveyor and Engineer make all necessary surveys & estimates on said work according to the Ordinances - and further that said property owners have the privilege of using gravel from Louisiana Street for said work.

L.Dunlap presented a petition praying for permission to fill the side walk on the north side of lots Mos. 1. 2 & 3 in Block No. 77 with earth and that he take the earth from Alabama Street south of Bridge over Pogues run: which was pranted and said petitioner directed to do the same under the direction of the Engineer and Councilman from the second ward.

Isaac Kinder asked and obtained permission to take earth and gravel from Alabama Street south of Pogues run for the improvement

of the side walks around Block No 64. under the direction of the Engineer & the Councilman of the 2nd ward.

Ordered That the Councilman of the 2d. ward make suitable improvements for conducting the water across Alabama Street into Pogues run, on the North side of the Bridge, said improvement to be paid for out of the Road Tax of the 2d. ward.

A W Russell asks and obtains permission to haul the earth from his side walk into the Street and deposite the same at such place as the committee on the improvement of Maryland Street shall think said applicant is to pay all expenses.

James Blake asks permission to grade Market Street East of the Circle as far as Pennsylvania Street and make other improvements with the Earth and gravel that is about to be dug out of the Cellar of the first Presbyterian Church, which is granted and said improvements are ordered to be made under the direction of the Engineer and a committee consisting of Messrs Cox, Norwood and Goldsberry.

Ordered That the Councilman of the 5d. ward make suitable improvements in New York Street from the Marion County Seminary to Pennsylvanie Street and defray the expence of the same put of the road Tax of the 3d. ward.

An Ordinance entitled "An Ordinance for licensing Street Pedlars and Hawkers" was presented read and ordered to lay on the table
