Council met: All the members present but Mr. Black.

Mr. Nowland presented the petition of J. N. Spller, J. P. Drake and others, Citizens, praying a redution of the tax imposed on Theatrical Exhibitions. On reading the petition, Mr. Nowland moved to reduce the said tax to ten dollars per week, which motion was lost. Mr. Rooker then moved to reduce it to fifteen dollars per week, which motion also, was lost.

On Motion of Mr. Rooker

Resolved, That a select committee be appointed to draught an Ordinance amendatory of the ordinance entitled "An Ordinance to restrain the licensing of Groceries and Tippling houses in the town of Indianapolis, and for other purposes," and report the same at the next meeting of the Council. Messrs. Rooker, Rickards and Goldsberry were appointed said Committee.

On Motion of Mr. Rickards

Ordered, That the Secretary issue license to Mr. E. Browning to re-tail spirituous liquors, as a Tavern keeper, for one year, upon his presenting the Treasurers receipt for twenty five dollars; and otherwise complying the Ordinance on that subject.

The Treasurer made his monthly report which was read and received.

The President laid before the Council the following petition, to wit:

"To the honorable the Common Council of the town of Indianapolis: The undersigned Citizens of Indianapolis, would respectfully ask your honorable body to cause the side walk on the west side of Tennessee Street to be graded & gravelled between Washington and Maryland Streets, at the expense of the property holders along said side walk. -- That the town engineer be directed to make a survey of said side walk, and set stakes, and That the owners of lots thereon be allowed fifty days to complete the grading and gravelling.

The undersigned would further ask that the gutter next to the said side walk between the point aforesaid, may be surveyed and opened,

and two large stumps near Maryland Street taken out and removed by the town Supervisor, and your petitioners as in duty bound i.e.:
