Mr. William Montague Councilman Elect for the first Ward. Mr. James R. Nowland Councilman Elect for the third Ward, and Mr. Humphrey Griffith Councilman Elect for the fifth Ward, presented their Certificate of Election and took their seats as Councilmen.

The President laid before the Council the Bond of the Assessor, Thomas Donnellan for its acceptance and approval; Thereupon the same was accepted and approved.

On Motion of Mr. Nowland Ordered That the Salary of the Treasurer of the Common Council of the town of Indianapolis for the present year be fixed at fifty dollars.

On Motion of Mr. Rooker The Council proceeded to appoint a Treasurer for the town of Indianapolis; Whereupon John L. Welshans was duly appointed such Treasurer for the term of one year.

On Motion of Mr. Nowland The Council proceeded to appoint a Weighmaster for the town of Indianapolis --- Whereupon Adam Haugh was duly appointed such Weighmaster for the term of one year.

On Motion of Mr. Louden The Council proceeded to appoint a Market-Master for the East Market in the town of Indianapolis; Whereupon Jeremiah Warmajem was duly appointed such Marketmaster for the term of one year.

On Motion of Mr. Goldsberry The Council proceeded to appoint a Market Master for the West Market in the town of Indianapolis; Whereupon Jeremiah Warmajem was duly appointed such Marketmaster for the term of one year.

On Motion of Mr. Louden The Council proceeded to appoint a Messenger to the Fire Department --- Whereupon David Cox was duly appointed such Messenger for the term of one year.

On Motion of Mr. Louden The Council proceeded to appoint a Sexton to the Public Grave Yard ---Whereupon John O. Conner was duly appointed such Sexton for one year.

On Motion of Mr. Griffith

Resolved That a committee be appointed to examine the fence around the Public Grave Yard and cause all necessary repairs to be made to the same.

Messrs. Griffith, Rooker and Goldsberry were appointed said committee.

On Motion of Mr. Griffith

Messrs. Griffith, Rooker and Montague were appointed said committee.
