The principal Object of the meeting being in relation to the assessment, the following Ordinance was passed, towit.

An Ordinance to amend an Ordinance entitled "an Ordinance to raise a Revenue in the Town of Indianapilis Ordained and established the 1st day of March A.D. 1845.

Section 1st. Be it Ordained by the Common Council of the Town of Indianapolis, That so much of the Ordinance, to which this is an amendment, as requires the assessor to list the town of Indianapolis by Wards, be and the same is hereby repealed.

Ordained and established this 8th day of April A.D. 1845.

Ordered, That the Salary of the Treasurer of the Common Council, be fixed for the ensuing Year at Seventy five dollars.

Ordered, that the Salaries of the Clerks of the East & West Markets, be fixed respectively at fifty dollars, per year.

Ordered, that the Collector of Corporation Taxes, be allowed fifteen per cent, upon the amount of Tax collected.

The President appointed Messrs. Nowland, Van Blaricum & Goldsberry, a Committee to examine the lower Grave yeard with full power to make all necessary repairs.
