Council met in regular meeting, Present Joseph A. Levy, President, Messrs. Montague, Goldsberry, Nowland, Loudan, & VanBlaricum, of the Council.

Mr. Nowland chairman of the Committee on Public Wells etc. verbally reported the same to be in good Order.

No. lll Allowed P. Byrhet \$4.00 for work (as per acts filed) at public pumps.

The President laid before the Council, the Treasurer's monthly Report which was examined and received, also the Weighmasters Monthly Report, which was in like manner examined and received.

The President laid before the Council, the Petition of Catherine Noble, praying an extension of time to open the Streets enclosed, by herself and the heirs of Gov. Noble. The petition being read, and duly considered, it was Ordered, that the prayer thereof be not granted.

On Motion of Mr. VanBlaricum

Resolved, That the Committee on Streets, Alleys, and Side Walks, be authorized to receive sealed proposals, to erect or build a bridge, across the Central Canal on Maryland Street, -- and report their proceedings herein to the Council at their next regular Meeting.

Mr. Goldsberry, introduced "An Ordinance to prevent Nuisances," which was read, Ordained, and established, and the Secretary directed to cause the same to be published in the Indiana Journal, and Indiana State Sentinel without delay.

Mr. Nowland from Select Committee appointed at last regular meeting of the Council to examine the Lower Grave Yard, reported the extent of their examinations up to present date, and asked time until next regular meeting to report an Ordinance on the subject of Said Grave Yard, which was granted.

Mr. Montague, presented a petition, signed by a large number of Citizens, praying the establishment of an Ordinance, to cause all the Streets and Alleys belonging to, and laid off on the plat of the City and Donation, to be opened for public use, within reasonable time after its publication.

The Petition being read and considered, it was Ordered, that the prayer of the petitioners be granted, And that a committee consisting of three persons be appointed to report an Ordinance upon the subject to the Council at its next regular meeting— Whereupon the President appointed Messrs. Goldsberry, Louden and Montague such Committee.

On Mction of Mr. Goldsberry

Resolved, That the Committee on Streets, alleys and Side Walks be and they are hereby authorized to examine all the Bridges on Pogues Run, within the Donation, and Make Such repairs thereto, as may be deemed Necessary.

Ordered, That the Collector of Corporation Taxes for the year 1844, be authorized to demand, and the Treasurer of the Corporation be required to give Said collector his receipt deposited with Said Treasurer in July 1844 for the amt. of the duplicats of such year upon the payment by said Collector of the Balance due from him to the Corporation at the Settlement in March 1845.

On Motion of Mr. Loudon

The Council proceeded to the appointment of Messengers for the Marion, and Good Intent fire Companies for the ensuing year - When David Cox, was on the first ballot, duly appointed Messenger for the Marion Fire Engine Company, for the term of One year, at a Salary of Twenty five \$25.00 dollars, per Annum.

Jacob B. Fitler was on the first ballot duly appointed Messenger for the Good Intent Fire Engine Company for the term of One Year, with a Salary of Twenty \$20.00 dollars per annum.

On Motion, The Council adjourned.
