Council Chamber Indianapolis June 7, 1845.

Council met, Present, All the Members, except Mr. Griffith.

The President laid before the Council, the monthly report of the Treasurer, for the Month of May which was read and received.

The Weighmasters report for the Month of May last past, was presented, read, and received.

Mr. Nowland, chairman of the Committee appointed at a previous meeting to examine, and make necessary repairs of the Lower Grave Yard, presented the following Report towit.

The Committee to whom was entrusted the authority to repair the Lower Grave Yard beg leave respectfully to Report, that since the last regular meeting of the Council, the Committee have made arrangements to procure Ninety Six posts and rail, at 30 cents each, amounting in the aggregate to \$28.80 to be used in the repair of said Grave Yard. And that they have also caused the old gates to be removed, and two new ones to be erected, one on the North Side, and the other at the South Side of the lot, at a cost of \$20.00, which report was concurred in.

Mr. Louden, Presented a remonstrance of Sundry citizens, against the arrangements, and proceedings of the Committee on the Grave Yard -- which was read, and laid upon the table.

Youngerman & Horfgen, make application for Grocery license--Whereupon it is Ordered, That the Secretary issue license, to said Youngerman & Hoefgen, (upon the presentation by them of the Corporation Treasurers receipt for the Sum of fifty dollars, and otherwise Complying with the ordinances regulating such licenses) to commence on the 10th day of June A.D. 1845, for One Year.

On the application of John Butch for Grocery License--It was ordered that the Secretary issue such license to said Butch, upon the presentation by him of the Corporation treasurer receipt for the Sum of Fifty Dollars, and otherwise Complying with the provisions of the ordinance, regulating such licenses, - to comence on the 9th day of June A.D. 1845, and to continue in effect for the term of one year.

Issd. No. 120 Allowed N. H. Horwood \$3.87 for removing nuisances.

The account of P. Bryrhet, amounting to \$4.00 for pump work, and cleansing wells at the Corner of Wrights Pork House, was presonted and after consideration, was laid upon the table.

Issd. No. 125 Allowed John Monteeth \$1.12 for repairing bridge below Carlisle's Will.

- No. 126 Allowed Frederick Voight \$5.62¹/₂ for 1¹/₂ days work, as per act. filed.
- No. 127 Allowed Michael Shea \$0.75 for cleaning Gutter & Culvert at Palmers as per act.
- No. 128 Allowed William Wilkison 4.80g for hauling Gravel & plank as per act. filed.
- No. 129 Allowed Wm. Harbeit \$3.50 for getting 2 posts for lower ' Grave Yard. (this act. is to be deducted from Delaware's act. per order of the Council.)
- No. 130 Allowed Philip Michael $\sqrt[6]{7.06\frac{1}{4}}$ for articles for use of good Intent engine

The act. of William Wood amounting to \$2.25 for Gravel on Illinois Street, was considered, and laid upon the table.

- No. 131 Allowed Edward Wilson \$2.50 for digging sink a putting in curb, at Public pump, opposite McMillans Store in 4th Ward.
- No. 132 Allowed Isaac Davis 2.00 for putting in hose and pipes at well in Union Row.
- No. 133 Allowed Kenper & Buchanan \$7.62¹/₂ for repairing Bridge on South east diagonal across Pogues Run in 1st. Ward.
- No. 134 Allowed Abraham Smack (1.87) for timber furnished for use of Bridge over Pogues Run, on South East diagonal --(this act is deducted from the original **amt** Kemper & Buchanan act. per order of the Council . (to be paid to Abner Smith.)
- No. 135 Allowed T. M. Smith \$5.00 for labour performed by John Pogus in removing good Intent Engine House.

Issd. No. 124 Allowed Michael Barrett 40.75 for digging at Pogues Run Bridge --

The account of denjamin Ream, for #6.50 for removing Muisances as Marshall for the Year 1843, was taken from the table, and referred to the Committee on Claims.

Ordered That the Supervisor, give Notice to all persons having harket Street in the Town of Indianapolis enclosed, to cause the same to be opened within ten days after such Notice, and if said Street be not opened, before the expiration of said ten days, then the Supervisor shall be, and he is hereby authorized, to proceed forthwith thereafter to open or cause the same to be opened, under the order of the Common Council of the town of Indianapolis made herein, on the fourth day of January 1845, the said ninety days therein mentioned, being elapsed, and the Street not having been opened in pursuance of said order of the Common Council.

Thomas Donnellan Lister for the Town of Indianacolis appeared and presented, his list of assessments and valuations of Real and Personal property, etc, for the year 1845, which was received.

No's. 136 & 137 Allowed Thomas Donnellan, §100. in full for Service as Lister for the year 1845. Ordered, That a tax of twelve and one half cents, be levied upon each One hundred dollars of keal & personal property, returned by the Lister, also a tax of one dollar on each person charged with a poll, and fifty cents upon each dog, returned by the lister as aforesaid.

Ordered, That Tuesday the 17th inst be set apart as a day upon which the Com on Council will meet to hear and determine any and all appeals, which may be taken from the assessment and valuation as returned by the lister for the present year, and that the Secretary publish notice of Said meeting to take place at 2 o'clock P. M.

Mr. Montague, presented, for the Consideration of the Council the following proposition towit.

"Indianapolis May 30 1845.

"We the undersigned do agree to pay the amount severally annexed to our respective Names for the prupose of Cutting, levelling, and grading Each Street between Ohio and New York, inclusively Provided, the Corporation of Said town, will appropriate and furnish a Sufficient Amount thereto, to complete that part of Said Street, to the proper grade or level."

Which proposition after deliberation, was referred to the Committee on Streets and Alleys.

On Motion of Mr. Louden.

Resolved, That the Committee on the Fire Department be authorized to examine, and make such repairs of the Good Intent Engine House, as they may deem proper.

On Motion the Council adjourned to meet on Tuesday the 17th Inst. at 2 o'clock P. N.
