Mr. Griffith from Committee on claims to whom was referred the a/c of James Vanblaricum for costs do him as late Marshall reported back said claim and recommended that the amount of \$4.08 be allowed Mr. Vanblaricum being the amt. of said a/c which had been paid to Council on said a/c - Whereupon

Mr. Goldsberry offered a Resolution to fine the Marshall and Supervisor each Ome quarters salary for Non performance of duty, which On Motion of Mr. Griffith was laid on the table.

On Motion of Mr. Goldsberry

Resolved, That the President and Secretary of the Council, be and they are hereby appointed a Committee to petition the Legislature to repeal the law authorizing the Citizens of the incorporation to elect the corporation officers - and to cause the act repealed by the last mentioned law to be veried.

No. 355 Allowed Job Trough \$22.50 for timber, order to be issued to Alvord & deducted from the last appropriation to the Sixth Ward.

Mr. Van Blaricum from the Committee appointed to make enquiry whether the Council had power to tax real estate etc. Made the following Report, viz.

Your Committee appointed to make enquiry as to the power of the Corporation for taxing real estate within the limits of the donation, respectfully report, that by an Act approved Feby 17, 1836 such power of taxation fully rests in said corporation for road purposes.

Sec. 1 of said Act provides that the whole of said Donation shall be included within the limits, and be known by the name of the "town of Indianapolis."

The last clause of Section 12 of the same act provides that the Council shall have power to levy and cause to be collected, a Tax for road purposes "On all property that is or may be subject to taxation for County purposes; provided also that no tax on Real property shall exceed One half of One per centum in the value thereof.

Your Committee also recommend the passage of the following resolution.

Resolved, That it shall hereafter be the duty of the corporation assessor to assess all real property, within the limits of the donation for the purpose of enabling the Common Council to levy a tax for road purposes.

Resolved Further - That for public information the foregoing report together with these resolutions be published in the State Journal and State Sentinel.

All which is respectfully submitted.

Which report was concurred in with exception of the Publication of same.

Ordered, That the Secretary issue Orders to the respective officers of the Corporation for their 3rd quarters salary ending 1st. January A.D.1846.
