Council Chamber Indianapolis June 8th 1846.

The Council met pursuant to adjournment. President Levy in the chair. Messrs. Montague, Goldsberry, Harrison, Louden & VanBlaricum, Councilmen in attendance. Mr. Cady absent.

The Proceedings of the last two meetings were read and approved, without admendment.

The Treasurer of the Corporation presented his report of the Receipts and Expenditures at the Treasury during the Month of May last past, accompanied with the proper vouchers, which report was read and received.

Mr. Harrison, from the Committee on Streets, alleys & sidewalks made a report in relation to sundry improvements made, and contemplated to be made, during the present year in the incorporation, which report was read and concurred in.

Mr. Louden, from the Committee on Markets & Market Houses, laid before the Council, proposals for erecting public pumps on each of the Market spaces, which proposals were presented in pursuance of a Notice of said committee authorized to be given at the last regular meeting of the Council. The proposals were opened, and read, and it appearing that Mr. Davis was the lowest bidder his proposal was accepted.

The President laid before the Council a petition from William A. Holliday, asking privilege to use a portion of the surplus earth on the side walk on Lot no. 9 in Square no. 24 - referred to Committee on Streets etc.

Mr. Harrison introduced an Ordinance to amend the 18th Section chapter 7 of the Ordinance regulating the Market in the town of Indianapolis which was read ordained established, and ordered to be published.

On Motion of Mr. VanBlaricum

Resolved, That the Committee on Streets & Alleys be and the same is hereby authorized to do, or cause to be done, any work on any of the Streets or alleys or bridges, in the town of Indianapolis, that in the opinion of a Majority of Said Committee is wanting to be done.

The President laid before the Council the Assessment list returned by the Lister for the present year, which was accepted.

Ordered, - That a Tax of 20 cents be levied on each One hundred dollars of Real and Personal Property, - One dollar on each poll - One dollar on each person chargeable with Road Tax - 50 cts. on each dog, and \$5.00 on each Bitch returned by the Corporation lister for the year 1846.

Mr. Louden, moved that the Lister be allowed fifteen dollars in addition to the Salary fixed by the Ordinance regulating fees & salaries, for extra services performed by him in making out the Assessment for the present year. And the ayes & nays being demanded, Those who voted affirmatively were Messrs. Montague, Louden, VanBlaricum & Mr. President-4. Those who voted negatively were Messrs Goldsberry & Harrison 2, so said allowance was granted.

Ordered, That the Secretary issue an Order to John Coen, Lister for the town for the amount of his yearly salary.

(Issued No. 440)

On Motion of Mr. Harrison

Resolved, That the regular meeting of the Council shall be held on the first Saturday in each Month of the Year.

And on Motion the Council adjourned to meet on the 13th inst. at 4 o'clock P. M.
