Council Chamber Indianapolis August 1st 1846.

The Council met - Present Joseph A. Levy President - Messrs Montague Goldsberry, Harrison, Louden & VanBlaricum.

That the Secretary issue such license to said Little upon the presentation of the Treasures receipt for the sum of Thirty five dollars and otherwise complying with the Ordinance upon that subject.

Ordered, That the Town Surveyor and Engineer be directed to fix the Grade of the side walk on Washington Street immediately in fron of Messrs Johnson's property for paving purposes.

Ordered, That the committee on Streets etc. be authorized to contract for the erection of a Bridge on Meridian Street, over Pogues Run.

Ordered, That an appropriation of \$10.00 be made for the repair of a Mud hole on the North west corner of the donation, and that the Supervisor direct such repair.

Ordered, That the Rail Road company have privilege to grade South Street in fron of the Depot location.

Ordered, That the Councilmen of the Second ward, in Overseeing the grading of parts of Delaware and South Streets under the Order of the Council heretofore made, may dispose of any earth, which, by the filling of parts of said streets from other sources than streets, may not be needed for filling such parts of said streets, in any way said Councilmen shall find serviceable towards completing said grade on said streets, without expense to the town.

An act. of John S. Watts for ground rent of the Good Intent Engine amounting to \$12.00 was presented, read, and laid upon the table.
