These bids are all too high, and the city will have to pay large sums of money for her proportion of the work.

# CONTRACT AND BOND OF THOMAS WREN.

This Agreement, made and entered into this 20th day of July, 1863, by and between Thomas Wren, of the county of Marion, and State of Indiana, of the first part, and the Common Council of the City of Indianapolis, of the second part :

Witnesseth, That the said party of the first part does covenant and agree to grade and gravel the first alley west of the Madison railroad track, running north and south from McCarty to Ray streets, at 34 cents per cubic yard for grading, and 84 cents per cubic yard for graveling, said amount to be collected by the party of the first part at his own expense, from the owners of property bordering on said improvement, according to their respective number of feet, and from the Common Council for the crossings of streets and alleys, in corporation orders, or city bonds, running two years, payable with six per cent interest, but payment thereof to be withheld so long as any sums remain unpaid to laborers employed by the contractor for work done in prosecution of said improvements. It is further understood that no assignment of this contract shall be made to any other party without the consent of the Common Council. The party of the first part further agrees to execute the work in accordance with the following specifications, viz: The alley to be graded full width according to stakes to be set by the Civil Engineer. The contractor to furnish at his own expense all the earth necessary for the proper completion of the contract, or if a surplus, shall remove the same to some street or alley as directed by the Engineer, not exceeding a distance of half a mile, and there level the same to his satisfaction. The centre of said alley to be graveled with good river or creek gravel, fifteen feet wide and fifteen inches deep in the centre, sloping to five inches at

either edge. The sidewalks to be graveled with good river or creek gravel to the depth of six inches.

To be finished on or before the first day of September, '1863, to the entire satisfaction of the Civil Engineer, and should said work not be finished by the time specified, and according to the above specifications, then the said party of the second part shall have the privilege and option of forfeiting this contract, and of releting the same, and the party of the first part shall be responsible for all damages that may accrue by said failure to perform said work according to contract.

By Mr. Brown:

INDIANAPOLIS, July 20, 1863.

To the Mayor and Common Council of the City of Indanapolis: GENTLEMEN:—The claim of Henry Giesel, Esq., for services rendered by him as a member of your body, having been referred to me for consideration, with instructions to report thereon, I beg leave to say, that, having carefully examined the matter, I have no hesitation in deciding that the claimant is entitled to full compensation for every session of your body at which he was entitled to a seat in accordance with the decision of the courts.

The case of Mr. Giesel, I will briefly remark, is by no means that of the other three gentlemen who were elected at the same time with himself. One of the latter left the city, and emigrated to a foreign country. Another went into the army, without prosecuting his claim to a seat. And the third, although remaining in the city, also failed or neglected to prosecute his rights. The Council, therefore, in my opinion, is or would be under no obligation to pay any one of them for services which they made little or no effort to claim the right to discharge. But the case of Mr. Giesel, I submit, presents an entirely different aspect. He has persistently, and unceasingly urged his claim to a seat, not only before your own body, but, as already observed, before the Courts of the country. These latter, after repeated hearings, finally decided in his favor, thereupon he at once took a seat among your body, where he served until the expiration of his term. But that he did not do so sooner, was not his fault and indeed, his prompt readiness to serve as a member of the Council when allowed, clearly demonstrates that he would have been equally prompt in doing so at any time from the period of his election, had it been in his power. I am, therefore, clearly of the conviction that the claimant is lawfully entitled to compensation for the whole of the term for which he was chosen.

AN ORDINANCE to provide for the furnishing and erecting of lamp posts, on Meridian street, between North street and the corporation line.

SECTION 1. Be it ordained by the Common Council of the City of Indianapolis, That Meridian street, between North street and the donation line be properly lighted according to the general plan of lighting the city, and that the expense of furnishing and erecting lamp posts, lamps and fixtures on such street, as aforesaid, (except so much thereof as is occupied by the crossings of streets and alleys,) be assessed against, and collected from, the owners of the lots bordering on said street, between the limits aforesaid, according to the provisions of sections 66 to 69, inclusive, of the city charter.

SEC. 2. The Civil Engineer is hereby directed to set the proper stakes and also to advertise by publication for ten days in the Indianapolis Daily Journal, and by posting up printed notices in not less than five of the most public places in the city, that sealed proposals will be received by the Common Council, at the meeting of the Council to be held on the 10th day of August, 1863, for the execution of said work.

SEC. 3. This ordinance shall take effect and be in force from and after its passage.
