By carefully examining the foregoing statements, it will be seen that the actual urrent expenses, for general purposes, of the city, for the year ending May 13, 1865, were \$35,717 89, less than the receipts for general purposes for the same year; and that the balance in treasury May 13, 1864, was \$4,183 90, making a total receipts and balance over and above disbursements of \$39,901 79; and the outstanding orders, May 13, 1864, both in general and war funds, being \$47,315 35; from which take the receipts and balance, as above, would leave a total indebtedness, May, 13, 1865, of only \$7,413 56; which would be a very good condition for the treasury of a city of the population of Indianapolis.

It will be seen, on the other hand, that the war debt is a large one; not so large, however, as might have been, owing to the unsettled condition of the country, and the trying ordeal through which we, as a nation, have passed; but the war is ended and the Union is preserved. We ought, therefore, to consider our war debt small, when we compare it with the value of such a country as ours, and when we contemplate that we have done only our duty, as a city, in defending the flag of our Union and assisted in crushing one of the most gigantic rebellions the world has

ever known.

I would ask to again express my appreciation of the cordial support given me by your honorable body in discharging the duties of my office, and especially to His Honor, Mayor Caven, who has rendered me invaluable service during the fiscal year just closed; and for your good will and co-operation, and that of all other city officers, I desire to return my sincere thanks.

Gentlemen:—The Finance Committee would respectfully report to your honorable body a statement of the indebtedness of the city, up to the 13th day of May, 1865, and also a statement of the estimated expenses for the year, from May 13th, 1865, to May 13th, 1866; and also a statement of the estimated expenses from May 13th, 1866, to October 31st, 1866. The estimated expenses of the city government for one year, ending May 13th, 1866, we have made at a fair estimate to be \$214,424.50, and from that time to the 31st day of October, 1866, \$101,369.50; added to the present debt of the city would make the indebtedness, \$684,741.22.

## Leaving indebtedness and estimated expense Oct. 31, 1866\_\_\_\_\_\_\$393,741 22

It will be seen that the greater portion of the city indebtedness has been incurred in relieving the city from the drafts of 1864 and 1865; in furnishing fuel to the poor; erecting House of Refuge; relief of soldiers' families, and other sundry

accounts, such as Pest House expenses, &c. Excluding the expenses of the above named objects, the city, on the 13th day of May, 1865, would have had cash sufficient in the treasury to pay all orders issued on the treasury to May 13th, 1865, without a single outstanding liability. It is doubtless apparent that in order to reduce our system to a cash basis, a sufficient amount must be realized, either by taxation, or the sale of city bonds, to meet the current expenses of the city until the 31st day of October, 1866, and to redeem, also, outstanding orders. The advantages of a cash system are quite obvious, if bonds can be sold at a just and fair rate, and we are led to believe they can be so disposed of. We are of the opinion that the annual saving from this system will more than meet our interest on the city debt. We cannot too strongly recommend the continuance of rigid economy in all departments of the city government. It will be seen by an examination of the Clerk's report, that by deducting the expenses incurred by being engaged in this unholy rebellion, that the actual city expenditures were only \$136,212 07, from May 13, 1864 to May 13, 1865. We would also recommend that bonds to the amount of four hundred thousand dollars be issued to fund the city debt, to run any length of time the Council may, in its discretion, think best.

Providing for a levy of one dollar on the one hundred dollars for general purposes, and a levy of —— cents on the one hundred dollars for special purposes.

Which was read the first time.

Mr. Emerson moved to fill the blank for levy for special purposes with fifty cents.

Mr. Loomis moved to fill the blank, with seventy-five cents.

The question being on filling the blank, the ayes and noes were demanded.

The motion to fill the blank with fifty cents having the precedence, under rule 17 of Council, the question was put:

Shall the blank be now filled with the words "fifty cents"?

Those who voted in the affirmative were Councilmen Boaz, Brown, Coburn, Colley, Emerson, Fletcher, Glazier, Grosvenor, Jameson, Kappes, Schmidt, Seidensticker, Staub and Thompson—14.

Those who voted in the negative were Councilmen Allen and Loomis—2.

So the motion to fill the blank with fifty cents, was adopted.

On motion of Mr. Emerson, the ordinance was then read the second time, as follows:

An Ordinance to raise a revenue for general and special purposes for the City of Indianapolis for the year one thousand eight hundred and sixty-five.

Section 1. Be it ordained by the Common Council of the City of Indianapolis: That there shall be and hereby is levied, and there shall be assessed and collected for general purposes of the city, one dollar on each one hundred dollars in value of all property for taxation, in the general list of taxables of said city for the year eighteen hundred and fifty-five and on each poll therein the sum of fifty cents.

Sec. 2 Be it further ordained, That the further and additional tax of fifty cents on each one hundred dollars in value of all property for taxation in said city in the general list of taxables of said city for the year 1865, be levied and assessed for the following specific purpose, to-wit: to pay "all bonds, orders heretofore issued, and appropriations made by and under the authority of the Common Council aforesaid, for the purpose of procuring and furnishing volunteers and substitutes for drafted men of the army and navy of the United States, and for maintaining the families of volunteers, soldiers, substitutes or drafted men, or otherwise to aid the Government in suppressing the rebellion."

Sec. 2. This ordinance shall take effect and be in force from and after its

passage.
