The Common Council met in regular session.

REPORTS FROM CITY OFFICERS.

The City Civil Engineer submitted the following report :

INDIANAPOLIS, June 7, 1875.

To the Mayor and Common Council of the City of Indianapolis :

Gentlemen:—I hereby report a second, *corrected*, and final estimate allowed D. Root & Co., for erecting lamp posts, lamps and fixtures on Madison Avenue, from Morris to Nebraska street.

INDIANAPOLIS, June 7, 1875.

To the Mayor and Common Council of the City of Indianapolis :

Gentlemen :—I herewith give you in detail, as far as my examination has extended, the extent of the damage sustained by the city during the recent high water, in the different sections of the city, and which requires your immediate attention.

I cannot give you the exact figures on account of the quantity of water at the various points.

I find that Fall creek, during high water, overflows on Millersville pike, just below the Peru Railroad bridge, and passes down through Fletcher's swamp, Car Shops, Root and Allen's addition and all the low grounds in that section, and passes west on Home Avenue, south on Delaware, and across to Pennsylvania, etc.

I would respectfully recommend the raising of the grade on Millersville pike at the point above mentioned sufficiently high and strong in order to prevent a like occurrence.

I also find the embankment on both sides of the new channel of Fall Creek has been washed out to an extent of from 200 to 250 feet on both sides, immediately below Geisendorff's dam, and about 320 feet on the north side and 200 feet on south side near the mouth.

These breaks ought to be filled up at once, and the slopes on both sides of embankment sodded over, or sown with grass seed and young willows planted, as this will materially strengthen the banks and lessen the danger of washing during high water.

The breaks at Geisendorff's dam should be made about 5 feet wider than formerly.

It will also be necessary, and I would respectfully recommend the building of an embankment on the east side of White river, from the north side of Fall creek, running north about 400 feet, in order to prevent the water of White river from washing out the bank of Fall creek, on the north side, during high water.

On account of the recent high water in White river and Fall creek, there has been about 170 feet of the improved portion of west Michigan street washed out at a point where the old channel of Fall creek crosses Sand street. On account of the water in the channel I could not ascertain the exact number of yards. I would recommend the repairing of this street at once.

I would also recommend to your honorable body the enlarging of the west bank of Fall creek, from Geisendorff's dam to the high bluff north of the pest house, by raising and widening the same so as to make it 3 feet above high water mark, and about 5 feet wide at the top.

I also find that culvert on Clifford street, over Pagues run, has given away some 8 or 10 feet and needs to be rebuilt. I understand that the contractor, who built this culvert, has given bond that it would stand five years, and can be made to do this work at his own expense.

I also find that the culvert on East Michigan street has given away some 10 or 12 feet at the north end and will have to be rebuilt at once.

I also find that the culvert on Morris street has given away at the north end some 10 or 12 feet and requires rebuilding.

I also find that east end of culvert on Illinois street, crossing Pagues run, needs slight repairing.

This can be done by the Street Commissioner under the supervision of myself.

I also find that embankment at White river bridge, on Morris street, on northeast and northwest corners, requires filling up and protecting with cinders or stone at the base. This work can be done by the Street Commissioner, under the supervision of myself.

I also find that wooden bridge, at the north end of Delaware street over the State ditch in front of Exposition buildings, is down and needs to be rebuilt.

This work can be done by the Street Commissioner under the direction and supervision of myself.

To the Mayor and Common Council of the City of Indianapolis

I herewith return the communication and bond of Andrew Wallace, referred to me on 24th day of May, 1875, for an opinion as to the liability of the city to pay interest on said bond after the same became due, without being presented for payment.

After an examination of the matter, I am of the opinion that the obligation submitted to me, is the promissory note of the city, it being a contract to pay a certain sum at a certain time, and that the holder is entitled to interest from the date of its maturity, whether it was presented for payment or not, unless the city can show that she was ready at all times since the maturity of the same to pay off said order.

This position, I think, is fully sustained by the following authorities :

The obligation does not fix any rate of interest, and therefore it will only bear the rate fixed by statute, to wit : six per cent., per annum.

I am satisfied that the city would save hundreds of dollars if she had some one whose business it should be to look up the evidence in cases in which the city is interested. It is impossible for the City Attorney to perform this work, if it were his duty to do so. I therefore suggest that the City Marshal be required to do this work, and that the Council pay him for the actual labor performed in that behalf.

The Gas Inspector submitted the following report :

INDIANAPOLIS, June 7th, 1875.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen :—I would respectfully submit for your consideration the following report of the work and expenditures of my office for the past year, from May 1st, 1874, to May 1st, 1875.

On taking possession of the office after my appointment, I found very little in it, and at my own expense I purchased several pieces of apparatus, and some expensive

chemicals with which to conduct tests. I also found a great many of the Cincinnati pattern tin lamps broken, and to save expense to the city I went to work at them myself, and during the year I repaired about 50 of them.

Of the old lamp cocks that came in, I fixed as many as were fit to be used again, the others I traded for new ones.

During the year I noticed that the gas bill for the Illinois Street Tunnel was higher than it ought to be, and permission was granted by the Council to make a change. Accordingly, I purchased 4 locomotive head-lights and fitted them up for gas, performing the labor myself, and the result was the saving of over \$150.00 per month in the gas bill. I would further say, that a few weeks before my time was out, some person set fire to the drip-cock in the reflector boxes, burning them so that they became useless. I have taken two of the boxes to my shop, and with the consent of your honorable body, will take the other two and repair them, and fit them up in the tunnel again by the first of the present month, at no cost to the city.

I would also state, that during the year I have tested for the Gas Company 835 meters, 25 of which I rejected as incorrect; the remaining 815 being within the 2 per cent. limit, I badged as correct.

I have also, from time to time, conducted Photometrical and chemical tests as to the illuminating power and purity of the gas furnished to the city and consumers, and have found it to be of excellent quality. At no time did I find the candle power less than 18 candles, and though there were traces of impurity, I could not get a weighable quantity. The only trouble with the gas is the high pressure, and that should be looked after. I had a great deal of trouble through the winter with frozen lamps, for which it is hard to suggest a remedy, as the winter was unusually severe, and the same thing may not happen again in years.

During the year I have located and superintended the erection of 454 lamp posts, all of which were erected according to contract, and were accepted.

The expenses of my office for the year amounted to \$72,436.03, of which amount \$53,242.00 was paid for gas for street lamps, \$6,659.60 was paid for gas for the engine houses and other places, \$6,568.08 was paid for lamp-lighting, leaving a balance of \$5,966.35 for repairs on street lamps, etc.

On leaving the office, I stored away in the Photometer room all the material I had on hand, viz: 12 boxes glass, 3 cases matches, about 20 dozen burners, and the apparatus belonging to the city laboratory, which are all in good condition. The year was one of hard work, and the only regret I have, is that I was unable to accomplish more work than I did.

The affidavit of the City Assessor, the City Clerk, and the City Treasurer, is herewith appended, showing that the Tax Duplicate for the present year will exceed \$70,000.000.

We also beg to submit for your approval, an ordinance to provide for the issuing and sale of warrants to the amount of \$50,000.00, to provide for the payment of the semi-annual interest falling due July 1st, 1875. Also, an ordinance to authorize the negotiation of a loan, and providing for the issuing of bonds to the amount of \$200,000.00, on twenty years time, for the payment of the warrants falling due in September and November, 1875.

Your Committee are deeply impressed with the fact that this course is necessary to maintain the credit of the city; and in our judgment the policy pursued by the Council for the past few years in carrying over, from year to year, large amounts of indebtedness, and borrowing money temporarily to keep up the current expenses, would, under present circumstances, be inexpedient and unwise, and we cannot recommend a continuance of it. What is needed now, is the strictest economy in all the departments of the city, and the limiting of the expenditures to the actual receipts of the treasury; and providing for and maintaining, as the charter provides, a sinking fund for the gradual payment of the accumulated debt. This can be done by an increase of the tax levy, which will not prove a hardship upon the tax-payers, as the rate of taxation has been lower here than in most cities.

The expenditures for the past few years have exceeded the revenue over \$200,000, each year, and it now becomes us to carefully guard against any increase of the debt in the future. It is the opinion of your Committee that expenses can be considerably curtailed in the expenditures for bridges, cisterns, fire department, purchasing gravel roads, hospitals, sewers, street improvements and street repairs.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—The covered wooden drain which the City recently constructed at the intersection of Randolph and Michigan streets, just west of the Indiana State Reformatory grounds, has been proven, by the late rains, to be wholly inadequate for the purpose of carrying away the accumulated water in the crooked run. The volume of water collecting at that point and finding no outlet, backs up and overflows the Reformatory grounds, causing great damage and interfering very seriously with the improvements now being made by the State.

This sewer should be nearly three times its present size, in order to accomplish the purpose for which it was placed there. I ask, therefore, the immediate attention of your honorable body to this subject, in order that the city may not be made liable for damage done to State property.

Accompanying this I send you the report of Mr. Wm. H. Morrison, Civil Engineer, to whom was entrusted the examination of the grounds.

Sir :—I have examined, since the recent rains, the covered wooden drain built by the city immediately west of Randolph street, and south of Michigan street ; and the valley of the branch running through the Reformatory grounds, and have to report, that said drain or sewer is insufficient to carry off the water of the branch, and therefore materially injures the Reformatory grounds.

The average area of the cross section of the natural channel of said branch above the State grounds, is about thirty square feet ; and in high water this channel is insufficient ; the water overflowing the adjacent grounds. My judgment is, that a covered drain, to pass the water of this branch without much damming up of the water, ought to have a cross section of not less than forty (40) square feet ; whereas the area of the cross section of the wooden drain constructed by the city is only about sixteen (16) square feet.
