INDIANAPOLIS, July 6, 1875.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—I would recommend as matter of necessity, the building of two catch basins; one on the south-west corner of Market and Pennsylvania streets, and the other on the north-west corner of Virginia avenue and Maryland street.

These should be done immediately, as the gutters will have to be changed at said points, and I would respectfully recommend that this matter be referred to the Committee on Streets and Alleys in connection with myself, with power to act.

#### Also, the following report:

#### INDIANAPOLIS, July 6, 1875.

To the Mayer and Common Council of the City of Indianapolis:

Gentlemen:—I was directed by your honorable body, in connection with the Street Commissioner, to examine the grade of Tennessee street, between McCarty and Ray streets, with a view to the prevention of the overflow of water into private property along the line of said street. Would report that we have examined the same, and find that since the canal has been filled, that the water of this locality must be drained along McCarty street into Pogues run. In order to do this, it will be necessary to lower the gutters on Tennessee street from Ray to McCarty street, and grade and "pave the sidewalks with brick between said points. If the sidewalks are only filled with gravel, it must be done at the expense of the city, hence we recommend the grading and paving of the same.

#### COMMON COUNCIL.

I was also directed to examine the gutter sewer on west side of Mississippi street, between Washington and Maryland streets, and report the best method of draining the same at that point; would report that, in my opinion, the best plan will be to boulder the gutters on the west side of Mississippi street, and boulder and curb the east side of same.

There is not much fall at this point, and the gutter sewer is but a one foot pipe, and if the Street Commissioner should clean it out it would fill up again inside of one month.

I was also directed to report the best plan for getting rid of the water that accumulates in the gutters on East street immediately north of Massachusetts avenue. Would report that I have examined the same, and find it best to recommend the curbing of the sidewalks, and bouldering the gutters on East street, from Massachusetts avenue to St. Clair street, and regrading said street between said points.

# Also, the following report :

#### INDIANAPOLIS, July 6, 1875.

To the Mayor and Common Council of the City of Indianapolis :

Gentlemen :---I deem it my duty to inform you of a large waste in the consumption of gas in the City Station House.

There was consumed at this point during the month of July, 24,500 cubic feet of gas, against 8,000 cubic feet for the month previous, making a difference in the consumption of gas at said point between the month of May and June of 16,500 cubic feet.

I would recommend that the parties in charge of the Station House be instructed to look after this matter, and try and prevent a like waste in the future.

I would also call your attention to the difference in the consumption of gas between the east and west side of the Illinois street tunnel.

The east side consumed during the month of Jnne 27,800 cubic feet, and the west side consumed but 20,000 cubic feet, making a difference in the consumption during the month, between the two sides of the tunnel, of 7,800 cubic feet.

This is accounted for from the fact that the west side of the tunnel which consumed the least is lit up by two large reflectors, one located at each end of the tunnel, and

only two drop lights in the center, while the other side has no reflectors and is lit entirely by drop lights, eight in number.

I would recommend the erection of two additional reflectors in the east side of said tunnel, as it will be a large saving of gas to the city.

#### INDIANAPOLIS, July 6, 1875.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen :-- The second high water has washed out the covered wooden drain on Randolph street, south of Michigan street and over the branch or creek running through the Reformatory grounds.

This drain had a capacity of sixteen square feet, but it was insufficient to carry off the water of said branch or creek. Nevertheless the damage would not have been so great had not the Reformatory people built a bridge two and a half feet high, immediately east of sxid drain, thereby lessening the capacity of said covered drain from sixteen to six square feet.

I would recommend the building of a brick culvert, six feet in diameter, across and along Randolph street to the south line of Michigan street, to take the place of said wooden drain, and enlarging the wooden drain on Michigan street, to correspond in size with said brick culvert.

Randolph street is under contract, and the work on said street cannot be finished until this culvert is put in, and I would therefore suggest that your honorable body order the same to be done at once.

The creek passes under Randolph street through a sewer, and owing to the small size and defective construction of the sewer, a leak occurred under the grade which I had constructed, cutting out and washing away several hundred cubic yards of finished street, thus damaging me to the amount of twenty-five cents per cubic yard, for which loss and damage I pray your honorable body to make me suitable compensation.

#### INDIANAPOLIS, July 6, 1875.

To the Mayor and Common Council of the City of Indianapolis :

Gentlemen:—I was directed by your honorable body, in connection with the Street Commissioner, to examine the grade of Tennessee street, between McCarty and Ray streets, with a view to the prevention of the overflow of water into private property along the line of said street. Would report that we have examined the same, and find that since the canal has been filled, that the water of this locality must be drained along McCarty street into Pogues run. In order to do this, it will be necessary to lower the gutters on Tennessee street from Ray to McCarty street, and grade and "pave the sidewalks with brick between said points. If the sidewalks are only filled with gravel, it must be done at the expense of the city, hence we recommend the grading and paving of the same.

I was also directed to examine the gutter sewer on west side of Mississippi street, between Washington and Maryland streets, and report the best method of draining the same at that point; would report that, in my opinion, the best plan will be to boulder the gutters on the west side of Mississippi street, and boulder and curb the east side of same.

There is not much fall at this point, and the gutter sewer is but a one foot pipe, and if the Street Commissioner should clean it out it would fill up again inside of one month.

I was also directed to report the best plan for getting rid of the water that accumulates in the gutters on East street immediately north of Massachusetts avenue. Would report that I have examined the same, and find it best to recommend the curbing of the sidewalks, and bouldering the gutters on East street, from Massachusetts avenue to St. Clair street, and regrading said street between said points.

#### INDIANAPOLIS, July 6, 1875.

To the Mayor and Common Council of the City of Indianapolis :

Gentlemen :--- I deem it my duty to inform you of a large waste in the consumption of gas in the City Station House.

There was consumed at this point during the month of July, 24,500 cubic feet of gas, against 8,000 cubic feet for the month previous, making a difference in the consumption of gas at said point between the month of May and June of 16,500 cubic feet.

I would recommend that the parties in charge of the Station House be instructed to look after this matter, and try and prevent a like waste in the future.

I would also call your attention to the difference in the consumption of gas between the east and west side of the Illinois street tunnel.

The east side consumed during the month of Jnne 27,800 cubic feet, and the west side consumed but 20,000 cubic feet, making a difference in the consumption during the month, between the two sides of the tunnel, of 7,800 cubic feet.

This is accounted for from the fact that the west side of the tunnel which consumed the least is lit up by two large reflectors, one located at each end of the tunnel, and

only two drop lights in the center, while the other side has no reflectors and is lit entirely by drop lights, eight in number.

INDIANAPOLIS, July 6, 1875.

To the Mayor and Common Council of the City of Indianapolis :

Gentlemen :--Your Committee on Sewers, to whom was referred sundry petitions and ordinances, make the following report :

#### FIRST.

The petition of J. C. New and others for straightening Crooked Run, we recommend that the stone culvert under Arsenal avenue be moved north so that the water will run straight through.

#### SECOND.

In regard to the motion of Mr. McGill, to advertise for bids for the construction of a brick sewer in Illinois street, from Washington street to the South street sewer,

we would recommend that the City Civil Engineer be directed to examine the locality and advertise for bids for the construction of a brick sewer as above, of sufficient size (to be determined by him), to carry the water and sewerage.

#### THIRD.

The ordinance for the construction of a brick sewer in Washington street from Pennsylvania street to Pogues Run, would recommend that, provided it is legal to issue 20 year bonds for the payment of the same, and provided the County Commissioners will appropriate \$2,000 for the payment of said sewer, that it be built from Pennsylvania street to Alabama street or New Jersey street.

## FOURTH.

An ordinance for a two-foot cement pipe sewer in and along Indiana avenue from west side of Tennessee street to connect with the Illinois street sewer, we recommend that the ordinance be postponed indefinitely.

#### FIFTH.

Also an ordinance for the construction of a sewer in Madison avenue from Dunlop street to the Ray street sewer, we would recommend that the ordinance be ndefinitely postponed.
