To the Mayor and Common Council of the City of Indianapolis:

Gentlemen: -The undersigned respectfully show to your honorable body:

- 1st. That they were duly appointed by the Judge of the Circuit Court to act as Commissioners to assess damages and benefits "accruing to the owners of lands and lots through which any street is proposed to be constructed or altered, or any building appropriated, or through which any creek or other water course is proposed to be straightened, or of which the course is proposed to be altered."
- 2d. That they did, as required by law, take and subscribe the oath and affirmation by law required.
- 3d. That they were and are duly qualified to act as such Commissioners, and dopossess lawful authority to assess benefits and damages.

SECOND.

Your Commissioners do further report-

1st. That on the 10th day of May, 1876, they met at the City Clerk's room, pursuant to the notice hereto annexed, marked exhibit "A."

2d. That they did, at the time and place aforesaid, enter upon the consideration of the matter of laying out, open and widen Sullivan street on the east side from Buchanan street to Bismark street, more fully described in the resolution to us referred and hereto annexed, marked exhibit "B."

3d. That they did inquire into the matter of the service of notices upon property owners, and do herewith report said notices with the Marshal's indorsement of service thereon.

THIRD.

The said Commissioners do further report that they did, at the time aforesaid, examine the real estate proposed to be appropriated, and did, at the time and place indicated in said notice, hear evidence touching the questions before them, and did also view the premises.

FOURTH.

Your Commissioners do further report-

1st. That all the witnesses who testified, with one exception, say that they do not want the street widened, but instead thereof, they do want Sullivan street straightened on the east side on a line with the north end of said Sullivan street, from Bismark street to Buchanan street, thereby making Sullivan street 50 feet wide throughout its whole length, and to condemn the portion of ground lying between said lines thus made, and the lots adjoining it on the east.

Your Commissioners do therefore recommend that the street be not widened, but that it be straightened as indicated above, and that the portion of ground lying east of a line running parallel with and fifty feet east of the west line of Sullivan street from Buchanan street to Bismark street, which is now a part of Sullivan street, be condemned, thus making Sullivan street fifty wide throughout its whole length.

And your Commissioners do assess benefits as follows:

That they did, at the time aforesaid, examine the road proposed to be appropriated, and did at the time and place indicated in said notice, hear evidence touching the questions before them, and did also view the premises and that they did estimate—

- 1st. What part thereof, if any, ought to be borne by the city.
- 2d. What real estate, if any, would be benefited by the improvement.

FOURTH

Your Commissioners do further report-

- 1st. That the value of the road to be appropriated is in the aggregate one thousand, six hundred and forty dollars (\$1,640.00).
 - 2d. That the city should pay the whole amount thereof.

That we do assess the benefits in full to the city of Indianapolis.

That we do assess damages as follows, to-wit:

Upon a parcel of ground owned by the Central Plank Road Co. and described as follows: From a point three hundred (300) feet west of the Washington street bridge across White river to the western boundary line of the city (about one mile in length), and which is of the value of one thousand six hundred and forty dollars (\$1,640.00).

That the benefits aforesaid are such as the city would receive.

That the damages assessed are such as said Central Plank Road Co. would sustain.

Your Commissioners do therefore recommend the said gravel road heretofore described be condemned as prayed, and that the damages be paid according to law.

Mr. Byram introduced general ordinance No. 24, 1876, entitled:

An ordinance to amend an ordinance entitled "An ordinance providing for the reorganizing of the police force of the City of Indianapolis," passed May 18, 1874.

Mr. Craft introduced general ordinance No. 25, 1876, entitled:

An ordinance appropriating money for the use of the Chief Fire Engineer.

Which was read the first time.

Mr. A. L. Wright introduced general ordinance No. 26, 1876, entitled:

An ordinance to provide for the compensation of the city officers and the officers and members of the police and fire departments for the fiscal year ending May 15, 1877.

Mr. Ransdell introduced general ordinance No. 27, 1876, entitled:

An ordinance providing for the management of the City Hospital of the city of Indianapolis, and repealing an ordinance entitled "An ordinance providing for the management of the City Hospital of the city of Indianapolis," ordained and established May 25th, 1871.

Which was read the first time.

Mr. Reed introduced general ordinance No. 28, 1876, entitled:

An ordinance to provide for the better protection of Indianapolis manufacturers, mechanics and laborers.

Which was read the first time and referred to the City Attorney for a report as to its legality.

Mr. Ransdell moved to suspend the rules for the purpose of placing general ordinances Nos. 24, 25, 26 and 27, 1876, and general ordinance No. 21, 1876, on their second and third reading and final passage.

Which motion was adopted and the rules suspended by the following vote:

Affirmative—Councilmen Adams, Buehrig, Bugbee, Byram, Case, Craft, Darnell, Kenzel, Laughlin, McGill, McGinty, Ransdell, Reasner, Reed, Schmidt, Steinhauer, Stratford, Webster, Wright, Arthur L. and Wright, William G.—20.

General ordinance No. 24, 1876,

Was read the second time and ordered engrossed.

General ordinance No. 25, 1876,

Was read the second time and ordered engrossed.

General ordinance, No. 26, 1876,

Was read the second time.

Dr. Startford moved to amend by inserting after the word employed in section 5, the words "provided they receive no fees in city cases."

Which amendment failed to pass by the following vote:

Affirmative—Councilmen Buehrig, Kenzel, Laughlin, McGill, McGinty, Reasner and Stratford—7.

Negative—Councilmen Adams, Bugbee, Byram, Case, Craft, Darnell, Ransdell, Reed, Schmidt, Steinhauer, Wright, Arthur L. and Wright, William G.—12.

Dr. Stratford moved to amend section 5 by increasing the pay of the patrolman from \$2.25 per day to \$2.50 per day.

Which amendment failed to pass by the following vote:

Affirmative—Councilmen Buehrig, Kenzel, Laughlin, McGill, McGinty, Reasner, Schmidt, Steinhauer and Stratford.—9.

I can further say that at the time of said accident I was perfectly sober, as I can readily prove by good and responsible citizens of this city, and that said accident was neither in whole or in part caused by any fault or neglect on my part.

I therefore ask your honorable body to have the city pay me the sum of my damage, to-wit: thirty-one dollars. I take this method of bringing the matter to your notice, rather than by suit against the city, believing this to be the better way, but in case you see fit to decide against my claim, I shall have to resort to the law, however much against my inclination.

There has been, and still is, a large pond of water at the intersection of Linden street and Lexington avenue, several feet in depth and covering, not only the street, but the major portion of two lots, and said pond can not be drained without the improvement of the said street. The health of the neighborhood has been greatly impaired by the existence of the pond, and the approach of warm weather will greatly increase the sickness should the cause remain.

Again, the street is improved north from Lexington avenue and only requires the improvement of the three squares prayed for in the petition to open it for general travel from Prospect street to English avenue.

Again, there are no streets improved running north and south from Prospect street to Lexington avenue between Olive street and the east corporation line, which fact completely cuts off the large and rapidly growing population north of Lexington

avenue from the advantages of schools and churches in muddy weather. We would also call your attention to the fact that the cross streets are all improved so that the city will be required to pay for nothing but the alley ways.

We therefore request that such action may be taken by your honorable body as will remove this nuisance, which, in our opinion, can be best done by putting in large cement pipes, so as to prevent it being filled up by caving in from time to time.
