CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, Monday, June 1st, $1876-7\frac{1}{2}$ o'clock P. M.

The Common Council met pursuant to adjournment.

The Common Council met for the purpose of taking action on ordinances on second and third reading.

INDIANAPOLIS, June 1, 1876.

To the Mayor and Common Council of the City of Indianapolis:

INDIANAPOLIS, May 31, 1876.

Honorable John Cavin, Mayor of Indianapolis:

Dear Sir:—As I expect to be out of the city for some time, I wish to say, as one property holder of Indianapolis, that it will be entirely satisfactory to me for the Common Council to order the improvement of any street or alley on which I own real estate. I believe I am the largest owner on Court street, and as I understand that street has been ordered opened, I will suggest it as one of the streets that might be improved.

I also take the liberty of enclosing you my check for one hundred dollars, to be used in any movement of citizens' for the relief of our unemployed and deserving people that may meet with your approval.

His Honor, the Mayor, read the following addrsss :

INDIANAPOLIS, June 1, 1876.

To the Common Council of the City of Indianapolis:

Gentlemen: The effect of the depressed condition of the business of the country generally, and the continued growth and prosperity of Indianapolis, has been to bring here large numbers of mechanics and laborers in search of employment, until there is now an excess, and large numbers are now without work and there is consequent want and suffering. The City Treasury is without ready funds and the

limit of debt allowed by law has been reached, and we have no system of public improvement, either planned or under way, sufficient to furnish employment to any considerable number. Some means, however, should be provided to aid our own citizens, at least those who have families, and to provide means of transportation for those temporarily here, and without means to leave.

Any system of relief, unless well guarded, would be subject to much imposition as the most unworthy would be the most clamorous, while modest want and noble pride would suffer in silence.

I recommend the appointment by this Council of a Committee of fifteen or twenty of our best citizens, prudent and humane men, commanding the confidence of all, to whom this subject of relief shall be referred, and report to this Council what is neeeded, what this Council can do, what it should do, and the plan and manner of doing it.

A few bad men are advising violence and robbery. I am glad to know that the great body, even of those who are suffering, are law abiding citizens and will be among the first to uphold law and order. All such bad counsellors are the worst enemies of those whom they pretend to befriend and bring greater distress upon those already suffering.

Law and order must be maintained and life and property protected, and those who contemplate violence must understand that they will be simply criminals on whom the severest penalties of the law will be enforced. Committing crimes themselves and inducing others who are now worthy of aid and sympathy for their misfortune, and respect for their honorable conduct, to forfeit all these and become criminals.

While it seems to be the general wish that aid as far as possible should be given to our own worthy citizens in need. It is also the unanimous demand that punishment, quick, sure and sharp, should be meted out to those who guilty of violence and disregard for the rights of person and property guaranteed by the law, and by their criminal conduct would plunge the already suffering poor into deeper distress.

Those expecting assistance must remember that whatever is given to them for labor not needed or by direct contribution must be taken from some one else, increasing the weight of taxation upon every little cottage and humble home in the city and upon those illy able to bear it. It will not be drawn from some inexhaustable source that will not feel it but from hundreds of our citizens themselves laborers and out of emloyment with an humble home not fully paid for, and to them the tax gatherer will soon come and if unable to pay, the home will be sold. And it is true that much of the suffering thus relieved will be simply transferred to others fully as deserving and but little, if any, better able to bear it.

Their troubles can not last long. We can not long sit idle and suffer, with inexhaustable resources on every side. In the midst of vast fertile plains, sufficient to feed the world, we can not long suffer for bread nor from cold, with inexhaustable mines of fuel at our doors. Let those be generous who cau. A kind deed is always "Bread cast upon the waters." Let us all be patient and hopeful, kind, and true to ourselves, true to the laws of the land, true to the honor, peace, and good name of

our beautiful city, relying upon ourselves and upon the first and cardinal principles of all prosperity, Honesty, Industry and Economy, the same kind providence that has smiled upon and blessed us for an hundred years and made us from a "little folk" has made us great among the nations, will still continue His smile and His blessing.

Gentlemen:--The undersigned owners of the real estate fronting on Indiana avenue, between West street and Fall Creek, respectfully remonstrate against the

passage of ordinances No. 42, 1876, an ordinance to provide for grading and graveling with screened river gravel Indiana avenue, to bowlder the gutters and curb with stone the outside edge of the sidewalks thereof, from West street to Fall Creek bridge; also, to flag and bowlder a double row crossing at the general street crossings between said points. No. 43, 1876, an ordinance to provide for grading and paving with brick the sidewalks of Indiana avenue from West street to Fall Creek bridge, where not already paved; also, to flag and bowlder the street and alley crossings between said named points.

There are over six thousand (6,000), feet on Indiana avenue, including about seven hundred (700), feet in cross streets and alleys, counting the two sides between West street and Fall Creek; which it is provided in said ordinances, "shall be improved by grading and graveling the street, bouldering the gutters, curbing with stone the outside edge of the sidewalks, flagging and bouldering double row crossings at the street crossings and grading and paving with brick the sidewalks;" and less than one-sixth of the entire distance is represented on the petition for the above improvements.

Your petitioners would respectfully remonstrate against such an expensive improvement at the present time, when business is so stagnant, when all are endeavoring to retrench, and when the tax-payers are demanding lower taxation.

We also state that for several hundred feet the pavement petitioned for in ordinance No. 43, would run in front of a common where there is no need whatever for any such improvement, and we respectfully remonstrate against the passage of said ordinance No. 43.

We would respectfully suggest, that if the City Street Commissioner would fill up the holes and ruts in the street with good screened gravel, the street would be greatly improved.

WHEREAS, There is a great and growing necessity for certain public improvements which can not be much longer delayed and do justice to the people, and

WHEREAS, There has been appropriated by the Council ten thousand dollars for the erection of a City Work House, and elected a Board consisting of His Honor, the Mayor, Col. B. C. Shaw, John W. Murphy and Thomas Sharpe, who have decided on a location, etc., therefore,

Resolved, That it is the sense of this Council that the erection of the Work House and the construction of a viaduct over the railroads on Virginia avenue (the plans

of which are already prepared and in the hands of the Committee on Bridges,) be pushed to completion without unnesessary delay. That we believe the course is justifiable for the reason that the work can be done at a much lower figure and the material furnished at one-third less than at any time for the past fifteen years, which will more than compensate for the interest on the money, besides giving employment to more than two hundred idle men whose families are at the point of suffering.

Resolved, That the Committee on Bridges are hereby directed to report to this Council next Monday evening in reference to the plans of a viaduct, and the Work House Commissioners are also directed to report at the same time as to what, if any thing, is being done toward the erection of the Work House.
