REGULAR SESSION.

CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, Monday, August 28th, 1876-71/2 o'clock P. M.

The Common Council met in regular session.

The proceedings of the regular session, held August 21st, 1876, were read and approved.

Sealed proposals for grading and graveling the first alley north of Christian avenue, running from College avenue to Ash street; also, for grading and graveling the west half of the first alley north of Home avenue, running east and west between Delaware and Alabama streets; also, for grading and graveling the first alley south of Prospect street, from Everson to Reed streets; also, for constructing a cement pipe, glazed earthenware, or brick sewer in and along Potomac or West Court street, running from California street to the first alley west of West street, and connecting with the sewer at said last named point; also, for grading and graveling Deloss street and sidewalks from Oregon or Nebraska street to Brooke street; also, for grading Sullivan street, between Bismark and Buchanan streets; also, for grading and paving with bowlders Oriental street, between Washington street and Michigan Road; also, for grading and graveling the first alley east of Yandes, running from Home to Lincoln avenues, were received, opened, read, and referred to the Committee on Contracts.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—I would recommend that your honorable body order a catchbasin built at the southeast corner of Orange and Shelby streets. This is necessary by reason of the early improvement of Orange street, now under contract, which, when done, will leave no outlet for the water from Shelby street, the latter street as yet unimproved.

SECOND.

I would also recommend that the Street Commissioner be instructed to construct a proper protection of cinders or stone, for the culvert on State Ditch at the crossing of Alabama street. The State Ditch having been widened and deepened, this work is important to prevent a washing out of said culvert. There are drain pipes from the Exposition grounds emptying into this ditch, which have caused a good deal of washing and caving of the north bank. I would recommend that the City Marshal be instructed to notify the proper authorities to protect the bank around their pipes with cinders or stone, so as to prevent further washing.

THIRD.

I beg leave to call the attention of your honorable body to the necessity of purchasing a new wagon for use of the City Civil Engineer. The one now in use is worn out and is a constant expense in the way of repairs. I would recommend that a new one be purchased.
