Gentlemen:—We deem it our duty to call your attention to the fact that the part of the City Cemetery, known as the "Potter's Field," is now entirely full, and bodies are being stored in vaults for want of space in which to bury them. You will no doubt recognize the immediate necessity of providing additional burying space.

We recommend that instead of buying ground elsewhere, the Council obtain by donation or purchase the title to various vacant lots in the Cemetery whose owners have removed their dead. In this manner space enough for one, or perhaps two years may be obtained, during which time ground may be secured in some other locality. We suggest that a committee be appointed

to look into this matter, and also to secure a proper plat of the entire Cemetery, so that a correct record of the burials may be kept.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen: - The State officers have subscribed in sums of ten dollars each a sufficient amount to procure a flag-staff and flag, and to pay for a State panel in this building. Barely sufficient funds have been raised to put the State exhibit in position, and to complete the house. Now that it is completed no Indianian need feel any doubt of a favorable comparison with other buildings upon the grounds, although the general standard is very high. The grounds require ornamentation, and a fountain in front will add much to its present appearance. May we not reasonably ask of your honorable body and the city officers, acting as individuals, a subscription to the amount of one hundred and fifty dollars, (\$150.00) or about \$5.00 each for this purpose, and to include a panel in the Memorial Room of the building, setting forth the organization of the city government, and presenting the names of all officers in this centennial year. Other cities will be similarly represented in connection with their panel of city statistics. The latter has been provided for by the liberality of a few members of the Real Estate Exchange for your city.

Mr. Thalman, from Committee on Streets and Alleys, submitted the following report:

Indianapolis, September 4, 1876.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—Your Committee on Streets and Alleys, to whom was referred sundry papers, respectfully report on the same, as follows:

- 1. Is a communication from Dr.Marsee in regard to filling up Lincoln avenue. We recommend that the Street Commissioner be directed to raise the gutter where too low, and clean, so the water will drain into Yandes street.
- 2. To raise the stone crossings on the corners of Pennsylvania and Ohio streets; also East and Market. We recommend they be raised to the proper grade, under the direction of the Civil Engineer.
 - 3. A petition for stone crossings corner of Ohio and Pennsylvania streets.

We recommend a stone crossing be put down from the southeast to northeast corner of Pennsylvania street across Ohio street.

- 4. An ordinance and remonstrance for grading, graveling, bowldering and curbing the gutters on Alabama street. We recommend the improvement be postponed until next May.
- 5. Is a communication from the Board of Health, calling attention to a stagnant pond in the first alley east of East street, running from McCarty street south. We find this alley in a filthy condition, and recommend that an ordinance be passed to grade and gravel it.
- 6. That the Civil Engineer contract for bowldering the gutter on Yeiser street, from Madison avenue to Kennington street. Instead of bowldering we recommend that the Street Commissioner protect the side with cinders, and repair the sidewalk where washed out.
- 7. An ordinance, petition and remonstrance, regarding the improvement of an alley between Kennington and Franklin streets, from Morris to Dunlap streets. We recommend in favor of passing the ordinance.
- 8. An ordinance and remonstrance as to improving the first alley east of Madison avenue, from Downey to Yeiser streets. It needs improving, and we recommend that the ordinance be passed.
- 9. Are ordinances Nos. 86, 91 and 92, several petitions, and a like number of remonstrances, regarding the improvement of East Market street and Highland street. We recommend that the ordinances be laid over until next spring, and that that part of the petition asking the regrading and graveling of Market street at the expense of the city be not concurred in. We, however, recommend that the Street Commissioner be directed to put Market street, from Pogues Run so far east as has been heretofore improved, in good repair—haul off the surplus dirt, and fill the low places with the gravel.
- 10. Is a motion to fill chuck-holes on New Jersey street from Washington to Merrill streets. We recommend that the Street Commissioner repair where needed.
- 11. Is an ordinance to improve with bowlders and pave with brick Wabash street, between Pennsylvania and Delaware streets. As there is no petition, and most all the property holders remonstrate, we recommend that the ordinance be stricken from the files.
- 12. Is an ordinance to improve Ramsey street from Brookside avenue to first street south. As that part of the city is still in the woods, we recommend that the ordinance be stricken from the files.

- 13. Is a petition as to the manner of improving Wabash street, between Delaware and Alabama streets. Also an ordinance to carry out the same. We recommend in favor of the improvement, and herewith return ordinance No. 108, to be placed upon its passage; and ordinance No. 106, for the same improvement, we recommend to be stricken from the files.
- 14. Is a motion that the Street Commissioner clean up the north side of East Market space, and fill in with gravel. We recommend the "cleaning up" as often as needed, but against graveling, as there is an ordinance on its passage for improving the same.
- 15. Is a motion that the Street Commissioner pave the point on southeast corner of Indiana avenue and Tennessee street. We recommend that he be directed to do that part belonging to the city, as staked out by the Civil Engineer.
- 16. Is a motion for flag-stone crossing on the north side of Market street, crossing Illinois street. We recommend that the Street Commissioner put down the same.
- 17. Is an ordinance and remonstrance regarding the improvement of Michigan street sidewalks. We recommend that the ordinance be stricken from the files.
- 18. Is an ordinance, petition and remonstrance regarding the improvement of the first alley north of North street, from Delaware to Alabama streets. We recommend in favor of petitioners, and herewith return ordinance to be placed on its passage.
- 19. Is an ordinance, petition and remonstrance regarding the improvement of the first alley east of Madison avenue, from Dunlap to Downey streets. It needs improving, and we recommend the ordinance be passed.
- 20. Is an ordinance and remonstrance regarding the improvement of the first alley south of Downey street, from Madison avenue to Kennington street. We recommend that the ordinance be placed on its passage, as the improvement is necessary.
- 21. Is an ordinance, petition and remonstrance as to improving the south-west sidewalk of Huron street, between Dillon street and Virginia avenue We recommend in favor of petitioners, and herewith return ordinance to be placed on its passage.
- 22. Is an ordinance, petition and remonstrance as to the improvement of Vermont street, between Agnes street and Mill Race. We recommend the matter be postponed until next spring.

- 23. Is an ordinance and remonstrance as to improving the first alley west of Tennessee street, from McCarty to Ray streets. We recommend that the ordinance be stricken from the files.
- 24. Is a petition to order the City Marshal to cause to be kept clear for passage the sidewalk on Virginia avenue, in front of the Vance Block. We recommend that the Marshal be so ordered.
- 25. Is a motion that the Street Commissioner be directed to protect the gutter on the south side of McCarty street, between Tennessee and Missouri streets, with Rolling Mill cinder. We recommend that the motion be concurred in.
- 26. Is a petition from the Atlantic and Pacific Telegraph Company, asking permission to erect poles for their line of wire through the city. We recommend that they be granted permission to erect said poles, on either Market or Maryland street, the poles to be shaved, and of respectable appearance.
- 27. Is an ordinance, petition and remonstrance regarding the improvement of the alley between Merrill and Grant streets, from the first alley west of West street to Acorn street. We recommend that the ordinance be placed upon its passage; the alley needs improving.
