The Common Council met in regular session.

The proceedings of the regular session, held February 26th, 1877, were read and approved.

Sealed proposals for erecting wooden bridge over Pogues Run at the crossing of Ray street were received, opened, read and referred to the Committee on Contracts.

REPORTS FROM CITY OFFICERS.

The City Civil Engineer submitted the following report :

Indianapolis, March 5, 1877.

To the Mayor and Common Council of the City of Indianapolis :

Gentlemen:—I herewith report the following estimates for work done :

A first and final estimate allowed August Verhofstad for grading and graveling the first alley east of West street, running from Merrill street to the first alley south of Merrill street—

365 lineal feet at 8 $\frac{3}{4}$ cents..... ..\$31 93

Also, a third and final estimate allowed Johnson & Christerson, for building a fire cistern at the corner of Beecher and Shelby streets—

1057.41 bbls. at 35c..... ..\$370 09

Less former payments..... .. 260 47

Final payment\$109 62

The City Attorney submitted the following report :

Indianapolis, March 5, 1877.

To the Mayor and Common Council of the City of Indianapolis :

Gentlemen :—I was directed to report what contract exists between Samuel J. Patterson and the city and the parties owning the lands adjoining Michigan street as to continuing the levee from Patterson's line to Michigan street. I would report that there is no contract between the city and the parties owning the land adjacent to Michigan street at White river to complete the levee down to White river bridge. Mr. Patterson's contract with the city was to build a levee down to his south line, and that has been done. Mr. Rockwood is the owner of the lands between Patterson's and Michigan street, and Mr. Patterson stated at the time of making his contract with the city that Rockwood would extend the levee to Michigan street, but there is no contract or stipulation to that effect in the contract of Patterson with the city.

Indianapolis, March 5, 1877.

To the Mayor and Common Council of the City of Indianapolis :

Gentlemen :—In the matter of the petition of John C. Wright, administrator of William Y. Wiley's estate, asking that certain damages awarded by the commissioners in the opening of Blackford street should be paid to him, I would report that I have examined the matter, and find that the property mentioned in the petition and also the damages referred to are claimed by one Millie Chizum. The statute under which Blackford street was opened and the damages awarded, provides in section 16 that "should such damages be claimed by different persons and the treasurer be duly notified thereof, he shall in writing certify that fact to the attorney of the city, and it shall be the duty of the attorney to file a bill of impleader in a court of general jurisdiction of the county, making parties thereto such claimants, and he shall

also pay into the hands of the county clerk the damages aforesaid, and upon the determination of the question the money shall be paid to the party entitled thereto, and the damages so far as the city is concerned shall be deemed paid from the time of their payment into the hands of the county clerk." I think that this is the only way of settling the matter, and I would recommend that the petition be referred to the city treasurer with instructions to take the proper steps to have such a bill filed.

The Street Commissioner submitted the following report :

Indianapolis, March 5, 1877.

To the Mayor and Common Council of the City of Indianapolis :

Gentlemen :—I have the honor to submit the following report of work done in my department for the month of February, 1877 :

Repaired and reset 106 foot bridges and culverts, and completed the repairs on the Virginia avenue bridge over Pogue's run.

Laid down stone walks at the following street crossings : On Virginia avenue, at the south end of street railroad tracks, and on the crossings of three alleys on South Union street; one crossing in front of Board of Trade; two crossings at the intersection of Pennsylvania and Ohio streets; four crossings at East and Walnut streets; two crossings at Massachusetts avenue and Delaware street; one crossing at Massachusetts avenue and Alabama street; one crossing at First and Illinois streets; one crossing at Illinois north side of Tinker street.

Bolwdered two alley crossings on North Mississippi street.

Repaired Illinois street at Pogue's run.

Repaired the driveways at Engine Houses Nos. 4 and 5.

Repaired the washouts and cleaned the gutters on Morris street, from West street to the river bridge.

Filled the chuck-holes with gravel on the following streets: On Prospect from Dillon to Reed streets; on Shelby street from Virginia avenue to Pleasant Run; on North from Illinois to California street; on Fifth at intersection of Illinois street; on Tinker from I. C. & L. R. R. to Meridian street, and on Madison avenue, Maple and Illinois streets.

The Board of City Commissioners made the following report:

Indianapolis, March 5, 1877.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—The undersigned respectfully show to your honorable body:

First. That they were duly appointed by Civil Circuit Court to act as Commissioners to assess damages and benefits, "accruing to the owners of lands and lots through which any street is proposed to be constructed or altered, or any building appropriated, or through which any creek or other water course is proposed to be straightened, or of which the course is proposed to be altered."

Second. That they did, as required by law, take and subscribe the oath and affirmation by law required.

Third. That they were and are duly qualified to act as such Commissioners, and do possess lawful authority to assess benefits and damages.

SECOND.

Your Commissioners do further report—

First. That on the 14th day of December, 1876, they met at City Clerk's room, pursuant to the notice hereunto annexed, marked exhibit "A."

Second. That they did, at the time and place aforesaid, enter upon the consideration of the matter of opening Dunlop street, more fully described in the petition to us referred, and hereto annexed, marked exhibit "B."

Third. That they did inquire into the matter of the service of notice upon property owners, and do herewith report said notices, with the Marshal's indorsement of service thereon.

Fourth. That the following named persons appeared in answer to said notice, viz: Arthur Mueller (for heirs), Fred. Kottkamp, Wm. Smith, Chris. Boose, J. Vandersaar, Hester J. Harrison (by A. C. Harrison), Philip Guenther, Mrs. H. Clearwater (by A. C. Harrison), Geo. Merritt.

THIRD.

The said Commissioners do further report that they did, at the time aforesaid, examine the real estate proposed to be appropriated, and did at the time and place indicated in said notice, hear evidence touching the questions before them, and did also view the premises, and that they did estimate—

First. The value of the land and property to be appropriated for said improvement.

Second. What part thereof, if any, ought to be borne by the city.

Third. What real estate, if any, would be benefitted by the improvement.

FOURTH.

Your Commissioners do further report—

First. That the value of the land to be appropriated is in the aggregate eighteen hundred dollars (\$1800).

Second. That the city should pay two hundred dollars (\$200) thereof.

That the benefits aforesaid are such as each of the persons respectively would receive. That the damages assessed are such as each of said persons to whom damages are awarded would sustain.

The persons whose benefits exceed damages, and the amounts of the excess, are shown in table "A," and those whose damages exceed benefits are shown in table "B," showing in the one table the benefits in excess of the damages, and in the other the excess of the damages over and above the benefits.

Your Commissioners do therefore recommend that the said Dunlop street be opened as prayed, and that the damages and benefits assessed be paid and collected according to law.

I feel that such action is due to me, and I therefore ask your honorable body to take action in the matter at once.

Gentlemen :—I make and present the following charges of misconduct and drunkenness against Austin C. Dewey, Chief of the police force, and respectfully ask that the trial and hearing thereof be fixed for an early day.

I charge Austin C. Dewey, Chief of the Police of the city of Indianapolis, while on duty and in uniform as such officer in said city, with drunkenness, drinking intoxicating liquors, disorderly conduct, and with conduct unbecoming an officer and a gentleman, in this, to-wit :

SPECIFICATION 1. That on or about the 8th day of January, 1877, at the city of Indianapolis, county of Marion and State of Indiana, said Austin C. Dewey, being then and there Chief of the Police of said city, and being then and there in uniform and on duty as such chief officer of said police force, was drunken and intoxicated, and thereby incapacitated for the discharge of his duties, contrary to the laws of said city and the rules governing said police force.

And I further charge said Austin C. Dewey, Chief of the Police of the city of Indianapolis, with drunkenness and conduct unbecoming an officer and a gentleman, in this, to wit :

SPECIFICATION 1. That on or about the 14th day of February, 1877, at the city of Indianapolis, county of Marion and State of Indiana, said Austin C. Dewey, being then and there Chief of the Police of said city, and being then and there on duty and in uniform as such officer, was drunk and intoxicated, and thereby unfit for duty, contrary to the ordinances of said city and the rules and regulations governing said police force.

SPECIFICATION 2. That on or about the 14th day of February, 1877, at the city of Indianapolis, county of Marion, and State of Indiana, said Austin C. Dewey, being then and there chief of the police force of said city, and being then and there on duty and in uniform as such officer, visited a house of prostitution kept by one Maggie Richmond in said city, for the purpose of having illicit or unlawful intercourse or connection with one of the women thereof, and that said Dewey, as such officer, and while on duty as aforesaid, then and there did have unlawful intercourse or carnal knowledge of one of the women thereof, whose name is unknown to informant. And that said Dewey did not visit said house of prostitution in the discharge of his official duties, all of which conduct was contrary to the ordinances of said city and the rules governing said police force.

SPECIFICATION 3. That on or about the 14th day of January, 1877, at the city of Indianapolis, county of Marion and State of Indiana, said Austin C. Dewey being then and there in uniform and on duty as Chief of the Police force, and at the head of a procession of the police, who were attending or proceeding to the funeral of a deceased comrade, lifted his hat and saluted publicly and spoke to one Hattie Anderson, a notorious prostitute of said city, in the presence of numerous and divers citizens of said city, which conduct was unbecoming an officer in the presence of his men, and against the rules and regulations governing said police force.

SPECIFICATION 4. That afterwards, to-wit, on or about the 14th day of January, 1877, said Austin C. Dewey, being then and there Chief of the police force of said city, and being then and there on duty and in uniform as such officer, took one Hattie Anderson, a notorious prostitute and strumpet, out riding in a buggy along the streets of said city, and in public highways and places, and conducted himself in a scandalous manner, all of which was improper, scandalous conduct, unbecoming an officer and gentleman, and contrary to the ordinances of said city, and the rules and regulations of said police force.

And I further charge said Austin C. Dewey, Chief of the police force of said city of Indianapolis, with incompetency and inefficiency as such chief officer, and with neglect of duties pertaining to his said office, in this, to-wit:

SPECIFICATION 1. That houses of prostitution in said city of Indianapolis are not suppressed, that the gambling houses of said city are

not closed up, and that all attempts in that direction by the said chief have been weak or abortive, and he frequently violates the ordinances of said city himself.

SPECIFICATION 2. That said Dewey, while chief of said force and acting as such, has never issued or promulgated any general orders of value to the men pertaining to the discharge of their duties.

SPECIFICATION 3. That said Dewey is wholly incompetent and unfit for the duties of his said office.

And I further charge said Austin C. Dewey, Chief of the Police of said city, while on duty as such officer, and in his uniform, with frequenting and visiting houses of prostitution in the city of Indianapolis, not in the discharge of official duties, but for the purposes of drinking intoxicating liquors and having illicit intercourse with inmates thereof, contrary to the ordinances of said city of Indianapolis and the rules governing the police force.

To the Mayor and Common Council of the City of Indianapolis :

Gentlemen :—The undersigned, residents of the city, whose homes are in the neighborhood of the building known as the Home of the Friendless, controlled by a charitable corporation organized for the protection and reform of friendless women, beg to state that they are informed that it is the design of said corporation to ask your honorable body to use said building, under its present management, as a prison for the confinement of female culprits who have been sentenced for violation of city ordinances.

That this building has been heretofore used to some extent for the same purpose, and has proved to these petitioners an indescribable nuisance, which has rendered residence in its neighborhood intolerable.

The prisoners are necessarily of the lowest class, who by the vulgarity, profanity and indecency of their speech, and the shameless exposure of their persons, call around the building gangs of brutal men and women, who render the streets in the neighborhood as offensive as the prison, and who render their use by the public, and especially by women and children, dangerous and in every way disgraceful.

The management of the building is in the hands of females, who are utterly unable to control the wretched prisoners whom it is proposed to commit to their care.

The object of the corporation is defeated by any such use of their house, as it is in vain to expect decent women to accept a refuge in such a place, and equally vain to hope for the reformation of the fallen who are to be surrounded by such shameful influences.

The petitioners have their homes surrounding this place, which is directly upon one of the most frequented streets of Indianapolis, and but little removed from the dwellings of many decent tax payers of the city; and these for the pretext of eking out a support for this charity by turning it into a female prison are to have their wives and their children, and their friends and visitors exposed to the infamies which are to be thus foisted upon them in the name of charity and reform.

We earnestly protest against any such outrage.

Indianapolis, March 5, 1877.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—Your committee to whom was referred the petition of John T. Dickson and others, asking that a lamp post be erected on Chesapeake alley, in front of the school house of St. Mary's church, would respectfully report as follows:

We find it practicable to remove one lamp post from the east end of Washington street bridge over White river, and would recommend that said post be removed to the point indicated in the petition above referred to, provided that the expense of removing said post and making the necessary connections be paid by the petitioners.

2. In regard to the petitions of Weitzel & Marples, agents for the DePalos "Pressure Moderator and Gas Saver," and J. Knight, agent for "Stacey's Automatic Regulating Gas Burner," we would report as follows:

That we have had one of Weitzel & Marples' Pressure Moderators in use at the City Hall since the 20th day of January, 1877, with the following results: amount of gas consumed during December, 1876, without Moderator attached, 20,000 feet; amount consumed during month of January, 1877, with Moderator attached ten (10) days, 16,500 feet; amount consumed during month of February, 1877, with Moderator attached, 9,800 feet. The week commencing January 13, shows a consumption of 4,600 feet without the Moderator, and the week following, with the same quantity of gaslights, shows a consumption of 2,300 feet with the Moderator attached, showing a saving of fifty per cent. of gas consumed in the same length of time.

3. The following is a correct statement of gas consumed at the Station House during the same months, with and without "Stacey's Automatic Gas Burner" attached: Number of feet consumed during month of December, 1876, without the Stacey Burner attached, 2,300 feet; number of feet consumed during month of January, 1877, with Stacey's Burner attached twenty days, 2,640 feet; thus showing a consumption of 340 feet more gas in the

same time with the Stacey Burner attached two-thirds of the month; number of feet consumed during the month of February, 1877, with the Stacey Burner attached, 1,790 feet. Therefore we would report in favor of the De Palos Pressure Moderator and Gas Saver, it being, in our judgment, the best method of saving gas, and would recommend the purchase of a few for the use of the city where the largest quantity of gas is consumed by meter measurement.

4. We also present the report of Prof. R. T. Brown as to the quality of gas furnished from January 17th to February 22d, giving the candle-power of fourteen observations:

To the Mayor and Common Council of the City of Indianapolis :

Gentlemen :—Your Committee on Parks, to whom was referred a communication from Messrs. Boyce & Dunlap, asking for a lease of the Southern Park for a term of three years, respectfully report that the park grounds, build-

ings and track are in a very dilapidated condition, and as the city will not have much money to expend on parks for some time to come, we would recommend that the parties be granted a lease of said track and buildings for a term of three years, they binding themselves to permit all other parties to use the track, on paying a reasonable fee. In consideration of such lease they are to repair and protect the banks of the creek where washed out, put in new and substantial bridges over the creek, fix up the gates, fences, buildings and amphitheater, and keep the same in good order until the end of such lease, when the same is, in like good order, to be turned over to the city. Such repairs to be made under the direction and to the satisfaction of the Park Commissioner and Civil Engineer. The said parties to file a bond, to be approved by the Council, for the faithful performance of said contract, also to bind themselves to keep all immoral characters off the grounds, and suffer no animals, such as cattle, sheep, swine, horses or mules, to run at large in said park, nor suffer any trees to be cut down or destroyed. The grounds to be at all times open and free to all, except on days when races are given, for which admission is charged at the gates, at which times they are to have entire control. We also recommend that the City Attorney, Park Commissioner and Committee on Parks be authorized to draw up and sign a contract with the parties to the effect of this report.
