To the Mayor, Common Council and Board of Aldermen:

Gentlemen:—I herewith report a first and final estimate for re-grading and improving with broken stone, the roadway of Washington street, from the old Donation Line to State street, authorized by Special Ordinance No 45, 1890, based upon the terms of the contract with Fulmer, Cooper & Co., contractors for said work, approved by the Common Council the 10th day of November, 1890, and by the Board of Aldermen the 10th day of November, 1890.

The Board of City Commissioners submitted their report in the matter of building the levee along the south bank of Fall Creek, accompanied with the following resolution:

Resolved by the Common Council and Board of Aldermen of the City of Indianapolis, Ind., That the first and final estimate of the City Civil Engineer, for grading, widening and repairing the levee on the south bank of Fall Creek, authorized by General Ordinance No. 3, 1890, and exhibit "A," being a list of lands and lots inside the City of Indianapolis, benefited by the strengthening, repairing and maintaining of the said levee, as provided for by said ordinance; and exhibit "B," being a list of lands and lots outside of the City of Indianapolis, benefited by the strengthening, repairing and maintaining of the said levee, as provided for by said ordinance; and all of the descriptions and amounts of benefits assessed against the lands and lots respectively, on each and every sheet comprising said exhibits "A" and "B," as therein and thereon fully shown, made by the Board of City Commissioners of the City of Indianapolis, Indiana; and the report of said Board, therein and thereon made as therein shown, all pertaining to the grading, widening and repairing of the levee on the south bank of Fall Creek, from a point two hundred (200) feet east of Central avenue to Tennessee street, as authorized by General Ordinance No. 3, 1890, be, and the same are each and all, in all respects, hereby confirmed, ratified and approved; and all of said lists so made by the City Clerk, and all of said assessments thereon made, as fixed by said Board of City Commissioners, are also hereby confirmed, ratified and approved, and the same are hereby declared a lien severally to the extent shown in each of said exhibits, upon the lands and lots therein shown respectively and severally; and the said report of the Board of City Commissioners is hereby in all things ratified and approved.

That the City Clerk be, and he is hereby, instructed to deliver said assessment rolls, marked respectively exhibits "A" and "B," to the Auditor of Marion county, Indiana, and that said Auditor be, and he is hereby, directed to place all said assessments upon a separate tax duplicate, and to deliver said duplicate to the County Treasurer of Marion county, Indiana, who is hereby ordered and directed to collect the same by law, all in one installment, as other taxes are collected, for the use and benefit of the contractors for said work, and to pay the

same, when so collected, to said contractors or their assigns.

To the Mayor, Common Council and Board of Aldermen of the City of Indianapolis:

Gentlemen:—The undersigned members, being all of the members of the Board of City Commissioners of the City of Indianapolis, Ind., and being duly appointed, qualified, and acting as such Board of City Commissioners in and for said city, under the provisions of the Statues of the State of Indiana, in relation to the vacation of streets and alleys, etc., beg leave to report:

1. That we met in the office of the City Clerk on Thursday, October 9, 1890, to consider the matter contained in the petition of Edward Hawkins et al., to vacate the first alley south of Seventh street, from Broadway to the first alley west of Broadway; all in accordance with the notice of the City Clerk, which said notice, with the proper return of the Superintendent of the Metropolitan Police Force endorsed thereon, is in words and figures as follows, to-wit:

2. After examining said petition and the accompanying plat—all of which we found correct—we proceeded to view the ground and surrounding locality, and directed the Secretary to prepare a notice to the Clerk to have the proper officer notify the persons named in said notice to meet the Commissioners on Friday, De-

cember 5, 1890, for the further consideration of the case; all in accordance with said notice, which is in words and figures following, to-wit:

That on Friday, December 5th, 1890, the Commissioners met, all present except I. N. Walker, pursuant to notice and adjournment, and proceeded to hear evidence from parties interested.

At the conclusion of the morning session, the Board adjourned until 2 o'clock, r.

M., for the further consideration of the case.

The Board then adjourned until Monday, December 8th, 1890, at which time, all the members being present except I. N. Walker, and found the following facts:

First-That the proposed vacation includes that part of the first alley south of Seventh street lying west of Broadway.

Councilman Stechhan presented the following petition; which was received:

To the Mayor, Common Council and Board of Aldermen of the City of Indianapolis:

Gentlemen:—The undersigned citizens respectfully petition your honorable bodies to provide for and have a viaduct built on Virginia avenue and Alabama street, with proper approaches, to the full width of the streets; said approaches leading to the viaduct to be built with curb or retaining walls and earth filling between said curbs, and with sidewalks attached. A map or plat of the streets, showing the surrounding locality, is hereby filed, and made a part hereof.

In connection herewith, we call your attention to a petition to your honorable bodies of many citizens and members of the South Side Viaduct Association, filed April 6th, 1885, and your instructions to the Committee on Railroads, to confer with a citizens' committee, consisting of Messrs. John Caven, J. W. Hill, Hiram Seibert, Lorenz Schmidt, August M. Kuhn and Wm. H. English, in relation to the erection of a viaduct on said Virginia avenue and on Alabama street, and as to an arrangement to be affected with the Cincinnati, Indianapolis, St. Louis & Chicago

Railroad Co. (Big-Four) in regard to the abandonment of Louisiana street from the west line of Alabama street to some point east of Dillon street. Also, to a similar petition of Messrs. Wm. Stolte, Hiram Sibert, Peter Spitzfaden, Henry Stolte, O. R. Olsen and Francis M. Churchman, to your honorable bodies, filed May 24th, 1886, (see Council Proceedings of 1886, at page 428,) in which is also prayed for a viaduct on Virginia avenue and Alabama street jointly.

side of Pogue's Run," insert the words "and Alabama street"

In the last clause reterring to G. O. No. 36, 1886, after the words "Whereas, said viaduct has not been erected, and it is now deemed advisable that a viaduct be erected on Virginia avenue, between Maryland and Louisiana streets," insert the words "and on Alabama street, between Maryland and South streets." Also, in the same clause (in the second line,) after the words "at its own expense and costs, such Virginia avenue," and before the word "viaduct," insert the words "and Alabama street."

In Section one (of the said new ordinance,) in clause "first," in the line after the words "a double truss viaduct and approaches on Virginia avenue, between Maryland and Louisiana streets," and before the words "over and across the railroad tracks," insert the words "and Alabama street, between Maryland and South streets."

In clause "third," after the words "on or before the completion of said" strike out the words "Virginia avenue."

Strike out all of clause "seventh."

In clause "tenth," after the words "when said committee for the adoption of plans and specifications for said Virginia avenue," and before the word "viaduct," insert the words "and Alabama street." .

On motion by Councilman Yontz, the amendment was laid on the table.

That the Central Union Telephone Company be, and are hereby, ordered to move the telephone pole from where it is now located on Arch street, between Broadway street and Park avenue, to the corner of Arch street and the first alley between Broadway street and Park avenue.

Councilman Woollen moved that when the Common Council adjourns, it adjourn to meet Friday evening, December 26th, 1890, at 7:30 o'clock.

Which was adopted.
