REGULAR SESSION.

CHAMBER OF THE COMMON COUNCIL, Monday, September 17th, 1877—7½ o'clock P. M.

The Common Council of the City of Indianapolis met in regular session.

Absent — Councilmen Case, Morse, Pouder, Sindlinger, and Tucker—5.

The proceedings of the regular session, held September 3d, 1877, having been printed, and placed on the desks of the Councilmen, the reading of the same was dispensed with.

COMMUNICATIONS FROM THE MAYOR.

His Honor, the Mayor, submitted the following report and executed contract; and, on motion, the report was received, and said contract duly concurred in:

Indianapolis, September 17, 1877.

To the Common Council and Board of Aldermen of the City of Indianapolis:

Gentlemen:—I would respectfully report that a contract, in duplicate, of date July 18th, 1877, for the keeping of our female prisoners, was duly signed by Mother Mary of St. Anselm Wells, President, on behalf of the Good Shepherd Society, and by myself, on behalf of the city, one of which duplicates is filed herewith.

THIS AGREEMENT, made this eighteenth day of July, 1877, by and between the City of Indianapolis and The Good Shepherd Society of said city,

Witnesseth, That the said The Good Shepherd Society hereby covenants and agrees with the said City of Indianapolis, for and during the term of one year from the date hereof, to keep and confine, in the building known as the "House of the Good Shepherd," any and all female prisoners that may be sentenced or committed to such confinement by the Mayor of the City of Indianapolis.

And she further agrees, That during the full term of sentence or commitment of any and all such prisoners, she will keep each and every one of them safely confined in said building, and not allow them to escape or be released until the expiration of their term of sentence or commitment, and only discharge them upon the expiration of the term of sentence or commitment, or upon the order of the proper authorities of said city; that she will also furnish to all such female prisoners, during the term of their imprisonment, good, wholesome food, and the necessary light and heat for the apartments occupied by them.

The said The Good Shepherd Society shall have the right to require such manual labor from said prisoners, and to use such necessary force and means to compel the enforcement of such manual labor, as she may deem right and proper.

In consideration thereof, The City of Indianapolis hereby agrees to pay to the said The Good Shepherd Society, for the keeping of the said female prisoners as aforesaid, at the rate of one dollar and fifty cents per week for the actual time each prisoner shall be so kept by the said The Good Shepherd Society; which amount shall be paid by the city, in monthly installments, at the end of each and every month.

In Witness Whereof, The parties hereto have hereunto signed their corporate names, by their proper officers, and affixed their corporate seals, the day and year first above written.

Benj. C. Wright, City Clerk:

Dear Sir:—I am in receipt of a motion, passed by the City Council, through the City Marshal, directing the "Water-Works Company to raise, fill, and bowlder two trenches running across the street in Pennsylvania street, between North and St. Clair streets, where the company put pipes down last season."

I answer: I will say this company has not put down or laid any pipe on Pennsylvania street, between North and St. Clair streets, since the year 1870; that our pipes do not run across the street, except where a fire-plug is connected; that the entire street has been bowldered since our pipe was laid, and that the street is now, and has been for years, in good condition over the line of our pipe.

I suppose the motion, above, refers to ditches made by plumbers, who obtain permits from the City Clerk to open streets, and for the condition of which this company is in no way responsible.

The City Attorney submitted the following report; which was received:

Indianapolis, September 17, 1877.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—At the last meeting of the Council, I was instructed to prepare and report an ordinance, repealing the present one upon the subject of Concert Saloons, and providing a license for such places.

I, therefore, herewith report an ordinance that I have prepared upon that subject.

General ordinance No. 38, 1877, was then read the first time, for information, and, on motion of Councilman Reed, the City Clerk was instructed to print same, in extenso, in the Proceedings of the Common Council, and the ordinance was made the special order for next regular session of said body:

G. O. 38, 1877—An ordinance repealing section two of an ordinance entitled, "An ordinance to prohibit the exhibition of Animals, Deformed Persons, or Monstrosities, within buildings, or on grounds fronting on certain streets; and also to prohibit certain Exhibitions in any room or building wherein

intoxicating liquors are sold" (ordained March 14th, 1864); and also providing for the licensing of Concert Saloons, and the regulation of the same.

- SECTION 1. Be it ordained by the Common Council and Board of Aldermen of the City of Indianapolis, That section two of the above named ordinance, ordained March 14, 1864, be, and the same is hereby, repealed.
- Sec. 2. It shall be unlawful for any person to exhibit any concert, or dancing or theatrical performance, in any room, or place or building, wherein intoxicating liquors are sold, or in any place or room or building where intoxicating liquors are kept or offered for sale, unless such person shall have a license therefor, as in this ordinance provided.
- SEC. 3. Any person desiring to obtain a license to carry on a concert saloon, or to exhibit any concert, or dancing or theatrical performance, in any place, room, or building, wherein intoxicating liquors are sold, or where intoxicating liquors are kept or offered for sale, shall pay to the City Treasurer the sum of one hundred dollars; and, upon the presentation to the City Clerk of the receipt of the City Treasurer for such sum, it shall be the duty of the City Clerk to issue to such person such license.
- SEC. 4. All such licenses shall run for the period of one year, and shall be signed by the City Clerk, and sealed with the seal of the city, and shall state the name or names of the party or parties applying therefor, with the purpose for which the same is issued, and that the same shall be forfeited upon a violation of any of the provisions of this ordinance; and shall describe the premises where the same may be exercised, by street and number. Each license shall be numbered, and it shall be the duty of the City Clerk to keep a record of all such licenses so issued, with the number thereof, and name of the person to whom issued, and date of the same. The City Clerk shall be entitled to a fee of one dollar for each license so issued, to be paid by the the person applying for the same.
- SEC. 5. Licenses issued under the provisions of this ordinance shall not be assignable by the holder thereof, and shall not be transferable; and any sale or leasing of the premises or business by the person to whom such license is issued shall immediately work a forfeiture of the same. Such license shall only authorize the person to whom the same is issued to act under it, and only upon the premises described in such license.
- SEC. 6. Any license issued under the provisions of this ordinance shall be at once forfeited, whenever the person to whom the same is issued, or any person in his employ, or who shall be engaged for him in assisting in carrying on the business under such license, shall have been convicted, before the Mayor, of a violation of any of the penal ordinances of said city.
- SEC. 7. It shall be unlawful for any person engaged in exhibiting any concert, or dancing or theatrical performance, in any room or place or build-

ing where intoxicating liquors are sold, or where intoxicating liquors are kept or offered for sale, to allow or permit any prostitute, lewd woman, or any women having the reputation of being prostitutes or lewd women, to congregate at, or attend any such concert, or dancing or theatrical performance.

- Sec. 8. Any person violating any of the provisions of this ordinance shall, upon conviction thereof before the Mayor, be fined in any sum not exceeding fifty dollars.

The Committee on Finance and City Assessor, through Councilman A. L. Wright, submitted the following report; which was read by clauses, and duly concurred in:

To the Mayor and Common Council of the City of Indianapolis :

Gentlemen:—Your Committee on Finance and City Assessor, to whom were referred sundry papers, respectfully report thereon, as follows:

1st. Is a petition from Riley & McClelland, asking that the taxes for 1876, assessed to and paid by them on \$1500 mill machinery, as personal property, be refunded.

We have examined the Assessor's books, and find that said machinery was assessed, also, as improvement on the real estate, and has been paid. We, therefore, recommend that the prayer of the petitioners be granted.

2d and 3d. Are petitions from sundry persons, asking that certain taxes, paid by them, be refunded under the Widows' Exemption Law.

We have examined the same, and recommend that the following be refunded:

Mary Franks, \$7.00—taxes of 1876, on \$500. Rachel Fetchner, \$7.00—taxes of 1876, on \$500.

4th. Is a petition from Stough & Hugo, asking that they be relieved from payment of taxes on \$1400 personal property, and claiming that there is an error in their personal assessment for 1876, to that amount.

We have examined their assessment list for 1876, which appears to have been regularly made out and sworn to, and we do not see how such a mistake as they claim was made, could have been readily made, and recommend that the prayer of the petitioners be not granted.

Illinois street tunnel for the sum of \$550 per year, have given the matter our consideration, and respectfully report against taking favorable action upon the recommendation from the Board of Aldermen.

Your committee recommend that the Council adhere to its former action,

in ordering the tunnel closed at night and instructing the City Civil Engineer to advertise for proposals for furnishing gates to close said tunnel.

Indianapolis, September 17, 1877.

To the Mayor and Common Council:

Gentlemen:—Your Committee on Printing, etc., to whom was referred the motion to ascertain the probable cost of preparing an index for the Council Proceedings of the past year, beg leave to report the following:

Index of 1867-68 consisted of 54 pages; for which \$175 were paid—an average of \$3.25 per page.

Index of 1868-69 consisted of 26 pages; for which \$100 were paid—an average of \$3.85 per page.

Index of 1869-70 consisted of 44 pages; for which \$100 were paid—an average of \$2.27 per page.

Index of 1870-71 consisted of 42 pages; for which \$100 were paid—an average of \$2.38 per page.

Index and Digest of 1871-72 consisted of 148 pages; for which George H. Fleming was paid \$222—an average of \$1;50 per page.

Index of 1872-73 consisted of 62 pages; for which \$100 were paid—an average of \$1.61 per page.

Index and Digest of 1873-74 consisted of 166 pages; for which Charles F. Fant was paid \$338.87—an average of \$2.04 per page.

Index of 1874-75 consisted of 40 pages; for which Charles P. Fant was paid \$100—an average of \$2.50 per page.

Index of 1875-76 consisted of 46 pages; for which \$70 was paid—an average of \$1.50 per page.

Your committee would beg leave to report that Mr. Fleming, of the City Clerk's office, is willing to prepare said index at the rate of \$1.50 per page, and that the contract therefor be awarded Mr. Fleming. This would make the cost of the index about \$200.

Gentlemen:—Your committee would respectfully report, as follows, upon the motions referred to them:

lst. Is a motion, granting permission to the Columbus Paving Company to lay a quantity of their pavement at any place the property owners may see proper to pay for the same.

We would recommend permission be granted, provided the work is done under the supervision of the City Civil Engineer and the Committee on Streets and Alleys.

2d and 3d. Are motions, instructing the Street Commissioner to notify property owners to remove obstructions from sidewalk on California street, between Washington and Maryland street, and ordering the Street Commissioner to clean out and fill (where needed) the south gutter of Washington street, between California street and the canal.

We recommend the passage of both motions.

The special committee on the matter of the Southside Market, through Councilman Steinhauer, submitted the following report; which was concurred in:

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—The undersigned, a special committee to whom was referred sundry petitions and papers relative to a "Southside Market," have given the same due consideration, and would report as follows:

That a "Southside Market" would be a great convenience to those citizens residing south of the railroad tracks, and, in our opinion, is greatly needed; but your committee have been unable to find a location that they feel justified in recommending to your honorable body, for the reason that all suitable grounds which we have been called on to examine are held at prices that

would not justify the Council, in its present limited financial condition, to purchase.

The special committee appointed "to secure additional grounds for the burial of the dead, when the same is done at the expense of the city," through Councilman Byram, submitted the following report; which was concurred in:

Councilman Brown offered the following motion; which was adopted:

Moved, That the Street Commissioner be, and is hereby, instructed to fill the pond on Spruce street, near Woodlawn avenue; and that the City Civil Engineer be instructed to set the proper grade stakes for said street.

The same gentleman offered the following motion; which was referred to the Committee on Sewers:

Moved, That the City Civil Engineer be, and is hereby, instructed to advertise for bids to construct a two-foot brick sewer, from the Station House west, on Pearl street, to connect with the Virginia avenue sewer.

Afterward, Councilman Layman, who had voted in favor of the above reference, moved to reconsider the vote referring same; which was done by the following vote:

The preceding motion was then adopted.

Moved, That the Street Commissioner be, and is hereby, instructed to repair the wooden bridge at the crossing of Pogue's Run, at Brookside avenue.

Said bridge is in an almost impassable condition, and should be attended to at once.

Councilman Cochran offered the following motion; which was referred to the Committee on Streets and Alleys:

Moved, That the Street Commissioner be, and is hereby, directed to repair the crossing, at the junction of Second and Pennsylvania streets.

Councilman Izor offered the following motion; which was adopted:

Moved, That C. E. Geisendorff & Co. have permission to pave, with brick and bowlders, the sidewalk in front of their factory on West Washington street; said work to be done at their own expense, and within thirty days, and under the direction of the City Civil Engineer.

Councilman Marsee offered the following motions; which were adopted:

Moved, That Nathaniel H. Bledsoe be granted a license as auctioneer, at 94 and 96 E. Washington street, for a period of three months, and that the City Clerk be instructed to issue the same, upon the payment of the fees prescribed by the ordinance.

Moved, That the Committee on Revision of Ordinances and City Attorney be instructed to prepare, and report, an ordinance amending the Market ordinance upon the subject of the fees of the Market Master.

Councilman McGinty offered the following motions; which were adopted:

Moved, That the City Civil Engineer be, and is hereby, instructed to make a survey of Wisconsin street, between Meridian and Mississippi streets, and as much of the property adjacent thereto, as will determine the proper description of property for purposes of assessment for street improvements.

Moved, That John Greene be, and is hereby, granted thirty days extension of time, in which to complete his contract on Maryland street, from Helen street, west, to White River.

The same gentleman offered the following petition; which was referred to the Committee on Streets and Alleys:

Indianapolis, September 10, 1877.

To the Mayor and Common Council:

Gentlemen:—We respectfully call your attention to the fact that when Braden's Block, on South Illinois street, was built, some three years ago, the

sand and dirt from the cellar was dumped in the alley of square 74, contrary to law; and it remains there to this day, obstructing the drainage of adjacent lots, and is otherwise a nuisance.

We beg you will order the same removed, and our alley restored to its proper grade and former good condition.

And your petitioners will ever pray, etc.

Moved, That the Street Commissioner be, and is hereby, directed to clean the street and gutters on South street, between Delaware and Pennsylvania streets.

Moved, That, in view of the fact that the question of the contract with the Gas Company has been, by the Board of Aldermen, referred to a committee of that body, and that the contract with the Water-Works Company is, in point of fact, a similar contract, a committee of five be appointed from this body, to confer with the Gas and Water-Works Companies, in relation to their contracts with the city, with a view to effecting a compromise with said companies.

On Councilman Dill's motion, the preceding motion was laid on the table by the following "ayes and noes":

Councilman Steinhauer presented the following remonstrance; which was referred to the Committee on Streets and Alleys:

Indianapolis, September 10, 1877.

To the Honorable City Council:

Gentlemen:—The undersigned, owners of property on first alley east of East street, running from Merrill to Valley street, respectfully remonstrate against the passage of an ordinance for the grading and graveling of said alley, now pending before your honorable body.

The undersigned did not petition for the improvement, nor had they any knowledge that such a proposal would be presented to your honorable body.

The undersigned regard the improvement as unnecessary; and it would be a hardship for them to pay for the improvement, in the present depressed condition of financial affairs.

Moved, That the Judiciary Committee and City Clerk be instructed to investigate and report what, if any, license Isaac Cohen now holds from the city, as auctioneer; and what, if any, steps are necessary for this Council to take to annul the same.

Moved, That the Street Commissioner he, and he is hereby, instructed to change the grade of the gutter on the east side of Pennsylvania street, between Washington and Market streets, so as to give better drainage.

Hahn, have permission to make a stone-crossing on Washington street, between Meridian and Illinois streets, at their own expense, and under the direction of the City Civil Engineer; the work to be completed within thirty days.

The same gentleman offered the following motion; which was referred to the Committee on Streets and Alleys:

Moved, That the Street Commissioner be directed to cover Delaware street, from Washington to Market street, with rolling-mill cinders.

Councilman Watts offered the following motion; which was referred to the Committee on Streets and Alleys, with power to act:

Moved, That the Street Commissioner be instructed to repair, at once, several chuck-holes west of Fall Creek bridge, on Indiana avenue, along the line of Schurman's farm, as, in its present condition, it is almost impassable.

Councilman A. L. Wright offered the following motion; which was adopted:

Moved, That the Street Commissioner be, and he is hereby, instructed to clean the gutter on north side of Massachusetts avenue, between Delaware and Alabama streets.

Councilman W. G. Wright offered the following resolution:

Resolved, That the City Marshal be, and is hereby, instructed to notify the property owners on the north side of Huron street, between Pine and Cedar streets, to repair the sidewalk where it has caved in; and if said repairs are not made within ten days, then the Street Commissioner to do said work, and collect the cost of the same from said property owners.
