GENERAL ORDINANCE NO. 42, 1958

AN ORDINANCE establishing certain passenger and/or loading zones in the City of Indianapolis, pursuant to the provisions of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as Amended, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That for the purpose of providing the owner or occupants of certain premises fronting on certain public streets in the City of Indianapolis, with ingress and egress for passengers, materials and merchandise coming to or going from such premises, such owners or occupants having complied with the provisions of Section 26 of General Ordinance No. 96, 1928, as Amended, and the Board of Public Safety, after due investigation, having recommended the esstablishment of the same, the following passenger and/or loading zone be, and the same is, hereby established in the City of Indianapolis, to-wit:

No. 93 C. E. Griener Company, 206-08-10 E. Maryland _____25 feet

Section 2. That said loading zone is hereby declared to be subject to all existing traffic and parking regulations, and to any later ordinances and regulations as may be applicable.

Section 3. This Ordinance shall be in full force and effect, from and after its passage, approval by the Mayor, and compliance with all laws pertaining thereto.

GENERAL ORDINANCE NO. 43, 1958

AN ORDINANCE recognizing the 500 Festival and authorizing street concessions and booths for the festival period in certain public streets of the City.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. The Indianapolis 500 Mile Race has long been an institution in the City of Indianapolis and the City and all civic leaders and merchants desire to create a carnival and festive atmosphere in this city immediately prior to the said 500 Mile Race.

Section 2. Accordingly, notwithstanding the provisions of any other ordinance, there shal be authorized and permitted the erection of booths, stands, and concessions for a period not exceeding forty-eight hours prior to the day of the race in an area of the City of Indianapolis, bounded as follows:

On the North by Sixteenth Street; on the East by Delaware Street; on the West by Illinois Street; and on the South by Maryland Street.

Concessionaires shal be designated by the Board of Public Works with the assistance and recommendations of the "500" Festival

Associates, Inc. Persons so nominated by the Board of Public Works shall have the exclusive right to sell any merchandise authorized in a list approved by said Board of Public Works. Streamer badges shall be provided and shall designate such concessionaires and all prices shall be listed and posted in accordance with a schedule to be approved by said Board of Public Works upon the recommendation of the Festival Committee.

Section 3. This Ordinance shall be effective only within the fortyeight hour period immediately preceding the running of the 500 Mile Race.

Section 4. The purpose of this Ordinance is to encourage the raising of funds by civic committees, without cost to the taxpayers, to encourage and create activity in the downtown area of the City of Indianapolis, just ahead of said Race.

Section 5. Any persons conducting concessions violating provisions of this Ordinance by charging prices in excess of the approved prices, or selling unauthorized merchandise, or conducting business without wearing the streamer badges provided for in this Ordinance, shall be deemed in violation thereof, and upon conviction shall be fined in any sum not to exceed Twenty-Five Dollars (\$25.00).

Section 6. This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication as by law provided.

All of lots numbered 167, 168, and part or lots numbered 170, 171, 178, 179, 180, and also part of vacated alley adjacent to said lots as recorded in Heywoods Second Park Addition; plat book 11, page 131, Marion County Recording Office, and more particularly described as follows:
