CHAMBER OF THE COMMON COUNCIL, Monday, December 3d, 1877-7 o'clock P. M.

The Common Council of the City of Indianapolis met in regular session.

The proceedings of the regular session, held November 19th, 1877, having been printed, and placed on the desks of the Councilmen, the reading of the same was dispensed with.

Sealed proposals for paving with brick the sidewalks of Fletcher avenue, between Dillon and Linden streets, were received, opened, read, and referred to the Committee on Contracts.

REPORT FROM COMMITTEE ON CONTRACTS.

The Committee on Contracts submitted the following report; which was concurred in, and the several contracts duly awarded, as recommended:

To the Mayor and Common Council:

Indianapolis, December 3, 1877.

Gentlemen:—Your Committee on Contracts, to whom were referred sundry proposals, presented to Council November 19th, 1877, have examined the same, and find them to be as follows, to-wit:

1st. For grading, and paving with brick, the east sidewalk of Park avenue (where not already paved), between Cherry and Vine streets—

James W. Hudson, 34 cents per lineal foot front. James Mahoney, 30 cents per lineal foot front.

William Morrison, 29 cents per lineal foot front.

E. B. Elliott, 28 cents per lineal foot front.

D. A. Haywood, 27 cents per lineal foot front.

John Schier, $24\frac{1}{2}$ cents per lineal foot front.

John Schier being the lowest and best bidder, your committee recommend that he be awarded the contract.

2d. For grading, and paving with brick, the east sidewalk of Pendleton Pike, between Clifford avenue and Orange street—

William Morrison, 42 cents per lineal foot front. James W. Hudson, 37 cents per lineal foot front.

John Schier, 33 cents per lineal foot front.

E. B. Elliott, 32 cents per lineal foot front.

Richard Carr, 31 cents per lineal foot front.

D. A. Haywood, 29 cents per lineal foot front.

D. A. Haywood being the lowest and best bidder, your committee recommend that he be awarded the contract.

3d. For grading and graveling East street and sidewalks, except where the sidewalks have already been properly improved, from Morris street to Minnesota street—

Geo. W. Seibert, 26 cents per front foot for grading and graveling the west side of the north portion of said street, where the sidewalks are already improved; 35 cents per lineal foot front for grading and graveling the east side and sidewalks, from Morris street, twelve hundred feet south; and 44 cents per foot front on each side of line improved, for the rest of said street, south, to Minnesota street.

James W. Hudson, 45 cents per lineal foot on each side of line improved.

John Greene, 49 cents per lineal foot front on the east side, and 27 cents per lineal foot on west side, where the sidewalk is already improved, and 49 cents for that part not improved.

Fred. Gansberg, 31 cents per lineal foot, where part of the sidewalk is improved, and 41 cents per lineal foot where not improved.

James Mahoney, 23 cents per lineal foot front on the west side, where the sidewalk is already graded; 35 cents per lineal foot front on the east side, as far south as the west sidewalk is already graveled, and, from that point, south, to Minnesota street, at 39 cents per lineal foot front.

James Mahoney being the lowest and best bidder, your committee recommend that he be awarded the contract.

The City Civil Engineer submitted the following report:

Indianapolis, December 3, 1877.

To the Mayor and Common Council:

Gentlemen :— I would respectfully report that I have examined the Delaware street viaduct over the Union Tracks, and would recommend that the Street Commissioner be instructed to tighten the bolts and screws that have become loosened.

I would also call your attention to the condition of the Vermont street bridge over the canal. It is in a very unsafe condition, and should be repaired, or re-placed by a new one.

The City Attorney submitted the following report and lease; which report was received, and the accompanying lease was duly accepted, approved, and ordered to be filed for record in the office of the Recorder of Marion County:

Indianapolis, December 3, 1877.

To the Mayor and Members of the Common Council of the City of Indianapolis:

Gentlemen :—I herewith submit, for your approval, a lease from the Board of County Commissioners to the City of Indianapolis of the basement story of the Court House, for the term of five years, from January 1st, 1878, with the privilege of a further term of five years.

THIS INDENTURE WITNESSETH, That the Board of Commissioners of Marion County, and State of Indiana, have, this day, demised and leased to the City of Indianapolis, of said county and state, the following premises, in said city, county, and state, to-wit:

All of the several rooms and halls of the basement story of the Court House of Marion County, excepting the two rooms now used for washrooms and water-closets.

The said Board of County Commissioners to furnish said rooms and halls, during the continuance of this lease, with all necessary heat, gas-light, and water; and also to furnish a janitor to properly clean and sweep the stairways leading from said basement story to the story above, and also to clean and sweep the rooms occupied by said washrooms and water-closets.

The said city to hold the said premises, together with the rights, privileges, and appurtenances to the same belonging, for and during the TERM OF FIVE YEARS FROM THE FIRST DAY OF JANUARY, 1878, with the right and privilege of the said City of Indianapolis to continue the same for THE FURTHER TERM OF FIVE YEARS FROM JANUARY 1st, 1883, if she shall so desire, upon the same terms and conditions as herein provided.

And the said City of Indianapolis hereby agrees to pay, as rent for said premises, the sum of THREE THOUSAND DOLLARS PER YEAR—the said rent to be paid quarterly on the first days of April, July, October, and January of each year, without relief from valuation or appraisement laws; which said sum shall be in full payment for the heating, gas, and water to be furnished for said premises, as aforesaid.

The said city shall have the right to occupy any part of said premises from and after the date of this lease, but rent shall not be charged or paid thercfor only from and after January 1st, 1878.

The conditions of this lease are that the premises are to be used and occupied by said City of Indianapolis, in her corporate capacity, for offices for the several city officers, Mayor's court room, and Council and Aldermanic Halls, and for no other purposes; that the same are not to be sub-leased by said city, or occupied by other persons or for other purposes than herein expressed; that no waste shall be committed or damage done the said premises. December 3, 1877.]

At the expiration of this lease, or on the failure to pay the rent when the same is due, or on a failure to comply with any of the conditions of this lease, the same shall terminate at once, at the option of the Board of County Commissioners.

Gentlemen :— I would report that, since the last meeting, the case of Louisa Jones vs. The City has been decided, in the Circuit Court, in favor of the city.

This was a case brought by the residents of N. Illinois street, in 1873, to enjoin the collection of the sewer assessment that was made by the Council . on account of the N. Illinois street sewer. The amount of the assessment was about \$15,000.

I would also report that the case of Valentine Foland vs. The City, in the Superior Court, has been tried since the last meeting of Council, and resulted in a judgment in favor of the city.

This was a suit for damages on account of the overflowing of Foland's premises by the water from the Merrill street sewer.

The Fire Board, through Councilman Case, submitted the following report; which was concurred in :

To his Honor, the Mayor, and Members of the Common Council and Board of Aldermen :

Gentlemen :— A motion, passed by your bodies, instructing the Chief Fire Engineer to examine the stairways and halls of the Surgical Institute, on S. Illinois street, and report if the same is provided with sufficient means of escape, in case of fire, beg leave to make the following report:

The Chief Fire Engineer has carefully examined the building, and finds no provision made for the escape of the inmates in case of fire, excepting a narrow back-stairway, which would easily become blockaded, were a fire to break out in said building; and it is the opinion of the Chief that loss of life would be great.

We therefore recommend that the City Marshal notify the proprietors of said building to proceed at once, and provide sufficient means of escape to the occupants in case of fire, and to conform to the law passed by the last Legislature, regarding fire-escapes.

REPORTS FROM STANDING COMMITTEES.

The Committee on Bridges, through Councilman Morse, submitted the following report; which, on Councilman Thomas's motion, was laid on the table until a report should be made by the special committee charged with investigating the possibility and expediency of using the Delaware street viaduct for bridges over the canal, etc.:

Indianapolis, December 3, 1877.

To the Mayor and Common Council:

Gentlemen:—Your committee to whom was referred the motion instructing the City Civil Engineer to advertise for proposals to erect an iron bridge, with stone abutments, across the canal on Vermont street, would report that we have referred the matter to the Engineer, who furnishes the following estimates of cost:

For wooden bridge, with stone abutments	\$1,975	80
For iron bridge, with stone abutments	\$3,896	70

Your committee would recommend the construction of an iron bridge, with stone abutments.

The Committee on Finance, through Councilman A. L. Wright, submitted the following report; which was considered and duly concurred in by clauses:

Indianapolis, December 3, 1877.

To the Mayor and Common Council of the City of Indianapolis :

Gentlemen :--Your Committee on Finance, to whom were referred sundry papers, respectfully submit their report on the following:

lst. Petition of John W. Davis, for refunding \$5.71 taxes paid, by mistake, on lot 103, in Noble's Sub. of out-lot 55.

As the taxes were due the city, the payment by the petitioner was voluntarily made, and, if refunded, could not be collected from the present owner, if payment should be resisted, your committee recommend that the prayer of the petitioner be not granted.

2d. Petition of Sophia Smith, for refunding a portion of her taxes.

The petitioner was not entitled to an exemption for 1875, her property being appraised, that year, for \$1000, which your committee think, at that time, was a reasonable valuation; and for 1876, she has received the benefit of all the exemption allowed by law. Your committee, therefore, recommend that the prayer of the petitioner be not granted.

3d. Petition of Henry Boecher, for refunding taxes on lot 13, in out-lot 121, claiming an excessive appraisement.

Your committee believe the appraisement to be fair and reasonable, and in accordance with the appraisement of adjacent property, and that it should not be changed; and recommend that the prayer of the petitioner be not granted.

4th. Petition of Thomas C. Burdsal, for refunding \$106.84, with interest at 6 per cent., because of an erroneous sale to him of certain property for delinquent taxes.

Your committee find the statements in the petition to be correct, and recommend that the prayer of the petitioner be granted, and that the Clerk be ordered to bring the taxes of 1876 against the property erroneously sold, and treat it as delinquent. 5th. Petition of John Conway, for refunding money paid by him for taxtitle on lot 5, in out-lot 127, and for the city to reimburse him for money expended in improvements subsequent to such purchase.

Your committee find that, by a suit in the Marion County Superior Court, the original owners of said property dispossessed the petitioner, and obtained possession, by defeating his title thereto; and recommend refunding to him the original purchase money, and six per cent. interest, but against reimbursing him for money expended in improvements.

6th. Petition of Laurena Griffith, for refunding \$7, taxes of 1876 on \$500, under the Widows' Exemption Law.

Your committee recommend that the prayer of the petitioner be granted.

7th. Your committee was instructed by this Council, November 5th and November 19th, upon the recommendation of the City Treasurer, to examine and audit coupons No⁻¹, from bonds 1 to 400, inclusive, of the City Bonds issued in aid of Union R. R. Transfer and Stock-Yard Company, then in the hands of said Treasurer, and, if found correct, to destroy the same.

Your committee made the examination, found the coupons as reported, and destroyed them as instructed.

8th. City Treasurer's Report of Receipts and Payments, for month of October, 1877.

Your committee examined the books of the City Treasurer, and find his report correct, and recommend its approval.

9th. Report of City Clerk, of Orders issued during the month of October, 1877.

Your committee examined the books of the Clerk, and find them to correspond with his report, and recommend that the report be approved.

10th. Petition of Otto Golnish, for refunding amount paid by him on taxcertificate No. 6746, on account of erroneous tax-sale.

Your committee has examined into this matter, and find the sale to have been erroneous, and recommend that the Treasurer refund to him the amount of original purchase, with six per cent. interest, less the amount of taxes legally due the city from the property described in said certificate.

December 3, 1877.] COMMON COUNCIL.

To His Honor, the Mayor, and Common Council of the City of Indianapolis :

Gentlemen :---Your Committee on Gas-Light, to whom was referred the matter of erecting four lamp-posts on West street, between Georgia and South streets, would most respectfully report as follows :

That, in our opinion, there should be two lamp-posts erected—one on the north side of the tracks and the other on the south side. In so doing, it will give the people that have occasion to cross at that point after nightfall, much more protection, as, in the present condition it must be very dark at night—especially a dark night.

The Committee on Streets and Alleys, through Councilman Layman, submitted the following report :

Indianapolis, December 3, 1877.

To the Mayor and Common Council:

Gentlemen :---Your Committee on Streets and Alleys, to whom sundry papers were referred, would report on the following:

lst. Is a petition of sundry business men for the laying of a stone crosswalk over Washington street, from the northeast corner of Pennsylvania street to the building of the Bank of Commerce.

We recommend that the prayer of the petitioners be granted, and the above mentioned cross-walk be laid. The probable cost will be near \$150.

2d. Is a motion to instruct the Street Commissioner to lay a stone crosswalk over Dillon street, on line with the north sidewalk of Fletcher avenue.

We recommend that a single-line crosswalk be laid at this point.

3d. Is a motion to instruct the Street Commissioner to take up the drainage-pipe now in the gutter, at the southwest corner of Delaware and Maryland streets, and make such gutter an open one, by bowldering same.

We recommend above work be done as indicated in the motion.

Gentlemen :--Your special committee and City Attorney, who were directed to prepare and submit an ordinance creating a Board of Public Improvements, would report that we have prepared such an ordinance, and herewith submit the same, and recommend that it be passed.

The following general ordinance was then read the first time, and, on Councilman Marsee's motion, further consideration of same was postponed, and it was ordered to be printed, *in extenso*, in the minutes:

G. O. 43, 1877—An ordinance creating a Board of Public Improvements, prescribing their powers and duties, and the manner of their election.

SECTION 1. Be it ordained by the Common Council and Board of Aldermen of the City of Indianapolis, That there shall be annually elected, by the Common Council and Board of Aldermen, in joint convention, a Board of Public Improvements; which Board shall consist of three members, one of whom shall be a member of the Board of Aldermen, and two of whom shall be members of the Common Council. Said Board of Public Improvements shall be so elected, as aforesaid, by the joint convention held in May of each year, and at the same time that the Fire, Hospital, and Police Boards are elected, and shall take an oath to faithfully perform their duties. The members of such Board of Public Improvements shall serve for the term of one year, or until their successors are elected; provided, that any member of such Board may be removed, at any time, by a majority vote of the Common Council and Board of Aldermen. Any vacancy in such Board may be filled, at any time. by the Common Council and Board of Aldermen, in joint convention, and any person so elected to fill such vacancy shall only be elected for the unexpired term of his predecessor; and provided further, that, after this ordinance shall be ordained and established, the Common Council and Board of Aldermen shall meet in joint covention, and shall elect a Board of Public Improvements, to serve until their successors shall be elected by the joint convention in May, 1878; and provided further, that the Street Commissioner shall be, exofficio, a member of the Board of Fublic Improvements.

SEC. 2. It shall be the duty of such Board of Public Improvements to keep a complete record of all their transactions and proceedings. They shall have general supervision and control of the repairing of all the streets, alleys, culverts, and bridges of the city, the cleaning and scraping of all the streets, alleys, and sewers of the city, the employment of all laborers and teams, and the purchasing of all supplies and materials used therein, and fix the prices to be paid by the city for laborers and teams, subject to the directions and orders of the Common Council and Board of Aldermen. All pay-rolls for labor and teams used and employed in the Street-Repair Department, and all bills, accounts, and claims for materials or labor used in the same, shall be certified to by the Street Commissioner and approved by said Board, before any order shall be drawn or issued upon the Treasurer for the payment of the same. It shall be the duty of said Board of Aldermen, once a month, the amount of the entire expenditures for the previous month, with a general statement of what the expenditures were for; and they shall, in such report, state the total amount of the expenditures of their Department from the beginning of the fiscal year up to the date of such report.

SEC. 3. Such Board of Public Improvements shall report to the Common Council and Board of Aldermen, from time to time, any needed public improvement of the streets and alleys of the city, and submit any plans or improvements in the mode or manner of making the same, that, in their judgment, should be adopted by the city.

SEC. 4. All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

SEC. 5. This ordinance shall take effect and be in force from and after its passage.

The contract and bond of John Schier, for grading, and paving with brick, the east sidewalk of Park avenue (where not already paved), between Cherry and Vine streets, was submitted, and aforesaid contract was concurred in and the bond duly approved.

To the Board of Aldermen :

The undersigned beg leave to report, in the matter of charges against Leander A. Fulmer, Street Commissioner, preferred by Alderman Stratford, as follows:

Alderman Coburn, and Councilmen Morse and Sindlinger were necessarily absent during most of the time of the investigation; but, by consent of the accused and the prosecution, the matter was submitted to the undersigned.

Careful investigation was made; every facility afforded for the production of witness and books and papers on both sides; and the result of the investigation is, That we find Leander A. Fulmer not guilty of the charges preferred against him.

We do find some irregularities in the manner of paying some small accounts for work on the streets and bowlders, not in any way affecting the integrity of the Commissioner and the parties to whom moneys were paid. It was shown that orders were issued, which embraced the accounts of several persons for work and labor and materials, the money paid to the Commissioner, who then paid it to the persons entitled thereto. This was done to save a notary fee of fifty cents, and lessen the discount on orders, which was less on large orders than on small ones. In all cases where this was done, it was proven before us that the account was correct, and the party got his money. We allude to this matter, because it is an exceedingly loose way to do business, and dangerous to the city officials as well as to the city. It would be an easy matter for the small claimants to make out their accounts and properly assign them, and thus afford to the city, and all persons, written and legal evidence of the regularity of their transactions; or, better still, endorse upon the account an order to pay the person or persons whom they wish to collect the money. We recommend that some such rule as this be established by ordinance, if there be none such in force.
