Aforesaid agreement is as follows:

THIS AGREEMENT, made this fourth day of February, 1878, between THE CITY OF INDIANAPOLIS and THE INDIANAPOLIS GAS-LIGHT AND COKE COMPANY,

Witnesseth, That, whereas, there is now existing a contract between said two parties, bearing date of the twenty-second day of July, 1876, concerning which, and the performance of the stipulations of which on the part both of said company and said city, disputes have arisen;

Now, Therefore, In settlement and compromise of all matters in dispute between the parties,

It is hereby agreed, That the City of Indianapolis shall pay to said company the sum of \$7,063.75, being the amount due from said city to said company for gas furnished during the month of February, 1877, and that the suit now pending in the Johnson Circuit Court shall be dismissed, by agreement, at the costs of said city; and that the stipulation in said contract, which provides for the payment, by the said company, of fifteen cents for each and every night for each and every post that is not lighted, and kept lighted, during the time required by the time-tables, be modified so as to apply only to cases where the failure to so light and keep lighted is not caused by frost, over which said company has no control, but said company agrees to use the

utmost reasonable dispatch in thawing out such posts—this modification to extend only to April 1st, 1878.

The said company also agrees to allow a deduction of ten thousand dollars from the bills under said contract of July 22d, 1876, for the months of April and May, 1878, being \$5,000 for each of said months.

Nothing herein shall be construed as changing, modifying, or in any way affecting the legal rights of either party under contracts heretofore made and existing between said parties, except as herein particularly specified.

The Board of Public Improvements, through Councilman Byram, submitted the following report; which was approved:

To the Mayor, Members of the Common Council, and
Honorable Board of Aldermen of the City of Indianapolis:

Gentlemen:—The undersigned having been elected at the last Joint Convention of your honorable bodies, under the provisions of an ordinance, lately passed, creating a Board of Public Improvements, members of said Board, have the honor to report that, under the provisions of said ordinance, they met at the office of the Street Commissioner, in said City of Indianapolis, on Friday evening, January 25th, 1878, and organized by the election of Councilman N. S. Byram as president, and of Henry Coburn as secretary, and are now ready for business.

Also, the following report; the first clause of which was approved, and the second and third clauses were duly concurred in:

To the Mayor and Members of the Common Council of the City of Indianapolis:

Gentlemen:—The undersigned, Board of Public Improvements, to whom were referred sundry papers, have given the several matters referred to them special attention, and beg leave to report as follows:

First. Was special ordinance No. 2, 1878, for the improvement of Morris street and sidewalks, from Chestnut street to Madison avenue.

We find, on examination, that the improvement of this street is of public utility and much needed, it being the only public thoroughfare between the streets named, within several squares, either north or south of the proposed improvement, and, in its present state, almost impassable. We would, therefore, recommend the passage of said ordinance, and that the work be completed at as early day as possible.

SECOND. Is a motion of Councilman Tucker, that the City Civil Engineer be instructed to advertise for proposals to erect a foot-bridge over the Union Railway tracks, on Virginia avenue.

We are of the opinion that a bridge of the kind contemplated in the motion might be a great convenience to the citizens of the South Side, and of public utility. We would, therefore, recommend that the City Civil Engineer prepare plans and specifications, and advertise for proposals for the erection of said bridge—the same to connect the east sidewalk of Alabama street with the east sidewalk of Virginia avenue.

THIRD. Is a motion of Councilman Walker, to have a double-stone crossing placed across Market street, from the northeast corner of Pennsylvania and Market streets to the southeast corner of said streets.

We find that the point named is a much-traveled thoroughfare, and that the crossing is badly needed. We would, therefore, recommend the passage of said motion.

Gentlemen:—Your petitioner would respectfully represent that, on the 17th day of February, 1877, he paid the city taxes on the following described property (paid by receipt No. 1,732, a copy of which is herewith submitted); McK. & P.'s sub. 16 8-12x90 ft. s.e. cor., lot 30, out-lot 126; McK. & P.'s sub. 13 4-12x90 ft. s.w. cor., lot 31, out-lot 126; Sharpe's Add, lot 2; and on personal property, \$25; amounting to \$19.95, paid in the name of Timothy Foley.

The name of Timothy Foley appears on the duplicate three different times; and your petitioner erroneously paid on so much of the within copy of the receipt as refers to parts of lots 30 and 31, in McK. & P.'s sub. of out-lot 126—they being the property of another Timothy Foley.

Your petitioner would respectfully represent that the city taxes for 1876, on the above described parts of lots 30 and 31, McK. & P.'s sub. out-lot 126, were \$8.40; and this amount, \$8.40, was paid in the receipt given. Your petitioner would request that the above amount, \$8.40, be refunded to him, or be made to apply on the tax of 1876 on lot 26, in I. & C. R. R. Co.'s sub. out-lot 90 (the lot which intended to pay on), and have the credit erased from the lots on which he erroneously paid.

Moved, That the City Civil Engineer be instructed to have the gas-lights now on the Delaware street bridge, placed on Michigan street—one at the corner of Leon street, on the north side of Michigan; one at the corner of Cincinnati and Michigan streets; and two at the alleys on the south side of Michigan street, between Noble and East streets.

Councilman Layman offered the following motion; which was adopted:

Moved, That Michael Sells be permitted to lay a brick sidewalk in front of his property on Walnut street, between New Jersey and East streets—the same to be done at his own expense, and under the direction of the City Civil Engineer.

The same gentleman offered the following motion; which was referred to the Board of Public Improvements:

Moved, That the Street Commissioner be instructed to fill, with gravel, the chuck-holes, and level up the low places, in St. Mary street, between Delaware street and Fort Wayne avenue.

Councilman McGinty offered the following motion; which was referred to the Board of Public Improvements:

Moved, That the Board of Public Improvements be directed to authorize the Street Commissioner to fill the chuck-holes in Kentucky avenue. (This motion being adopted about two months ago, it was referred to the Committee on Streets and Alleys, and they reported in favor of it, and named the amount of thirty dollars to be sufficient to complete the same.)

Councilman Pouder presented the following communication; which was referred to City Attorney, with power to act:

Indianapolis, February 4, 1878.

To the Common Council:

Gentlemen:—The lessees of the Sellers' Farm objects to a tank and boiling establishment, for the purpose of rendering dead animals, inside the corporation limits, while the lessees of Sellers' Farm have a long haul over tad roads and compelled to haul their stock some two miles from the city—compelled to haul the distance by an ordinance passed this Council.

I would recommend that the City Marshal be instructed to remove the rendering establishment in question, at once.

Councilman Reading offered the following motion; which was adopted:

Moved, That Howard Barnes have permission to erect a lamp-post on the northwest corner of Pearl street and the first alley east of Illinois street, at his own expense—the gas to be furnish from his own meter.

Councilman Reed presented the following petition; and the prayer of the same was duly granted:

To the Common Council and Board of Aldermen of the City of Indianapolis:

Gentlemen:—The undersigned, citizens of Indianapolis, partners trading under the name and style of Bledsoe & Coombs, respectfully petition your honorable bodies to grant them an "auctioneers' license," authorizing them to sell, at public auction, merchandise, at their place of business, No. 96 E. Washington street, in said city, for and during the term of one year from February 1st, 1878, with the privilege of taking out license for three months at a time.

The same gentleman presented the following petition; which was received:

To the Honorable, the Mayor, and Common Council of the City of Indianapolis:

The undersigned, knowing as they do, from practical experience, that a pure and highly illuminating gas, free from smoke and offensive odors, can be furnished at a less price than is now charged, and at the same time afford a reasonable compensation to the manufacturer, respectfully petition your honors that an ordinance be passed, granting to your orators, their associates and assigns, permission and authority to lay gas mains and pipes under and along the streets, alleys, sidewalks, and other public grounds in the City of Indianapolis, and to maintain and keep the same in repair, for the term of thirty years from and after the date of said ordinance.

Your orators further represent-

- 1. That they will erect their works, lay ten miles of mains and pipes, and furnish gas to consumers, within eighteen months from the date of the passage of the ordinance.
- 2. That they will in no instance charge more then one dollar and sixty cents per thousand cubic feet of gas.
- 3. That the gas shall not be of less than sixteen candle capacity, and free from impurities and offensive odors.
- 4. That the streets, alleys, sidewalks, and public grounds shall be left in as good condition as before trenches are opened for the purpose of laying the mains and pipes.
- 5. That they will, after the first eighteen months, extend their mains and pipes not less than ten miles in each year, until those portions of the city which are now piped, shall be laid with their pipes.
- 6. That they should not be required to lay mains or pipes on streets not now supplied with gas pipes, unless there shall be at least two consumers for each one hundred feet of mains or pipes so required to be laid.
- 7. That the gas should be inspected and tested at such times as the Common Council may determine, and by an expert inspector appointed for that purpose.

And your petitioners will ever pray, etc.

THE CAPITOL GAS IMPROVEMENT & CONSTRUCTION COMPANY OF WASHINGTON, D. C. By its President, duly authorized, Thos. S. Sprague, Detroit, Mich.

On Councilman Steinhauer's motion, it was ordered that the above document be referred to a select committee of two Aldermen and three Councilmen.

The Chair, thereupon, appointed Councilmen Reed, A. L. Wright, and Layman as the Council members of aforesaid select committee.

Councilman Steinhauer presented the following remonstrance against the passage of special ordinance No. 3, 1878; and said document, together with the ordinance and the petition for the introduction of the same, were, on motion, referred to the Committee on Streets and Alleys, with instructions to such committee to recommend that the ordinance be not passed:

Indianapolis, January 25, 1878.

To the Honorable Mayor, Aldermen, and Councilmen of Indianapolis:

Gentlemen:—We, the undersigned, property holders on Russell avenue and S Illinois street, having heard that, in the City Council, an ordinance was introduced, providing for the grading and graveling of the alley between Russell avenue and Illinois street, running from W. McCarty street not further up than to the first alley below Norwood street (about 190 feet long), respectfully remonstrate against the passing of this ordinance, for this alley is closed up at the northern end by Harting's brewery buildings, and is of no use to any body, except to the adjoining inhabitants. And besides, it is too hard on us to pay for the proposed improvement these needy times, when we hardly make our living, and have to restrain all expenses as much as possible. We are willing to repair this alley ourselves, and keep it passable and clean. And thinking this sufficient, at the present time, we pray that your honorable boards will not consent to pass aforesaid ordinance.

the Common Council at its meeting held January 7th, 1878, and amended by the Board of Aldermen, at its meeting held January 22d, 1878, be referred to the Commissioners, with instructions to assess benefits and damages, and to make due report; and that for the purposes of such laying out, opening and extending such street, as aforesaid, the Common Council and Board of Aldermen do propose to appropriate such real estate and property as may be necessary therefor. The said Commissioners are instructed to return, as part of their report, all petitions and notices. The City Clerk is hereby directed to issue, and the City Marshal to serve, the proper notices upon the Commissioners and property owners.

Which was passed by the following vote:

Affirmative—Councilmen Brown, Bugbee, Byram, Dill, Izor, Layman, Marsee, Morse, McGinty, Pouder, Reading, Reed, Steinhauer, Thomas, Tucker, Walker, Wood, and W. G. Wright—18.

Councilman Reed was granted leave of absence for the balance of this session.

At request of Councilman Izor, the courtesies of the Council were extended to —— McMullen, of Washington, D. C., and the latter gentleman explained the merits of the Parisen Concrete Pavement.

On motion, the Common Council then adjourned.
