The Board of Aldermen met, pursuant to adjournment.

PAPERS FROM THE COMMON COUNCIL—ACTION UPON.

The report from the City Civil Engineer, reporting a second and partial estimate in favor of James Mahoney, for improving Wabash street between Alabama and Delaware streets; also, a first and final estimate in favor of John Flaherty for grading and graveling the first alley north of Second street, from Pennsylvania street to the first alley west, and the estimate resolutions accompanying said report [see Proceedings of Common Council, May 21, 1877, pages 33 and 34], were read, and the estimates concurred in and adopted by the following vote:

The report of the City Clerk, stating that sundry affidavits, for the collection of street and sewer assessments by precept, were on file in his office [see Proceedings of the Common Council, May 21, 1877, page 40], was read and concurred in, and the precepts ordered to issue by the following vote:

The resolution providing for a special election, to be held in the Sixteenth Ward, on the 20th day of June, 1877, for the election of

one Councilman from said ward [see Proceedings of the Common Council, May 21, 1877, page 46], was adopted by the following vote:

Affirmative—Aldermen Chandler, Coburn, Foster, Krug, McGill, Snyder, Stratford, Wiles, and President Newcomb—9.

The motion instructing the City Clerk and Committee on Printing to cause to be printed 200 committee cards [see Proceedings of the Common Council, May 21, 1877, page 47], was read.

On motion by Alderman Foster, the motion was amended so as to include the committees of the Board of Aldermen.

The motion, as amended, was adopted by the following vote:

The motion instructing the Street Commissioner to clean the gutters on Tennessee street, between Ray and McCarty streets [see Proceedings of the Common Council, May 21, 1877, page 50], was read, and, on motion by Alderman McGill, referred to the Committee on Streets and Alleys.

The motion granting permission to Fred Brocking to grade and gravel, at his own expense, the sidewalk on the corner of Illinois

and Ray streets [see Proceedings of the Common Council, May 21, 1877, page 50], was read and adopted.

Special ordinance No. 123, 1876, entitled

An ordinance to provide for grading and graveling California street and sidewalks, from Washington street to Maryland street,

Was taken up and read the first time.

Special ordinance No. 134, 1876, entitled

An ordinance to provide for grading and graveling Pearl street, between Tennessee and Mississippi streets,

Was taken up and read the first time.

Alderman Stratford moved to suspend the rules for the purpose of placing the above entitled ordinances on their second and third reading, and final passage; which motion was adopted, and the rules suspended by the following vote:

Church from its present lot, north of Massachusetts avenue, between Oak and Plum streets, to Butler street, near Central avenue, by way of Arch street to Park avenue, on Park avenue to Butler street, and on Butler street to the new lot, northeast corner of Butler street and Central avenue.

Negative-None.

Alderman Stratford offered the following resolution:

Resolved, That this Board of Aldermen recommend to the Mayor and Common Council the appointment of two or more experts, to examine the books of the City Treasurer and City Clerk, they never having been examined, or for many years at least.

Alderman Wiles moved to refer the motion to the Committee on Finance; which motion to refer was adopted by the following vote:

Affirmative—Aldermen Chandler, Coburn, Foster, Krug, Wiles, and President Newcomb—6.

Negative—Aldermen McGill, Snyder, and Stratford—3.

On motion, the Board of Aldermen adjourned until Wednesday evening, May 30, 1877, at 8 o'clock.
