Beginning at the Northeast corner of East 38th Street and North Post Road as now located, said point also being on the corporation line of the City of Indianapolis, running thence East upon and along the North line of the City of Indianapolis as now located, to a point on the East line of the West half of the West Half of said Southwest quarter Section; running thence North upon and along the East line of the West Half of the West Half of said Southwest Quarter Section and along the corporation line of the City of Indianapolis to a point on the South line of East 42nd Street as now located; running thence West upon and along the South line of East 42nd Street as now located and along the corporation line of the City of Indianapolis to its intersection with the East line of North Post Road as now located; running thence South upon and along the East line of North Post Road as now located and the corporation line of the City of Indianapolis to the point or place of beginning.

Containing in all 40.0 acres more or less.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication according to law.
