At the time of the annexation of the Town of Brightwood the city assumed bonds issued for this plant to the amount of \$18,000; \$8,000 of this amount has been paid, leaving \$10,000 still unpaid. The maintenance of this plant has not been satisfactory from a financial point of view, and as it would be necessary to practically build a new plant in order to overcome the faults found by the City Sanitarian and the Chief of Fire Department, we would respectfully suggest the sale of this property. Board of Public Safety, City of Indianapolis:

GENTLEMEN: After making a test of the Brightwood Water Plant, with three lines of hose, one line of 400 feet, with $I_3^{\frac{1}{2}}$ inch nozzle; two lines of 250 feet each, with one I inch nozzle and one $I_3^{\frac{1}{2}}$ inch nozzle, I would recommend that something be done in the near future to give the town better fire protection.

As it is now, judging by my experience in the past and from the test I made January 10, 1909, at 9:35 A. M. it is entirely inadequate to take care of the factories and business buildings located there.

PRESSURES AND DISTANCE THROWN AT TEST JANUARY IO, 1909. Attached pressure gauge to hydrant at corner of Wheeler street and Roosevelt avenue at 9:30 A. M., gauge showed 40 pounds; sent in alarm at 9:33 A. M.; laid 400 feet of hose with 1¹/₈ inch nozzle; turned on water at 9:40 A. M.; at 9:45 A. M. gauge showed 60 pounds with a good stream of water. Then we laid two lines of 250 feet each, with one I inch nozzle and one 11k inch nozzle, from a hydrant 500 feet north; at 9:50 A. M.,

when this hydrant was opened, the pressure dropped to 35 pounds, five minutes later it dropped to 30 pounds, where it remained for ten minutes. The three streams reached a distance of 35 feet each and were of no force whatever, in fact the play pipes were left lying on the ground when the men went to shut down the hydrants.

GENTLEMEN: Your letter of January 8th to hand. In reply to your first question I will say, that the water of the Brightwood Water Works at its best, is in no way superior or better than the water furnished to the citizens of Indianapolis by the Indianapolis Water Company. The mere fact that it is obtained from a well does not signify that it is more potable than water that is carefully treated from the river; nor is it more wholesome as far as human consumption is concerned.

In reply to your second question, I will say, that the Brightwood Water Works cannot be compared in any particular with the facilities of the Indianapolis Water Company. This is exactly where the trouble is. It requires careful and expert management of a water plant to constantly supply a potable water.
