WHEREAS, The said Board of Public Works did at the same time fix the 1st day of February, 1909, at 10 o'clock a. m., as a date to hear all persons interested or whose property is affected by said proposed improvement; and the notice of the passage of said resolution and of the said time for hearing was published on the 14th day of January, 1909, and the 21st day of January, 1909, in the Indianapolis Sun, a daily newspaper of general circulation, printed and published in the City of Indianapolis, and notices by mail duly forwarded as provided by law; and

WHEREAS, On the 1st day of February. 1909, the Board having met in regular session. took final action on said improvement resolution, the same being confirmed without modification; and

WHEREAS, On the 9th day of February, 1909, a written remonstrance of a majority of the resident property owners was filed with the Board against the said improvement; and

WHEREAS, On the 10th day of February. 1909, the said Board of Public Works directed that an ordinance ordering said improvement be submitted to the Common Council for their consideration and action thereon; now, therefore,

SECTION I. Be it ordained by the Common Council of the City of Indianapolis, Indiana. that the Board of Public Works of said city be, and are hereby ordered to improve Lowell avenue from the north end of Hawthorne Lane to the west property line of Arlington avenue, except the crossings of Irvington and Ritter avenues, with bitulithic roadway, brick gutters and curbing, in accordance with Improvement Resolution No 5860. 1000, adopted by the Board of Public Works January 13, 1909, and confirmed February 1, 1909. Be it ordained by the Common Council of the City of Indianapolis, Indiana, That it shall be unlawful for any person to remove, take possession of or dispose of the body, or any part of the body, of any dog or other animal that has been killed by any person within said City of Indianapolis, and which is suspected to have been afflicted with the disease known as rabies, until the Board of Public Health and Charities has had opportunity to make examination of the same.

SEC. 2. It shall be the duty of every person who shall kill or assist in the killing of any dog or other animal in the City of Indianapolis, which is suspected of being afflicted with the disease known as rabies, immediately after such killing to notify the Board of Public Health and Charities of the location and description of the body of such dog or other animal.

SEC. 3. Any person violating any of the provisions of this ordinance shall, upon conviction thereof, be fined in any sum not less than twentyfive dollars, nor more than fifty dollars. SEC. 4. This ordinance shall be in full force and effect from and after

SEC. 4. This ordinance shall be in full force and effect from and after its passage and publication once each week for two consecutive weeks in the Indianapolis Commercial, a daily newspaper of general circulation, printed and published in the City of Indianapolis.
