George T. Preunig, City Controller, City:

My Dear Sir: The appropriation for the care of tuberculous patients is practically exhausted. At the time the appropriation was made it was not possible to foresee to what extent this clinic would grow. It has now far exceeded our expectations and is still continuing to grow.

We early recognize that in order to accompolish results it would be necessary to maintain a colony in connection with the clinic, for the reason that offtimes patients would come from homes in which the family lives in two or three rooms; that the patients would sleep in the same room and sometimes in the same bed with other persons; that they were not only a menace to themselves, but to the rest of the family if permitted to continue in this way, and that under these circumstances the tubercular clinic could do little good.

Through the kindness of the Anti Tuberculosis League of Indiana four cottages were erected on the City Hospital ground. This was soon followed by private donations, so that at the present time we have

eleven cottages and two more in the process of erection.

All of these, with one or two exceptions, were also furnished by the donors, so that as far as the colony itself is concerned it has not cost the city a single cent, with the exception, of course, of its maintenance.

In order that this work may continue to grow, and to take care of the patients we now have, it will be necessary to have an additional appropriation of at least \$1,500.

INTRODUCTION OF GENERAL AND SPECIAL ORDINANCES.

# By Mr. Wood:

General Ordinance No. 29—1909: An ordinance regulating the use of vehicles on the streets, alleys and public highways of the City of Indianapolis; providing penalties for the violation thereof and fixing a time when the same shall take effect.

Section I. Be it ordained by the Common Council of the City of Indianapolis, Indiana, That it shall be unlawful for any person, firm or corporation to use or leave standing in any public street, alley or highway within the corporate limits of the City of Indianapolis, from one-half hour after sunset to one-half hour before sunrise, any vehicle of any kind, unless there shall be kept burning on the front of said vehicle at least one white light, visible for a distance of not less than two hundred feet, and on the rear at least one red light, visible for a distance of not less than two hundred feet, or, in lieu thereof, at least one light so located on the vehicle as to be visible both toward the front and toward the rear of not less than two hundred feet, and which shall show white towards the front and red toward the rear.

SEC. 2. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction, be fined not less than one dollar (\$1.00), nor more than one hundred dollars (\$100), to which may be added imprisonment for a term not to exceed sixty days in the Marion

County jail or workhouse.

SEC. 3. This ordinance shall take effect and be in full force in twenty days from and after its passage and publication once each week for two

consecutive weeks in the Indianapolis Commercial, a daily newspaper having a general circulation in the City of Indianapolis.

## By Mr. Royse:

Special Ordinance No. 6—1909: An ordinance annexing certain territory to the City of Indianapolis, and defining a part of the boundary line of said city, and fixing the time when same shall take effect.

Section I. Be it ordained by the Common Council of the City of Indianapolis, Indiana, That the boundary lines of the City of Indianapolis be, and the same are hereby extended so as to include the following described contiguous territory, all of which is hereby annexed to and made a part of the territory constituting and forming the City of Indianapolis in Marion County, Indiana, to-wit: Commencing at a point at the corner of Tibbs avenue and Vermont street; thence west to Little Eagle Creek; thence follow the bed of said creek in a northwesternly direction to the west line of the northeast quarter of Section 5, township 15, range 3 east; thence north to the north line of said quarter section; thence east with said north line to Tibbs avenue; thence south on Tibbs avenue to Vermont street, to the place of beginning.

SEC. 2. This ordinance shall be in full force and effect from and after its passage and publication for two consecutive weeks in the Indianapolis Commercial, a daily newspaper of general circulation, printed and published in the City of Indianapolis, Indiana.
