GENTLEMEN: Your Committee on Finance, to whom was referred Appropriation Ordinance No. 38, 1909, being "An ordinance appropriating moneys for the purpose of defraying current expense of the city government of the City of Indianapolis, Indiana, and for the use of the several executive departments thereof, for the fiscal year beginning January I, 1910, and ending December 31, 1910, including all outstanding claims and obligations, and fixing a time when the same shall take effect," beg leave to report that they have had the same under consideration and would recommend that said ordinance be amended as follows:
