ORDINANCES ON FIRST AND SECOND READING.

By Councilman Nolan. Read the first time:

Ap. O. No. 4, 1891—An ordinance appropriating thirteen hundred dollars for the use of the Department of Public Works, and eight hundred dollars for the use of the Department of Public Health and Charities.

On motion by Councilman Coy, the following entitled ordinance was read the second time :

G. O. No. 16, 1890—An ordinance to divide the City of Indianapolis, Indiana, into fifteen Wards, and to establish the boundaries of the same, under and by virtue of an Act entitled "An act concerning the incorporation and government of citus having more than one hundred thousand population, according to the last preceding United States census, and matters connected therewith, and declaring an emergency;" approved March 6th, 1891.

On motion, the above entitled ordinance was then ordered engrossed.

Councilman Coy moved that G. O. No. 16, 1891, be read the third time; and on that demanded the previous question.

The question being, "Shall the main question be now put?" which was so ordered, by the following vote:

On motion by Councilman Rassmann, the following entitled ordinance was read the second time :

G. O. No. 17, 1881—An ordinance designating the license fee to be paid the City of Indianapolis by distilleries and breweries, and the depots or agencies in said city of all breweries and distilleries, and all wholesale dealers in malt liquor, as provided for by the Act of the General Assembly of Indiana, approved March 6, 1891.

Ordered engrossed, read the third time and passed, by the following vote:
