Moved, by the Common Councilof the City of Indianapolis, That the City Clerk be, and is hereby, authorized to have printed five hundred maps of the City of Indianapolis, showing the Ward and Precinct boundaries as established in General Ordinance No. 20, 1891, and that he be authorized to supply one to each of the Inspectors of the city election when said Inspectors are appointed.

Councilman Woollen offered the following resolution :

RESOLUTION No. 9, 1891.—Resolved by the Common Council of the City of Indianapolis, That the City Comptroller of said city be, and he is hereby, authorized and empowered to arrange for the exchanging of funding bonds of said city to draw four and one-half per cent. interest, payable semi-annually, and both interest and principal payable at the Banking House of Winslow, Lanier & Co., of New York, at such times as 'may' be named in the bonds, for a like amount of any of the outstanding bonds of said city drawing six per cent interest or more, upon the following terms and conditions, to-wit: The premium on said outstanding bonds to be determined upon a basis of four per cent. interest on the bonds, and the holders to be compensated for the premium thereon by the funding bonds running for a sufficient time to equal it on the basis of four per cent. interest; that is to say, until the one-half of one per cent. shall equal the premium. And it is further Resolved, That said Comptroller shall prepare in proper manner funding bonds of the denomination of one thousand dollars each, for the purpose aforesaid, which bonds shall be signed by the Mayor and City Comptroller, and for their payment, according to their tenure, the faith of the City of Indianapolis is hereby irrevocably pledged. And it is further Resolved, That said Comptroller is authorized to pay a commis-

And it is further Resolved, That said Comptroller is authorized to pay a commission of one-fourth of one per cent. on the principal of such outstanding bonds of the city drawing six per cent. interest or more, to any person or persons who shall procure their exchange for an equal amount of the funding bonds, upon the terms heretofore named.

Which was referred to the Committee on Ways and Means.
