APPROPRIATION ORDINANCES.

Councilman Rassmann introduced the following ordinnnce; which was read first time:

Ap. O. No. 7, 1891.—An ordinance appropriating moneys for the purpose of defraying the current expenses of the City Government of the City of Indianapolis, Indiana, for the fiscal year ending August 31, 1892, including all outstanding obligations or claims which become due and payable within said period.

Councilman Coy moved the suspension of the rules for the purpose of placing Ap. O. No. 7, 1891, on its final passage; which was objected to by Councilmen Myers and Trusler.

INTRODUCTION OF GENERAL ORDINANCES.

Councilman Rassmann introduced G. O. No. 35, 1891, which was read first time:

G. O. No. 35, 1891.—An ordinance fixing the rate of levy and taxation for the City of Indianapolis for the ensuing year.

By Councilman Gasper. Read first time :

G. O. No 36, 1891.—An ordinance licensing, taxing and regulating branch stores or establishments, and all other concerns established in the City of Indianapolis for temporary business only; and repealing all ordinances or parts of ordinances in conflict therewith.

By Councilman Markey:

G. O. No. 37, 1891.—An ordinance amending Section one of General Ordinance No. 26, the same being an ordinance to increase the public revenue of the City of Indianapolis by requiring all retail dealers in intoxicating liquors to obtain and pay for license thereof.

Councilman Markey moved to suspend the rules for the purpose of placing G. O. No. 37, 1891, on its final passage, which was objected to by Councilman Burns, who moved to refer same to the Judiciary Committee, which latter motion failed of adoption by the following vote :

NAYS, 21-viz: Councilmen Austin, Cooper, Coy, Dunn, Gasper, Gauss. Hicklin, Markey, Martindale, Murphy, Myers, McGill, Nolan, Olsen, Pearson, Rassmann, Sherer, Stechhan, Trusler and Weber.

Councilman Burns then withdrew his objection to the suspension of the rules.

On motion the City Clerk was ordered to amend G. O. No. 37, 1891, by inserting the publication aud emergency clause, by the following vote :

G. O. No. 37, 1891, was then read a second time, ordered engrossed, and passed, by the tollowing vote :

By Councilman Myers. Read first time ;

G. O. No. 38, 1891.-An ordinance regulating the closing of saloons.

Councilman Myers offered the following motion :

Moved by the Common Council of the City of Indianapolis, That the Chair appoint a committee of three to confer with Mr John P. Frenzel, President of the Citizens' Street Railroad Company, with the view of securing cheaper rate for fare, by selling six tickets for twenty-five cents.

Which was adopted, and the following committee was then appointed : Councilmen Myers, Olsen and Gauss.

Councilman Stechhan moved as a question of personal privilege that the records (*ante*, page 20, 2d part) be corrected, showing that he voted "Nay" on the salary ordinance raising the salaries of certain city officers.

Which was adopted.

Councilman Trusler offered the following motion:

Moved by the Common Council of the City of Indianapolis, That the city records, vouchers, pay-rolls etc., are public records, and that access to said papers and vouchers is necessary to a proper understanding of the city's affairs, without which members of the Common Council would be unable to vote intelligently on many subjects; and that a copy of this motion be furnished to the City Comptroller, City Commissioners, City Engineer and Board of Public Works.

Which motion was adopted by the following vote:

Aves, 19-viz: Councilmen Austin, Cooper, Coy. Dunn, Gasper, Gauss, Hicklin, Markey, Martindale, Murphy, Myers, McGill, Nolan, Olsen, Pearson, Rassmann, Sherer, Stechhan and Trusler.
