REGULAR SESSION--November 2, 1891.

The Common Council of the City of Indianapolis, met in the Council Chamber, on Monday evening, November 2d, A. D. 1891, at 7:30 o'clock, in regular session.

INTRODUCTION OF GENERAL AND SPECIAL ORDINANCES.

Under this order of business the following entitled ordinances were introduced:

By the City Clerk (for Board of Public Works). Read first time.

G. O. No. 40, 1891.—An ordinance approving a certain contract granting the right to lay and maintain a switch or side-track across Cruse street, in the City of Indianapolis, Indiana.

By Councilman Coy. Read first time and referred to Committee on Health:

G. O. No. 41, 1891.—An ordinance to prevent the sale of impure and unwholesome baking powder.

By Councilman Myers. Read first time and referred to Committee on Streets and Alleys:

G. O. No. 42, 1891.—An ordinance changing the name of Plum street to that of College avenue, and to provide for re-numbering College avenue from Massachusetts avenue to Seventeenth street.

By Councilman Myers. Read first time and referred to Committee on Judiciary:

G. O. No. 43, 1891.—An ordinance to provide for the annexation to the City of Indianapolis of certain territory adjacent and contiguous to said city, made under and by virtue of an Act of the General Assembly of the State of Indiana, approved March 6th, 1891.

By Councilman McGill. Read first time:

G. O. No. 44, 1891.—An ordinance fixing the limits within which privies not connected with a sewer shall not be erected or maintained, and providing a penalty for violation thereof.

By Councilman McGill. Read first time:

(4. O. No. 45, 1891.—An ordinance providing for the licensing of buyers of empty bottles, fixing the amount to be paid for such license and the period for which the same shall be issued, and repealing all ordinances or parts of ordinances in conflict therewith.

By Councilman Nolan. Read first time and referred to Committee on Health:

G. O. No. 46, 1891—An ordinance prohibiting the removal of dead horses, mules, cows, dogs, sheep and other animals through or along any of the public highways of the City of Indsanapolis, except the same be authorized by contract with said City of Indianapolis, and providing a penalty for violation thereof.

INTRODUCTION OF MISCELLANEOUS BUSINESS.

Councilm in Rassmann, by request, offered the following resolution:

RESOLUTION No. 11, 1891—Resolved by the Common Council of the City of Indianapolis, That the City Comptroller be, and he hereby is, authorized to use of the money heretofore appropriated by the Common Council to the Department of Finance to pay salaries, a sum not exceeding one thousand (\$1,000) dollars, to pay for clerical help in his office in addition to the amount named in schedule "A," heretofore submitted to the Committee of Ways and Means, and included in the estimates of the present fiscal year.

On motion of Councilman Coy the above resolution was referred to the Finance Committee.
