RESOLUTION No. 15, 1891 - Whereas, The General Assembly of the State of Georgia did, on the 10th day of October, 1891, unanimously adopt certain resolutions asking for the co-operation of all interested in securing an adequate appropriation by the Congress of the United States for the immediate improvement of the Savannah River, from the City of Savannah to the Ocean, upon the plan adopted by Congress, at its last session, for this purpose; and whereas, the Common Council of the City of Indianapolis, Indiana, fully recognizes and appreciates the importance of immediately completing the work at Savannah, Ga., in the interest of the commerce of the whole country, but as especially due to the rapidly-growing commerce of the South and West; therefore, be it

Resolved, That the Common Council of the City of Indianapolis urges upon our Senators and Representatives in Congress to aid and assist the Senators and Representatives from Georgia to secure the appropriation asked by their State for the improvement of the river and harbor of Savannah.

Resolved, That a copy of these resolutions be furnished to the Hon. John J. McDonough, Mayor of Savannah, Ga., and our Senators, and the Hon. Wm. D. Bynum, the Representative from this district in the Congress of the United States.

To the Honorable, the Common Council of the City of Indianapolis:

Gentlemen:—I respectfully a k you to authorize the Mayor and City Comptroller to make a temporary loan or loans in behalf of the city, for an amount not exceeding one hundred and twenty-five thousand dollars, at a rate not exceeding six per cent., and not to run beyond April 20, 1892. The semi-annual interest on the city's bonded debt, amounting, with exchange, to \$63,157.35, will be due January 1, and must be paid, and the other necessary expenses of the city will be greater than the ordinary receipts until next April, when the taxes on the duplicate of 1891 will be available. DEPARTMENT OF FINANCE, OFFICE OF CITY COMPTROLLER,) Indianapolis, Ind., December 15, 1891.

To the Common Council of the City of Indianapolis:

Gentlemen:-The County Auditor of Marion county has filed a bill against the city for \$8,873.90, the city's portion of the cost of assessing her property for 1890. I find, by examining the records in the office of the City Clerk, that the city is one year behind in paying the cost of assessing her property, and has been since 1887. On the 28th of last April the city paid the county \$8,217.59, which has been allowed by the Council, December 8, 1890. At the commencement of the present fiscal year I asked for an appropriation of \$2,500—the amount fixed by law—to pay tor ass ssing the property of 1891, which was granted. But the cost for a sessing for 1890 is unprovided for. I therefore recommend that your honorable body appropriate \$8,873.90 to the Department of Finance, to enable it to pay the bill named above.

Mr. President and Members of the Council:

Gentlemen:—As my time is about to expire as a member of this body, I wish to take advantage of this opportunity with a few words.

I was elected a member of Council from the Fifth Ward in 1879, and have had the honor of representing that banner Ward ever since — making nearly thirteen years I have been a member. Having received the nomination and election six times in succession, which entitles me to the credit of serving more years in succession than any member in the history of the Council.

I can only say that I have endeavored at all times to represent my constituents and the City at large to the best of my ability and judgment. If I have made mistakes, it has been of the head, and not of the heart. I leave my record with you. My votes on all questions for the thirt en years are recorded in the Council Proceedings, and I can say I am proud of that record. I can not recall a single vote I have cast in all that time I would not cast again under the same circumstances. And, gentlemen, there is another record that I have with you, that I am more than proud of—one that no contractor, agent, citizen or corporation can deprive me of, and I defy contradiction—and that is, I leave this body with the satisfaction of knowing that during my thirteen years of service for the city, I have never received one cent, directly or indirectly, for my vote or influence.

My experience has taught me that the mann r of running our city government, before the passage of the new Charter, was unbusiness-like—It was to the interest of each member to look after his particular Ward, consequently the city as a whole did not receive its share of attention.—I am a strong advocate of the new Charter,

believing it is formed on business principles, and trust the incoming Council will work in harmony, and give all aid in their power to the Mayor, city officers and the different Boards, to make the Charter a grand success.

My relations with this Council have been most pleasant, and I wish to thank his Honor, Mayor Sullivan, President Yontz, and each and every member of this Council, the city officers and last, but not least, the gentlemanly reporters of the papers, for kind and courteous treatment.

I thank you, gentlem n, for your attention. Wishing you a merry Christmas and a happy New Year, I will say good by.

O. 13, 1891—An ordinance creating the office of Inspector of Plumbing and House-drainage; daining the powers, duties and functions attaching to such office; providing for the licensing of those carrying on the business of plumbing and house drainage, as proprietors, and of those engaged in such business as journeymen; authorizing and directing the inspection of all plumbing and house-drainage in buildings and structures in the City of Indianapolis, and relating to other matters properly connected therewith; fixing penalties for any violations thereof, and repealing all ordinances or parts of ordinances in conflict therewith.
