GENTLEMEN: On November 21, 1910, I sent to your body a communication from the City Attorney regarding the passage of an appropriation ordinance to pay certain claims against the city on account of reductions in assessments on the Pleasant Run interceptor sewer by order of the Marion Circuit Court. At the meeting of your body on the same date, Appropriation Ordinance No. 77 was introduced providing for the appropriation of \$1,807.46, which sum was to provide for the payment of a part of the assessments reduced by said court.

I now submit herewith another communication from the City Attorney advising me that further reduction by said court in the amount of \$6,829.25, together with interest on the amount of \$1,807.46 should be paid.

I submit herewith an ordinance providing for the appropriation of \$8,745.16 to cover all of the above amounts, and recommend its passage, the amount of \$1,807.46 covered by Appropriation Ordinance No. 77 being included in this appropriation ordinance, and would respectfully recommend that Appropriation Ordinance No. 77 be not further considered.

DEAR SIR: Referring to yours of the 28th inst., with reference to an appropriation covering interest on assessments for the Pleasant Run interceptor, kindly be advised that we have submitted to the court the question of the assessment for the cemeteries, and the court has held that the city is bound to pay such assessments, and so in making your recommendation for the appropriation, we would advise that the amount allowed by the court, which is \$6,829.25, together with interest on the \$1,807.46, the interest running from the time when the amount would be due, which I am informed is thirty days after the adoption of the final assessment roll. There is no question but what the Capital National Bank has a right to the interest on the fund.

SEC. 4. This ordinance shall take effect and be in full force from and after its passage.
