Notice is hereby given to tax-payers, that, in pursuance of the provisions of section 59 of the City Charter, the Common Council and Board of Aldermen, together with the City Clerk and City Assessor, will meet at the Chamber of the Common Council, in the City of Indianapolis, on Wednesday evening, August 28th, 1878, as a Board of Equalization, to hear and decide complaints, if there be any, and equalize the appraisements for the year 1878, as right and justice may require.

A roll-call was had, with the following result:

Absent—Aldermen Chandler, Coburn, Grubbs, and Snider, and Councilmen Dill, O'Brien, Rodibaugh, and Showalter—8.

It appearing from the foregoing roll-call that a quorum was present, the Board of Equalization proceeded to business.

The City Clerk called the roll of the Wards, for the presentation of complaints against the assessments of 1878.

First Aldermanic District—Councilman Morris. Second Aldermanic District—Councilman Maus. Third Aldermanic District—Alderman Grubbs. Fourth Aldermanic District—Councilman Marsee. Fifth Aldermanic District—Councilman Steeg.

On Councilman Walker's motion, the Board of Equalization then adjourned, to meet again on Friday evening next, September 6th, at the usual hour.
