Indianapolis Arsenal, Indianapolis, August 24, 1878.

Hon. John Caven, Mayor of the City of Indianapolis, Ind.:

Sir:—I would respectfully call your attention to the filthy condition of "Crooked Run,"

In view of the recommended action of the Board of Health, published in this morning's paper, I would respectfully suggest the propriety of determining whose duty it is to disinfect this fearfully dirty stream. Its condition is a disgrace to any civilized community, and it seems as if the city authorities would take some action, if brought to their notice. For this reason, I have the honor to request that you will call their attention to the condition of Crooked Run.

In the summer of 1876, I called your attention to this same subject, with request it be referred to the City Council. Last summer (1877), I presented a petition to the Board of Health of the city, signed by a large number of property holders in this vicinity, asking for an examination and relief, without avail. To-day, the nuisance is as bad as ever. Yesterday, at 3 o'clock P. M., the stench from this stream was perceptible at my house, and last night it was worse.

If the city authorities will give the subject enough of their attention as to secure an examination of this stream by a committee or otherwise, I am under the impression they will not fail to see the necessity of some action being taken at once. This communication is based upon the advice of the attending physician.

And the party of the second part hereby agrees to pay to the party of the first part the sum of ninety cents per foot for said hose, when so furnished and delivered.

Perhaps some of the above receipts would be more satisfactory with a little explanation. In taking charge of the Fire Department, I found that four (4) of the fire alarm boxes connected with our telegraph lines, were owned by the following Institutions, located outside of the city: One at the Insane Hospital, one at the Deat and Dumb Asylum, one at the Female Reformatory, one at the U.S. Arsenal. Finding that the above boxes were kept up at the city's expense, I reported the same to the members of the Fire Board, who ordered me to estimate the cost of keeping up the boxes, to make out a bill of the same, and present it to the above named Institutions. This I did, with the result mentioned, being informed by the Superintendent of the Insane Asylum that they would cheerfully pay the required amount.

If it could be so arranged that a small amount of money could be appropriated, so as to be drawn through the agency of the Fire Board or otherwise, in order to pay for expressage, telegraph dispatches, and other incidental expenses that can not be put off, it would be very convenient, as parties connected with the Fire Department are not always prepared to meet such demands. At other times, money could be saved by buying feed on the market, were some way provided for immediate payment, since parties living in the country, and selling feed on the

market will not sell unless cash is paid.

Also, presented the following petition; which was referred to the Judiciary Committee and the City Attorney:

Indianapolis, September 2, 1878.

To the Mayor, and Members of the Common Council and Board of Aldermen:

Gentlemen:—Your petitioner, William Brink, would respectfully show that he is the owner of a house and lot situated in Yeiser street, being number 31 on said street; that his said house and lot is all the real estate that he owns, and is his place of residence; that said house and lot has been greatly damaged by the overflow of water in and upon the same; that the said overflow was caused by the defective drainage system adopted by the city in providing for the grading and improvement of a large number of streets, by which the surface water was accumulated and caused to flow down said Yeiser street, in front of your petitioner's residence, in such large quantities that, at and after each hard rain, the same overflowed the street, and ran in and upon the property of petitioner; that said water has been allowed to so overflow for the past six years, and has caused his cellar to cave in, greatly injures the property, and, by causing the water to accumulate and stand in his cellar, has injured the health of his family; and he therefore asks your honors to allow and pay him the sum of three hundred and fifty dollars for his damages. And he will ever pray.

Moved, That the Street Commissioner be instructed to deposit such quantity of street scrapings as can be spared for that purpose, in the low ground formerly used as a coal-yard, on North street, between Railroad and Davidson streets.

Moved. That all lamps that have been cut off, that seem to have been cut off in wrong places, that the Councilmen knowing of such, to report the same to the Committee on Gas-Light as soon as the 5th of September, in writing.

Moved, That the Committee on Markets be allowed to have the East Market-House enclosed by one gate at each end of said house, so as to do away with the burning of gas in said Market-House.

Moved, That G. A. Shubert be permitted to pave with brick the sidewalk in front of his premises, No. 347 N. West street, at his own expense, and under the direction of the City Civil Engineer, who is hereby directed to set the proper grade stakes—such work to be done within sixty days.

Also, offered the following motion; which was referred to the Board of Public Improvements:

Moved, That the Street Commissioner be instructed to clean the east gutter of West street, from North street to Seventh street.

Councilman Layman offered the following motion; which was referred to the Board of Public Improvements:

Moved, That the Street Commissioner be instructed to clean the gutters of Wayne avenue.

Councilman Marsee presented the following petition; and, on his motion, the prayer of the petitioner was duly granted:

Moved, That the Street Commissioner be directed to fill the wash-outs and holes in Michigan street, between the mill-race and White River.

Councilman Morse offered the following motion; which was duly adopted:

Moved, That the Street Commissioner be directed to notify the I., C. & L. Railroad Company to plank the crossing of their track, opposite the south and north roadway of the Vermont street bridge, and that the same be done within ten days.

Also, offered the following motion; which was referred to the Board of Public Improvements, with power to act:

Moved, That the Street Commissioner be directed to clean the gutters of West street, between Washington street and North street.

Councilman McGinty offered the following motion; which was duly adopted:

Moved, That Henry Slusher be permitted to put down a brick sidewalk in front of his property, at Nos. 472 and 474 S. West street, at his own expense, and in thirty days. The City Civil Engineer is directed to set the stakes.

Also, offered the following motions; which were severally referred to the Board of Public Improvements:

Moved, That the Street Commissioner be directed to clean the north gutter of Catherine street, and cut the weeds from West street to Pogue's Run. The distance is a little over a square in length.

Moved, That the Street Commissioner be directed to clean the gutters of Missouri street, from Merrill to Ray street, and cut the weeds.

Also, offered the following motion; which, at Councilman Marsee's suggestion, was referred to the Committee on Gas-Light:

Moved, That the City Marshal be directed to notify the Indianapolis Gas-Light and Coke Company to put down the pipe on West street, between Kentucky avenue and Georgia street, and the City Civil Engineer be directed to set the stakes.

Also, offered the following motion; which, at Councilman Marsee's suggestion, was referred to the Judiciary Committee and the City Attorney:

Moved, That the Board of Aldermen be directed to report, or show cause for not concurring in the action of the Council about Special Ordinance 32, entitled "An Ordinance to provide for the grading and graveling of Wilkins street and sidewalks, from Church street to West street."

Councilman McKay offered the following motion; which was duly adopted:

Moved, That the Police Board be instructed to furnish each patrolman with a printed copy of the schedule time-table by which the street-lamps are to be lighted and extinguished, with instructions to keep accurately the time when the lamps are lighted and extinguished, and report once every week, to the Police Board, any deviation from the schedule time-table in lighting or extinguishing the street-lamps; also all lamps not burning a full flame, and the number of lamps not burning at all.

Councilman O'Brien offered the following motion; which was duly adopted:

Moved, That the Board of Public Improvements be directed to examine the crossings of Illinois and Washington streets, and report to this body, at its next meeting, what, in their judgment, is necessary to place said crossings in proper condition.

Also, offered the following motions; which were severally referred to the Board of Public Improvements:

Moved, That the Street Commissioner be directed to fill, with gravel, the chuck-holes in W. Washington street, from White River bridge to the crossing of the Belt Railroad.

Moved, That the Street Commissioner be directed to clean the gutters and fill chuck-holes in Maryland street, from Illinois to Tennessee street.

Councilmen Off offered the following motion, which was adopted:

Moved, That Wm. Koehler have permission to pave with brick in front of his premises, on Railroad street, lot 148, out-lot 56, Noble Sub.—the same be done at his own expense, within sixty days, and under the supervision of the City Civil Engineer.

Councilman Rodibaugh offered the following motion; which was duly adopted:

Moved, That the Committee on Street and Alley Opening be directed to inquire into the matter of opening Fifth street, from the canal, west, to West street, and report the cost of the same at next regular meeting of the Common Council.

Councilman Showalter offered the following motion; which was duly adopted:

Moved, That John Larken be granted permission to move a frame house from the corner of Blackford and North streets, to lot 11, square 51, on W. Washington

Councilman Steeg offered the following motions; which were severally adopted:

Moved. That the Street Commissioner be instructed to notify the Street Railroad Company to fill in with cinders, or other suitable material, between their tracks on Virginia avenue, between East and Dillon streets.

Moved, That Mr. Christian Kruger be granted the privilege of erecting a plank bridge across the gutter in front of his place of business, on Virginia avenue.

Moved, That the Street Commissioner be directed to notify the property holders to repair their sidewalks in front of their places of business, on the west side of Virginia avenue, between Dougherty and Coburn streets.

Also, offered the following motions; which were severally referred to the Board of Public Improvements:

Moved, That the Street Commissioner be directed to repair the bridges across the gutter on the west side of Virginia avenue, between Merrill street and the first alley south of said street.

Moved, That the Street Commissioner be directed to repair the sidewalk on the corner of Virginia avenue and Coburn street.

Moved, That the Street Commissioner be directed to clean the gutters of Dougherty street, between Virginia avenue and East street.

Councilman Tucker offered the following motion; which was referred to the Board of Public Improvements:

Moved, That the Street Commissioner be directed to clean the gutters of Elm and Huron streets, as the weeds are forty feet high and the mud ten feet deep in the gutters of said streets.

Councilman Walker offered the following motion; which was referred to the Board of Public Improvements:

Moved, That the Street Commissioner be instructed to clean the gutters of Ohiostreet, between Pennsylvania and Delaware streets.

Councilman Wiese offered the following motions; which were severally adopted:

Moved, That Wm. Hartman be permitted to move a house from the corner of Morris and Meridian streets, about five squares—all to be done in one week.

Moved, That the Chair appoint a special committee of three members of the Council, to ascertain at what price aboutsix-tenths of a mile (from Morris street to the corporation line) of the Three-Notch Line Gravel Road could be purchased at, and report the same at the next regular meeting.

The Chair appointed Councilmen Wiese, Morris, and Wright as the select committee called for by last preceding motion.

Councilman Wright offered the following motions; which were severally adopted:

Moved, That the City Civil Engineer be ordered to remove the first street-lamp north of Vermont street, on the east side of East street, south, to the northeast corner of East and Vermont streets.

Moved, That the City Attorney be empowered to settle any claims against the city, on account of street opening, if the same can be done without expense or cost to the city.

On motion, the Common Council then adjourned.
